    - 2021-2022 Enrollment Fees Tulare County youth enrollment fees will be \$40 cash discount price/\$42 credit card price paid by member and Tulare County adult volunteer enrollment fee will be \$0/FREE; youth enrollment fees can be paid <u>online using a credit card</u>.
    - 3. <u>Returning Adult Volunteer Enrollment</u> Volunteers that were active last year must complete the re-enrollment process by 12/31/21. If a volunteer was not active during the 2019-2020 year and would like to return this year, they must check with the 4-H Office to see if they qualify for the exemption due to COVID-19, which will allow them to return without redoing the Live Scan and New Volunteer trainings. must complete the required eXtension trainings through their website at: <u>https://campus.extension.org/</u>. Additional information and support is available through the State 4-H Office on the <u>CA</u> <u>4-H Learning and Development webpage</u>.
      - a. Submit 4-H Adult Volunteer Application in the <u>4-H Online 2.0 system</u>.
      - b. Complete the required eXtension training: <u>2021-2022 California</u> <u>Returning Volunteer Course</u> which includes the Abuse Risk Management course (approx. 20 minutes) only. The enrollment key for the required eXtension training is Tulare with a capital T. Returning Volunteers that had a lapse in service and qualify for the COVID-19 Exemption need to also complete the Reporting Child Abuse and Neglect Course. Please contact the 4-H

Office to see if you qualify for this "exemption".

- c. Complete the required <u>2021-2022 COVID-19 Safety Training</u> and follow all guidelines for 4-H meetings and events.
