SF 425 Quarterly Reporting Requirements

Effective October 1, 2010, capacity grantees are not required to submit a quarterly SF-425, (previously SF 272) Federal Financial Report to NIFA.

Capacity grantees ARE required to submit an annual SF 425 (previously SF-269) Financial Status Report.





SF 424 R&R Submissions

- No Standard Form (SF) 424-A, Budget
 Information for Non-Construction Programs,
 and no Budget Narrative Attachment Form are
 required for FY 2015
- The Application Package submissions will include:
 - Application for Federal Assistance, Standard Form (SF) 424 Research and Related (R&R) (Required)
 - NIFA Supplemental Information Form (Required)
 - NIFA will use the Supplemental Information Form to capture all necessary attachments for this initial submission of the SF 424 R&R application (i.e., matching waiver requests (via pdf attachment)).
 - That information will be captured through the SF 424 R&R. Please refer to instructions in the RFA's for more detailed information.
 - NIFA will be capturing the information for three key contacts, and each organization will determine who those individuals are.
 - Block 5 should reflect the person responsible for fiscal/financial issues.
 - The AOR must have the authority to represent and bind the organization for any agreement.
 - The name of the Project Director will be reflected on the NIFA-2009.

NIFA 2009 Award Face Sheet

NIFA plans to issue all FY-2015 Capacity Grants on the NIFA-2009 award face sheet form. This form is also used to issue non-capacity grants.

- (Q) What does this mean for the land-grant institutions receiving capacity grant funds?
- (A) All Research and Extension capacity grant funded programs will now go through a programmatic review by the National Program Leaders (NPL) in addition to a financial & administrative review by the NIFA Capacity Grants Branch.

NPL's will review each SF 424 **R&R** application submitted in Grants.gov to ensure all prior year and current year programmatic requirements have been met (i.e., approved CRIS projects, Program of Research, approved budgets). Once NPL's have completed the programmatic review, capacity grant award files will be forwarded to the Capacity Grants Branch (CGB). CGB will conduct a financial and administrative review of the application to ensure all financial & administrative requirements have been met (i.e., prior year SF 425 received, matching requirements met). If all requirements have been met, CGB will approve the award and the Financial **Operations Division (FOD) will certify the** funds in ASAP.
