Partnerships with New Land-Grants

- 1890 Land-Grant Institution
 - Central State University OH
- 1994 Land-Grant Institution
 - College of the Muscogee Nation OK
 - Keweenaw Bay Ojibwa Community
 College MI

Non-Land-Grant Colleges of Agriculture

- Farm Bill redefines Non-Land-Grant College of Agriculture (NLGCA) to require certification
 - Must be public institution of higher education & offer 4-yr degree in a food and agricultural science
 - Web-based form to request certification

 - Response to request within 30 days

Building New Processes – New Matching Provision

- 100% match for certain competitive grant programs effective 10/1/14
 - List of impacted programs at <u>http://nifa.usda.gov/new-matching-requirement-frequently-asked-questions#faq2</u>
 - Does not replace old matching requirements

New Matching Provision


- Many entities exempt from new match requirement, including:
 - 1862, 1890, and 1994 Land-Grant Institutions
 - Animal Health Schools
 - Hispanic-Serving Agricultural Colleges and Universities
 - Insular area institutions
 - McIntire-Stennis recipients
 - Non-Land-Grant Colleges of Agriculture
 - Research agencies of USDA
 - Recipients of funds from certain higher education programs

New Matching Provision

Applicants who are not exempt, may

- Partner with an exempt entity to become exempt
- Request a 1-yr waiver, if proposed activities are consistent with NAREEEAB priorities

Do I need to meet the new 100% match requirement for competitive grant programs?



Building New Processes – Identifying Centers of Excellence

- 2014 Farm Bill requires NIFA identify Centers of Excellence for food and agricultural research, extension, and education activities
- Purpose: to provide these Centers of Excellence with priority consideration when selecting recipients of grants from the Agency's research or extension competitive grant programs

Who Can Be a Center?

- Centers' include 1 or more of the following:
 - State agricultural experiment stations;
 - colleges and universities;
 - university research foundations;
 - other research institutions and organizations;
 - Federal agencies;
 - national laboratories;
 - private organizations, foundations or corporations; and
 - individuals

How will Centers of Excellence be Identified?

Use existing grant application process

- For programs offering Centers opportunities in FY 2015, Requests for Applications describe
 - Types of applications offering Centers opportunities
 - Criteria for Center of Excellence (from legislation)

Use existing grant application process

- To be considered, applicants justify how proposed research/extension activities outlined in application meet criteria
 - Include within Project Narrative, subject to same page limitations
- Center of Excellence status will be specific to a grant application



Criteria for recognition as Center, as related to proposed research/extension activity in applications:

- Ability of Center to ensure coordination and cost effectiveness by reducing unnecessarily duplicative efforts in research, teaching, and extension;
- In addition to any applicable matching requirements, ability of Center to leverage available resources by using public-private partnerships among agricultural industry groups, institutions of higher education, and the Federal Government;



Criteria for recognition as Center, as related to proposed research/extension activity in applications (continued):

- Planned scope and capability of Center to implement teaching initiatives to increase awareness and effectively disseminate solutions to target audiences through extension; and
- Ability or capacity of Center to increase economic returns to rural communities by identifying, attracting, and directing funds to highpriority agricultural issues.



Additionally,

- Where practicable (not required), Centers applicants should describe proposed efforts to improve teaching capacity and infrastructure at colleges and universities, including:
 - Land-grant colleges and universities
 - Cooperating forestry schools
 - Certified Non-Land Grant Colleges of Agriculture, and
 - Schools of veterinary medicine

How Will NIFA Provide Priority for Funding Centers?

- Eligible applications will be competitively peer reviewed and ranked using program's standard evaluation criteria
- Where applications are ranked highly meritorious and request consideration as Centers, peer panels will review justification to determine whether Centers standard was met
- 3. Where Centers and non-Centers applications are found equally meritorious, selection for funding weighed in favor of Centers
 - Effectively, a tie breaker

How Will NIFA Provide Priority for Funding Centers?

Please note:

- If ranked highly meritorious but did <u>not</u> request Center of Excellence consideration or did <u>not</u> meet Center standard, still can be funded
- If applicant meets Center of Excellence standard and is selected for award, Notice of Award will reflect that distinction for that particular grant program
 - Distinction will be for duration of award or as identified in grant terms and conditions

Building New Processes – Commodity Board Ideas for AFRI

- Invite Commodity Boards to propose ideas for funding that align with AFRI priorities
- Assess ideas and solicit applications in those selected as part of FY16 AFRI RFAs subareas
- If applicants to these subareas are selected for award, awards would include equal funding from NIFA & Commodity Board
