STEP #1

Fill out the 4-H Adult Volunteer Interest Survey online at: http://ceglenn.ucanr.edu/glenn_county_4-h_program_286/join_4-h/become_a_leader/.

*Note: One-on-one interview may be required (will be notified by county-based staff or volunteer).

STEP #2

Submit the 4-H adult volunteer application packet to UCCE Office or process online enrollment at: https://v2.4honline.com/#/user/sign-in. Create a profile, enter all required information, and submit. 4-H Online adult volunteer status will show as pending until all steps listed below are completed.

STEP #3

Complete the required "2022-23 California New Volunteer Course" in eXtension* (qo to: https://campus.extension.org/course/view.php?id=2225.) (3 Hours Completion Time)

- a. Module 1: 4-H Orientation 40 minutes
- b. Module 2: Foundations of Positive Youth Development 20 minutes
- c. Module 3: Toward an Interculturally Connected 4-H 60 minutes
- d. Module 4: Abuse Risk Management for Volunteers 15 minutes
- e. Module 5: Reporting Child & Abuse Neglect for UC Volunteers 45 minutes

STEP #4

STEP #5

The application is reviewed by the County Director.

- a. If approved, notification of your 4-H adult volunteer appointment will be sent from 4-H Online and you will receive a letter of approval from the County Director along with your 2022-2023 Adult Volunteer Appointment Card.
- b. If there are any limitations on the appointment, they will be included in a letter sent from the County Director.
- c. If not approved, a letter will be sent to the applicant from the County Director.
