House Trailer/Tent Reservation Application Forms are to be submitted to the office **by 5:00 pm on May 8, 2023** and will be assigned based on the number of miles (distance) the applicant lives from Alturas.

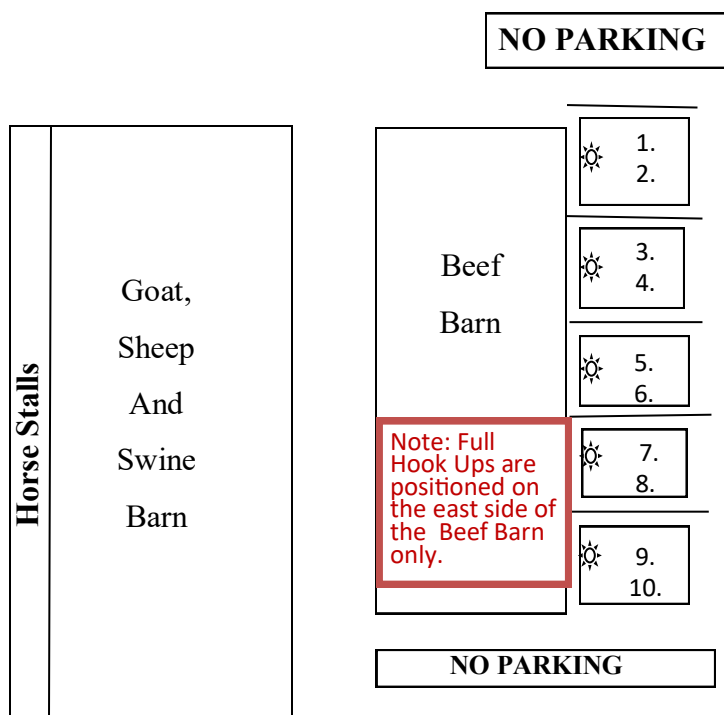
Payment for prospective space must accompany this application. Your application fee will be returned if you are not chosen for a trailer space. *Space Fee's are subject to change.

Applicants will be notified in writing if they will receive a trailer/tent space or not. Successful applicants will receive a Parking Permit to be visibly displayed on/in the trailer/tent or risk being towed.

***Full Hook Up (East side of Beef Barn) - \$90.00**

***Reserved Dry Camp (South Parking Lot) - \$25.00**

NOTE ~ If you are applying for a Full-Hook up spot and your camper has pop-outs, remember that space is limited and NOT designed for the Taj Mahal. You may not be able to use your pop-outs!!



Applicants who are not awarded a trailer/tent space may choose to park house trailers/tents in the west parking lot (across the road, near the roping arena without electrical hookup) at no cost. **(Please do not park or set up in front of the loading chute.)** Or in the south parking lot without electrical hookup.

No House Trailers/Tents will be permitted to park before 12:00 pm on Sunday of show week.

Absolutely **NO PARKING** permitted in front of any barn gates at anytime during the show with the exception of loading and unloading.

Please keep your campsite neat. Contain all trash.

NOTE: "All 4-H and FFA members are PROHIBITED from possessing or using alcoholic beverages and drugs, rough housing, destroying property, or insubordination when on the John Cummings Memorial Livestock Grounds, including show rings, barns and house trailers/tents. Infractions as determined by a responsible adult or Junior Show Board member may result in any or all of the following penalties:

- Disqualification of the member and animal from the show and sale.
- Assessing the member the cost of damage.
- Releasing the member to the law enforcement agency.

I agree to abide by the above rules regarding house trailers/tents and be responsible for my son/daughter's behavior in a house trailer/tent at the Junior Livestock Show & Sale. I also agree that it is not the responsibility of the Junior Show Board or their Advisor's to look after the welfare of my son/daughter while they are residing at the show grounds.
