



DPR Licenses and Certific



- Individuals who use or supervise the use of pesticides who are not private applicators and not structural applicators
- Businesses that perform pest control
- Pesticide dealers and brokers
- Individuals who give advice on agricultural pest control, including making written recommendations



DPR's Licensing Authority

DPR has authority to revoke or suspend the licenses of companies and individuals that do pest control work, sell pesticides, or advise on pest control in California.

DPR has authority to levy civil penalties against persons who make any misrepresentation in connection with meeting any license requirement or who cheat on or subvert a licensing examination. *Food and Agricultural Code Section 11792(e)*



A Brief History of Pesticide Regul

1901 – First pesticide -related law was passed in California .

1919 – The Legislature created the California State Department of Agriculture (CDA).

1949 – Legislature enacted new laws requiring professional applicators and pest control pilots be licensed by the CDA.

A Brief History of Pesticide Regul

1950 – First year applicator and pilot licenses were issued to individuals.

1972 – CDA became the Department of Food and Agriculture.

1991 – Regulatory program was given departmental status as the Department of Pesticide Regulation (under newly formed EPA).



What is a Pesticide?

What they are:

- Insecticides
- Herbicides
- Algaecides (such as pool chlorine)
- Disinfectants and sanitizers
- Repellants
- Rodenticides
- Fungicides

What they do:

- Control
- Destroy
- Repel or prevent
- Regulate plant growth
- Defoliate plants



General-Use vs. Restricted-Use

Available for purchase and use by any individual

Can be purchased at any general retail establishment

Must be applied according to the label instructions

Only available for purchase and can only be used by or under supervision of a licensed or certified applicator

Can only be purchased from a licensed dealer location

Some product labels require a Certified Applicator be "physically present" at the use site.

Licensing Requirement

Individuals and businesses that sell, consult on, or professionally apply pesticides must possess the appropriate license or certificate with DPR.

Pest control advisers, businesses, and aircraft pilots must register with the County Agricultural Commissioner (CAC) in each county in which they work.

Certificates and licenses must be renewed every two years.

You cannot legally work under an expired license or certificate.

Agricultural Pest Control Adviser

Any person who offers a recommendation on any agricultural use of a pesticide or;

Represents him/her self as an authority on any agricultural use or;

Solicits services or sales for any agricultural use.



PCA Minimum Qualifications

You must meet the minimum educational requirements and/or technical experience to take the PCA examinations.

Types of Business Licenses



Who Needs a PCB License?



Advertise

Solicit

Operate



Exemptions to the PCB License

- Structural pest control activities under a valid structural pest control business license.
- Preservation treatment of fabrics or structural materials.
- Tree surgery involving the removal of disease/infested tissue or applying disinfectants to wound cavities *incidental* to the surgery.
- Household or industrial sanitation services.
- Seed treatment incidental to regular business.
- Live capture/removal of vertebrate pests, bees, or wasps without the use of pesticides.



PCB Responsibilities

- Register with the CAC.
- Retain pesticide application completion notices for two years.
- Retain pesticide use records for two years.
- Submit pesticide use reports to the CAC. School and daycare PURs must be submitted to DPR annually.
- Have a copy of the restricted materials permit during the application.
- Retain written recommendations and work orders for one year.
- Must demonstrate financial responsibility for illness/injury/damage and Worker's Compensation insurance (if the business has employees).



Maintenance Gardener Pest Control Business (MGB)

You must possess a Maintenance Gardener Pest Control Business (MGB) License if you occasionally engage in pest control work that is *incidental* to your primary gardening business for hire.

You are a Maintenance Gardener if your maintenance gardening activities include mowing lawns, general yard cleanup, and/or taking care of plants and turf in indoor or outdoor settings.





Designated Qualified Applicator

Business must have at least one designated qualified applicator that supervises and oversees the business's pest control operations. The qualified applicator(s) must have each category attached to their lic./cert. that the business will do work in.

MGB

PCB

- QAC-Q: Is the minimum. No restricted use.
- QAC-B: May use restricted pesticides and perform MGB scope of services.
- QAL-B: May use restricted pesticides and perform MGB scope of services.

- **QAL Only!**



Pest Control Broker Business

Any person in or outside of California engaged in the sale or distribution of any DPR registered pesticide products in California.

Does not authorize the sale of agricultural use or restricted use pesticides to end users.

Not required if you are the registrant or if you are a pest control dealer.





Pest Control Dealer Business (PCD)

- Sell agricultural use pesticides, methods, or devices for the control of agricultural pests to end users.
- Solicit pest control sales through recommendations made by your field representative.
- Sell restricted use pesticides to end users.
- Sell RUP's that require a restricted use permit or applicator certificate for purchasing.



Pest Control Dealer Responsibilities

- Ensure appropriate products are being sold.
- Maintain dealer records – purchase, sales, and distributions for four years.
- Verify buyer authority to purchase, possess, or use federally restricted use or California restricted materials.





Dealer Designated Agent (DDA)

You must possess a Pest Control Dealer Designated Agent (DDA) license if you are responsible for supervising all operations of a licensed pest control dealer at a principle or branch location.



PCA, QAL, and APC/JPC license and certificate holders may also act as a licensed Designated Agent to actively supervise operations of a Pest Control Dealer business.

CE Requirements

- All CE courses must be DPR-approved
see the Approved Courses List on website:
www.cdpr.ca.gov
- Deadline to complete CE is December 31 - NO GRACE PERIOD
- Must take all CE during the valid period of your license/certificate
- For QAL/QAC/PCA extra hours in Laws = “Other” For APC/JPC extra hours in Aerial = “Other”



Cherry Buckskin Project: This project began in 1987 to prevent the establishment of Cherry Buckskin Disease. The largely unfunded volunteer operation has resulted in the current absence of the disease in Contra Costa County and no need for preventive sprays. The Cherry Buckskin Project trains growers and master gardeners to identify the disease during harvest, and emphasizes grower to grower exchanges, skills and resources to cherry growers. This is a collaboration among the University of California Cooperative Extension, the Contra Costa County Department of Agriculture and local cherry growers.
