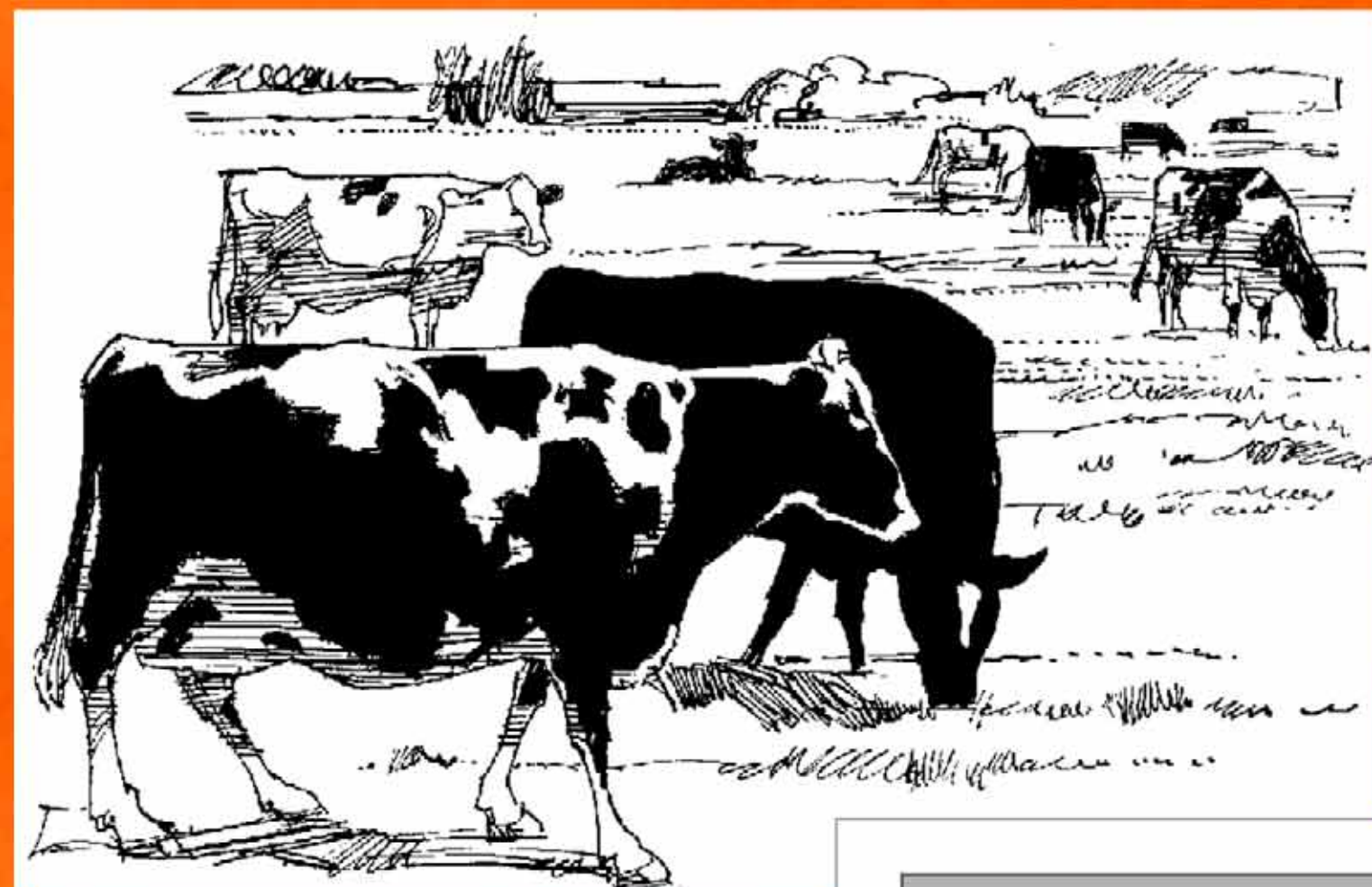
Environmentally Sound

This is a means for ranchers to document good practices and identify specific action items to improve their operation. This will help the individual rancher as well as the industry as it relates to finances, regulations, public relations, and overall good stewardship.

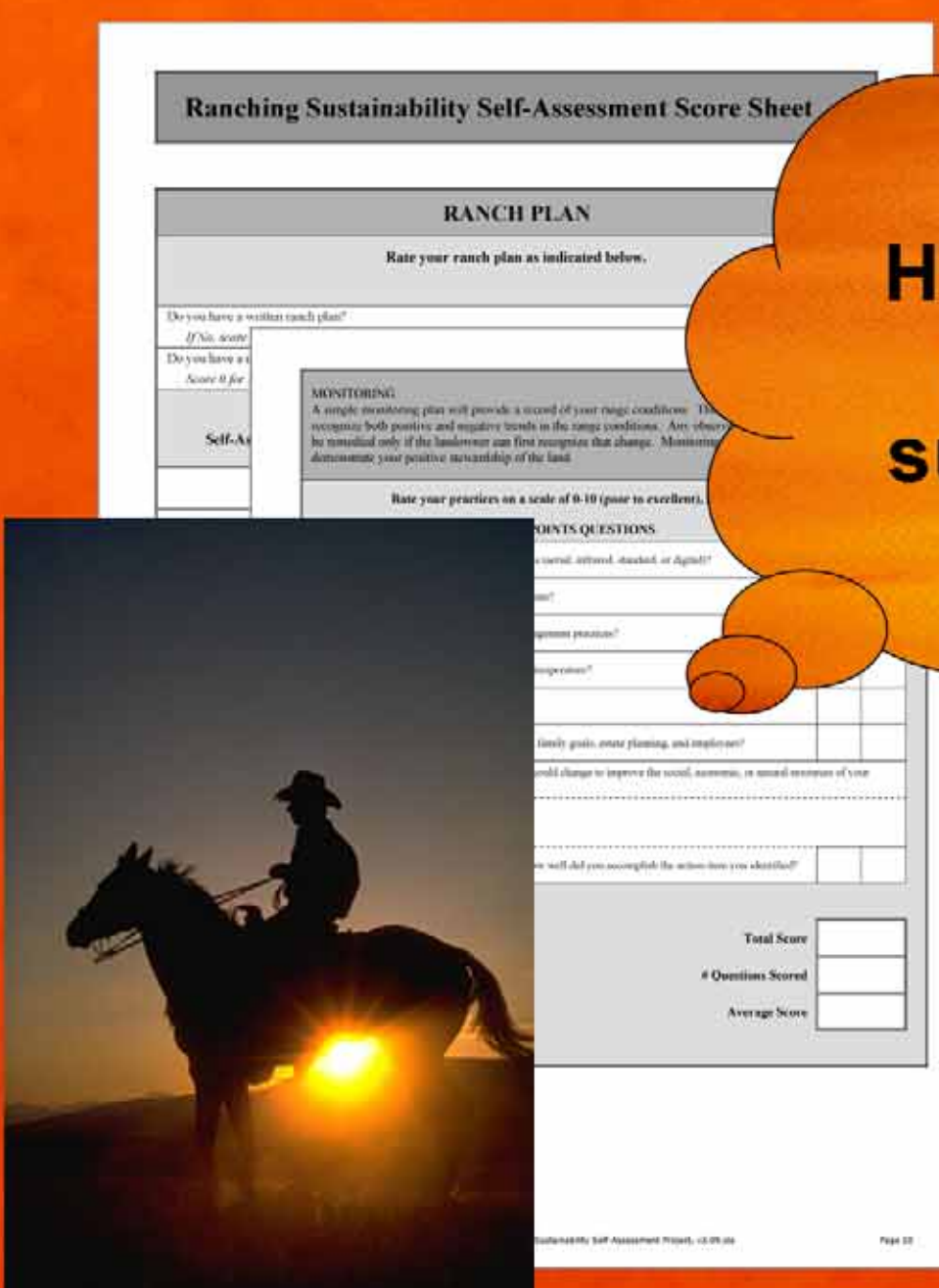
Assessment Categories
