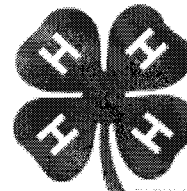


POTTER VALLEY 4-H RABBIT & CAVY SHOW

Rules: All entry forms must be postmarked by April 25, 2011. Changes by phone can be made until April 29, 2011 by calling 707-743-1630. Substitutions of the exact same class may be made until 9:30 am on show day.

The show is a one-day carrying cage show. All rabbits and cavies must be in cages with bottoms.

All rabbits and cavies are to be in place by 9:30 am. Judging will begin at 10:00 am.

It is suggested that showmanship participants wear full 4-H uniform

Exhibitors are responsible for having their animals at the judging table

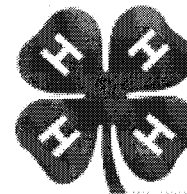
Information: A food concession stand will be open for snacks, lunch, and beverages
