

# Stream Restoration Success II

Decades of lessons in watershed restoration offer future opportunities & challenges



The practice, science, and art of stream stewardship and restoration have evolved over the last 30 plus years. Local and state researchers and practitioners have identified additional opportunities and challenges for successful stream restoration projects and watershed management. This includes the use of monitoring to learn from past efforts and improve future projects. As a follow-up to the first Stream Restoration Success shortcourse in 2006, we have gathered presenters to share their experiences and lessons learned through the evolution of conservation practices.
