## **RULES AND INFORMATON**

1. Classes are \$12/class. \$18/championship classes. 4-H Classes \$6  
SPECIAL: 5 classes for \$50 (non Championship classes only)
2. Stalls are \$75 for 3 days. Horses may arrive Friday July 29<sup>th</sup>. No bedding or feed is included in the price
3. Feed and Shavings can be ordered from: **Country Feed 831-722-6588**
4. Helmets are encouraged for those 18 and under. Required for 4-H
5. Classes are open to all breeds unless specified.
6. Gaited breeds (Fox Trotters, Walkers etc) are eligible to enter any classes.
7. Cross entering is allowed between walk-trot and walk-trot-canter classes – however once a rider has cantered in any class, they may not enter an Academy/Beginner walk-trot class.
8. Dogs are discouraged. If they come, they must be on leashes at all times.
9. Classes marked with a \* will be count toward NCASHA points.
10. The show will also count toward Pacific Coast and ASHA Pleasure points
11. A riders' age is their age as of December 1, 2010

## Class Descriptions: 2011

**Academy/Beginner Division** \*: A beginner is a rider who has never shown outside a beginner division or one whose experience is so limited that they would be considered a beginner in a lesson program. An Academy rider is one showing a horse used regularly in a lesson program by multiple students and has never shown outside the Academy/Beginner Division. Riders may be of any age. Open to English and Western Riders. Riders who have cantered in a class in any show are not eligible to ride in the walk-trot section. Equitation judged on the basics of horsemanship appropriate to the style of riding. Showmanship judged on riders ability to show the horse to its best advantage. Open to Gaited Horses too. Riders cannot enter other classes except Halter, Costume and Walk/Trot class # 43. Riders to show in Academy attire (no jackets or full show outfits)

Novice Rider: not to have won 3 blue ribbons, Junior Horse: 4 yrs and under. Will divide English/Western if entries warrant
