1. Entries must be postmarked by September 10, 2012. Mail entries to Diana Anderson, 219 E. Maple Ave, Lompoc, CA 93436 Make checks payable to Santa Barbara County Fair
2. Entry fee is \$3.00 per bird. This is a single open and single youth show. Payment must accompany entry or be paid prior to judging. If payment is not received animals will not be judged.
3. A clean up fee of \$3.00 per exhibitor will be charged to cover set up and clean up expenses.
4. The building will open at 7:00 a.m. All birds must be in place by 8:30 a.m. If a youth exhibitor uses a bird for showmanship they must place an "out for showmanship" card in their coop.

5. This will be a closed tag show. The aisles will be closed if necessary so that the judges can work without interruption . The decision of the judges will be final.
6. No bird will be cooped unless an entry fee has been paid. Only judges, owners, and show officials will be permitted to handle entries.
7. Competition is open to all recognized breeds of poultry and waterfowl.
8. Diseased or sick birds, including those vermin infested will be removed from the showroom. They will not be eligible for any award and will forfeit entry fees.
9. All birds must be identified by leg bands. Numbers must correspond to the entry form.
10. Please feed and water your own birds, or make arrangements for their care with the show secretary. Feed will be furnished.
11. Absolutely NO SMOKING and NO ALCOHOLIC BEVERAGES are allowed in the building.
12. The Santa Barbara County Fairgrounds or the show officials will not be held responsible for any losses or accidents sustained by any exhibit or exhibitor.
13. This show will be held under the rules of the APA and ABA.
14. The judges and their immediate family will only be able to enter the show in which they are not judging.
