Master Gardeners are enthusiastic, have time to volunteer, can effectively communicate and work with diverse groups of people.

Training class description:

Master Gardeners receive an intensive college level 12-week training program beginning January 9, 2026. Students are expected to complete a minimum of 10 hours of independent learning each week using our online platform, attend hands-on class each Friday from 9:00 am - 1:30 pm and create a 20-minute presentation with a team of fellow trainees. Weekly classes are held at 1710 Soscol Avenue, Napa.

Topics covered provide a practical course in plant science and horticulture, including:

- Botany, plant pathology and entomology
- Sustainable gardening
- Integrated pest management (IPM)
- Soils, composting and mulch
- Disease and insect identification
- Plant problem diagnosis
- Fire-smart landscaping
- Climate and climate change
- Pollinators and beneficial insects
- Weeds and invasive plants

Cost

There is a charge of \$300 for materials, instruction and supplies. Partial scholarships are available upon request.

Classes are taught by experts in their fields. They include Cooperative Extension advisors, specialists from the University of California, and other qualified presenters. Hands-on learning is emphasized in most training class exercises.

Volunteers don't have to have ALL the answers. We are learners and teachers, engaged in a process of life-long inquiry about natural systems. Our collective aim is to learn how to use UC research-based information to support sustainable gardening outreach.

The mission of the UC Master Gardener program is to extend research-based information on home horticulture, pest management and sustainable landscape practices to the residents of California and be guided by our core values and strategic initiatives.

What is the Master Gardener's commitment to the program?

Master Gardeners are expected to make at least a 2-year commitment to the program.

Master Gardeners are selected based on their skills, ability, desire to fulfill this commitment and current needs of the program.

Master Gardener trainee requirements:

- Be a Napa County resident
- Attend one scheduled informational meeting to receive an application (dates on back)
- Complete an online application
- If invited, participate in an in-person interview
- Receive fingerprint clearance from the California Department of Justice
- Attend orientation meeting on November 14
- Complete preliminary online assignments in November and early December to familiarize yourself with the online learning platform and policies and procedures of Master Gardeners
- Successfully complete the 12-week training class

First year after graduation:

Accrue at least 50 volunteer hours to support educational programs

To maintain certification and active status:

In subsequent years, master gardeners must complete at least 25 hours volunteering in educational program activities and 12 hours continuing education per year.
