

## **Viticulture Advisor** **Applied Research and Extension**

### **Serving the Northern San Joaquin Valley of California**

#### **Position Overview**

The University of California, Agriculture and Natural Resources (UC ANR), a statewide program with local development and delivery, is seeking the following UC Cooperative Extension (UCCE) Advisor.

**Location Headquarters.** San Joaquin County, CA

**Purpose.** The Viticulture Advisor will implement an innovative extension education and applied research program to address high priority production issues in wine and table grapes including pest, disease and water management.

The advisor will support entry-level growers who require an intensive educational effort on basic viticulture and pest management practices while experienced growers need information on new technologies to remain competitive. All producers face mounting pressures from increased regulatory and environmental compliance requirements as well as cost-competitiveness in an increasingly global marketplace. Secondary responsibilities will include providing support for cane berries and blue berries, although the major program emphases will be on wine grape production.

This is an exciting opportunity to have meaningful impacts in the viticulture communities of the northern Central Valley and throughout California. The advisor will work closely with growers, industry and with more than 100 pest control advisors, a large and important secondary clientele group.

Opportunities abound for research and extension partnerships that link consumers and resource professionals across multi-sectors with relevant science-based information and promote effective problem solving. The advisor will also join a team of highly motivated UCCE colleagues who are passionate about their work, and are dedicated to making a difference within the communities and throughout California. The potential for collaborative projects within the UC ANR system is nearly limitless.

**Counties of Responsibility.** This position will be headquartered in San Joaquin with regional responsibilities in southern Sacramento (including the Lodi Appellation in southern Sacramento) and Stanislaus counties.



**Reporting Relationship:** The CE Advisor serves under the administrative guidance of the University of California Cooperative Extension (UCCE) County Director for San Joaquin County with input from the other UCCE County Directors in the coverage area.

## Qualifications and Skills Required

### Required Qualifications

**Education:** A minimum of a Master's degree in viticulture, crop science, soil science, pest management, or a closely related field is required at the time of appointment.

### Additional Requirements

- Valid driver license.
- Live within a commutable distance of the position headquarters during period of appointment.
- The CE Advisor must possess or obtain within one year of hire a Qualified Pesticide Applicator Certificate (QAC) prior to applying pesticides or supervising the application of any pesticide.



### Desired Experience

- Experience with vineyard or orchard crops.
- Passion and desire to pursue a career in Cooperative Extension and community development.
- Experience in successful Cooperative Extension programming or community development.
- Demonstrated ability to effectively plan, manage teams and implement a research program, including setting measurable goals and objectives.

### Skills Required

To be successful, the CE Advisor requires skills in the following area:

#### Technical Competence and Impact

The candidate should have a deep understanding of key concepts related to vineyard production systems and agronomic research design and be able to design and implement a program that leads to positive changes and impact within the community and beyond. There is an expectation that advisors evolve and grow across their career and respond to changes in the industry and by clientele.

#### Communication

Demonstrated excellence in written, oral and interpersonal and information technology communication skills. Public speaking is a routine part of this position.

#### Collaboration, Teamwork and Flexibility

Demonstrated ability to work collaboratively as a team member with others. Able to adapt as circumstances warranted.

Aware and willing to actively promote diversity, equity and inclusion.

#### Lifelong Learning

Demonstrated commitment to ongoing self-improvement - both professionally and as a person. Ability to shift program focus as times and organizational needs change.
