

## Woody Biomass & Forest Products Advisor Applied Research and Extension

### Serving Siskiyou, Shasta, and Trinity Counties, California

#### Position Overview

The University of California, Agriculture and Natural Resources (UC ANR), a statewide program with local development and delivery, is seeking the following UC Cooperative Extension (UCCE) Advisor.



**Location Headquarters.** Siskiyou County, CA

**Purpose.** The Woody Biomass & Forest Products Advisor will implement an innovative extension education and applied research program to address high priority needs and problems related to increasing the use of woody biomass in the region.

The advisor will serve as the regional lead for integrating biomass vegetation management work and community resilience. In so doing the advisor will provide technical assistance for community scaled vegetation management and natural resources manufacturing enhancing both private industry biomass utilization and long-term community resiliency in the face of a changing climate and pressure on keeping communities safe in the face of increased wildfire.

The advisor is responsible for the assessment, development, implementation, and evaluation of educational and research programs that will have significant impacts on increasing the use of woody biomass in the region. This position will assist local forestland owners, processors, and marketers to increase use of wood products. The advisor will collaboratively develop and disseminate science-based practices for wood utilization, including niche production, marketing, resource sustainability, and appropriate-scale equipment and technology.

This is an exciting opportunity to develop and deliver relevant program content to have meaningful impacts in local communities and throughout California.

Opportunities abound for extension and research partnerships that link to work in partnership with the state of California including the Office of Planning and Research, CalFire, the Joint Institute on Wood Products Innovation, community water groups. The advisor will also join a team of highly motivated UCCE colleagues who are passionate about their work, and are dedicated to making a difference within the communities and throughout California. The potential for collaborative projects within the UC ANR system is nearly limitless.

**Counties of Responsibility.** This position will be headquartered in Siskiyou County and also serve Shasta and Trinity Counties.

**Reporting Relationship:** The CE Advisor serves under the administrative guidance of the University of California Cooperative Extension (UCCE) County Director for Siskiyou County with input from the other UCCE County Directors in the coverage area.

## Qualifications and Skills Required

### Required Qualifications

**Education:** A minimum of a Master's degree in in community development, forestry, manufacturing, engineering, design, or related fields is required at the time of appointment.

### Additional Requirements

- Valid driver license.
- Live within a commutable distance of the position headquarters during period of appointment.



### Desired Experience

- Educational and professional background in economic development
- Experience working in woody biomass production systems such as engineered wood products, wood science, biomass energy or advanced manufacturing is highly desirable
- Passion and desire to pursue a career in Cooperative Extension and community development
- Experience in building partnerships and with multidisciplinary teams
- Demonstrated ability to effectively plan, manage teams and implement an applied research and outreach program, including setting measurable goals and objectives

### Skills Required

To be successful, the CE Advisor requires skills in the following area:

#### Technical Competence and Impact

The candidate should have a deep understanding of community and economic development and be able to design and implement a program that leads to positive changes and impact within the community and beyond. There is an expectation that advisors evolve and grow across their career and respond to changes in the industry and by clientele.

#### Communication

Demonstrated excellence in written, oral and interpersonal and information technology communication skills. Public speaking to stakeholders is a routine part of this position.

Demonstrated ability to share complex information in a manner tailored to the audience.

#### Collaboration, Teamwork and Flexibility

Demonstrated ability to work collaboratively as a team member with industry and other stakeholders. Able to adapt as circumstances warranted.

Aware and willing to actively promote diversity, equity and inclusion.

#### Lifelong Learning

Demonstrated commitment to ongoing self-improvement - both professionally and as a person. Ability to shift program focus as times and organizational needs change.
