## Winning – At What Cost?

*The following two articles are printed annually in this newsletter.*

As fair time and various competitions approach we often hear parents and leader concerns about the ethics of some participants in the 4-H program. The following short story fits very well in the discussion of WINNING IN 4-H.

We hear, "We just know that member did not do the work on the outfit entered in the 4-H Home Arts Expo -- her mother did it!" "You know that kid who was County Winner -- his parents did the record book!" "Did you see those parents grooming that animal at the fair...and then

the kid wins the showmanship contest!" "I just know that member has not had that animal for 60 days before the fair. This is obvious favoritism".

Sometimes, there is little or nothing that can be done about personal ethics as it affects the way people behave when they are involved in a competitive situation, or any situation for that matter. 4-H is not set up with a system of policing and it shouldn't be. The infractions that help youth WIN AT ANY COST are few. People will violate the rules, whether it is ignoring the speed limit, cheating just a bit on income tax or littering along the highway. Because 4-H involves people it is unlikely that those who

have such values and standards will be eliminated. But there is an opportunity to open lines of communication with the young members of the program about what is right and wrong and that right and wrong are personal decisions. We can help them when they are young, but that will be THEIR decision to make as they grow older and become more independent members of the great American society.

Those who must WIN AT ALL COST are the losers in life's game.

Entry fees are just \$4.99 per class.



The class list includes something for everyone. Numerous High Point Awards will be presented.

## THE TEN COMMANDMENTS OF SHOWING LIVESTOCK

As the Amador County Fair nears, read these "Ten Commandments for Parents of Youngsters Showing Livestock" by Clyde Lane, Jr., Extension Specialist from the University of Tennessee.

1. Thou shalt not feed, train, and care for thy animal for thou art trying to teach the child responsibility.
2. Thou shalt forgive a child for making mistakes in the show ring for thou hath made mistakes, too.
3. Thou shalt not get mad when thy child forgets items in the show box, for one day thou may forget the show box.
4. Thou shalt help the show management for

they are doing a job that thou would not want to do.

5. Thou shalt see that thy child is on time for all show activities for thou would not want to wait on another.
6. Thou shalt be sure that thy child has the animals entered and the registration papers in order by the designated time.

7. Thou shalt teach the child that winning a blue ribbon is a desirable goal, but making friends along the way is a more worthy goal.

8. Thou shalt not complain about the judge, for it is his opinion that

has been sought.

9. Thou shalt remember that livestock projects are teaching projects, not necessarily money-making projects.

10. Thou shalt remember that the live-stock project is a family project that shall be enjoyed and supported by the entire family.



# Are you “YouTube™ — ready”?

## Animal welfare

It's show day. The day you have prepared for, worked so hard for, and waited for. You have washed, brushed, weighed, fed and walked your animal. While you are nervous and excited about stepping into the show ring, take a moment to ask yourself: If anyone around the ring captured this moment on video, how would I look? How are my attitude and actions being perceived by others? Am I “YouTube™-ready”?

We've all seen livestock with red marks on their shoulders and jowls in the show ring. Maybe the pig isn't responding the way it should. Maybe it's a thin-skinned, light-colored hog that reddens easily when tapped. Maybe nerves take their toll and the exhibitor “over taps” their pig. Maybe too much “coaching” from parents ringside frustrates the exhibitor, or maybe its trying to unload a stubborn pig off of a trailer, or trying to get to the wash rack through a maze of alleys, people, strollers. While most of us realize that the red marks are gone in less than an hour, when captured on film or video, it is hard to put into the proper context to most people.

How you handle each situation will determine how those around you interpret it. It's not always in the show ring that you can make an impression on the public. It may be in the aisles or at your pen. Don't avoid questions; see them as an opportunity to tell agriculture's story. Be prepared to answer what may seem to be silly questions, such as: “What happened to the pig's ears?” (notching). Treat these questions and comments with respect and honesty.

Carefully-worded, truthful answers will make a lasting impression and may often change a person's view of our industry. Of course, without a little practice or thinking about these things before the show, your answers may not come out as smooth as the ones written out on paper.

The main thing to remember is to be honest, yet avoid using inflammatory words such as “slaughter” (use “harvest” instead). If you know that you may be interviewed by media or have a chance to speak to a large group (say, school tours), develop two to three message points that you want your audience to carry away with them. The opportunity to educate others doesn't only occur at the show itself. It may happen while talking to your friends at school, your neighbors, or even your grandparents or extended family members.

Start thinking of your role as being an advocate for the industry. This puts an added weight on youth exhibitors' shoulders. Since the show may be the only connection that the public may have with livestock, exhibitors are representing the entire livestock industry. With today's technology, virtually everyone has a camera and/or video camera on their phone. With a little preparation and forethought, you can be the best ambassador and representative that our industry could ask for!

So, as you load up the tack and hook up the trailer to head out to the fair, ask yourself: “Am I “YouTube™-ready”?


