## New Farmer Eligibility for Federal Funds

This week the Senate passed the latest aid package, which is now on its way to the House for a vote. This means that the Payroll Protection Program (PPP) as well as the Small Business Administration's Economic Injury Disaster Loan (EIDL) *could* reopen as early as THIS FRIDAY.

### Two wins here for farmers:

1. This bill will allow agricultural operations with fewer than 500 employees to qualify for the EIDL, which offers emergency grants of up to \$15,000.
2. It also will replenish the now-depleted Paycheck Protection Program, which provides forgivable loans to small businesses (including farmers) to keep their workers on the payroll.

### What you should do NOW:

If you want to access this funding, contact your bank, local credit union or other lender ASAP to get your ducks in a row. As we saw in the last round of aid, these funds won't last long. If you don't have access to a traditional lending source, contact the good folks at [California FarmLink](#) who are assisting farmers in need.
