

4-H Policy & Procedure Reminders

Project Completion

Must be a member in good standing, complete a minimum of six (6) hours of project instruction or more as required by the project leader and complete the Annual Project Report (APR). Members receive a year stripe and pin for project completion. Primary members do not complete the APR, and receive a year stripe and pin for participation in a project. If used, proficiency or other tests must be reviewed, evaluated and approved by the 4-H YDP staff prior to implementation.

Livescan Deadline- New Volunteers 2023-24 ONLY!

If you are a new volunteer and have not yet completed a livescan, in order to participate in 4-H this year, you must have your livescan submitted by MAY 15TH, 2024

California State Sales 1ax

Scope

In California, sales tax applies to the sale of tangible personal property unless the sale is covered by a specific legal exemption or exclusion. In most circumstances, the 4-H YDP is exempt from charging sales tax on the items it will sell because it is considered a consumer and not the retailer of specific kinds of tangible personal property under certain conditions. Specific legal exemptions or exclusions that pertain to 4-H units and VMOs engaged in fundraising projects are set forth in Section <u>6361</u> and Regulation <u>1597</u>, Revenue and Taxation Code.

Items Not Taxable

The sale of food products, nonalcoholic beverages or other tangible personal property made or produced by members of the organization are exempt from state sales tax when those sales are made on an irregular or intermittent basis and the organization's profits from those sales are used exclusively in furtherance of the purposes of the organization. A seller's permit is not required for the sale of these items as 4-H is considered a consumer.

Taxable Items

In general, the sale of items not made or produced by group participants such as tshirts, wrapping paper, mugs, stuffed animals, etc. are subject to California sales tax. Thus, 4-H may not sell items that require collecting and reporting sales taxes.

4-H Age FAQs

How is 4-H Age defined in CA 4-H?

4-H Age is the age of an individual as of December 31st each enrollment year. The CA 4-H enrollment year is July 1st through June 30th . A few examples below will help illustrate the considerations and limitations involved based on various participant's 4-H Ages.

Example A: Primary 4-H Member

- Mary's date of birth is March 20th, 2011.

- In the 4-H enrollment year 2023-2024, Mary's age as of December 31st , 2023 is 8 years old.

- For purposes of enrollment, Mary's 4-H Age for the 2023-2024 year is 8 years old.

Project List.

- Mary will turn 9 years old in March 2024.

- Mary is eligible to re-enroll in the 2024-2025 program year, and begin participating

in 4-H Activities as a Junior 4-H member (4-H ages 9-10 years old).

Example B: Primary 4-H Member

- Taylor's date of birth is December 19th, 2019.

- Taylor will turn 5 years old on December 19th.

- In the 4-H enrollment year 2023-2024, Taylor's age as of December 31st , 2023 is 5 years old.

- For purposes of enrollment, Taylor's 4-H Age for 2023-2024 year is 5 years old.

- Taylor is eligible to enroll as a Primary 4-H Member.

Example C: Primary 4-H Member

- Shawn's date of birth is January 10th, 2020.

- Shawn will turn 5 years old on January 10th, 2024.

- In the 4-H enrollment year 2023-2024, Shawn's age as of December 31st , 2023 is 4 years old.

- For purposes of enrollment, Shawn's 4-H Age for 2023-2024 year is 4 years old.

- Shawn is NOT eligible to enroll as a Primary 4-H Member, because they are not 5 years old as of December 31st , 2023 of the 2023-2024 program year.


Example D: Senior 4-H Member

- Riley's date of birth is August 5th , 2009.

- In the 4-H enrollment year 2023-2024, Riley's age as of December 31st , 2023 is 14 years old.

- For purposes of enrollment, Riley's 4-H Age for the 2023-2024 year is 14 years old.
