
## UCANR/UCSF: A powerful collaboration





# Review: Cooperative Extension's National Framework for Health Equity and Well-Being



#### FOCUS: Five Framework Recommendations



- Highlight a few examples
- Reminder: each recommendation can be approached in a variety of ways
- How might you approach this recommendation with your work?

Advance health equity as a core system **value** to ensure that all people have a fair and just **opportunity** to be as **healthy** as they can be.

#### How?

- Infrastructure: health equity council, anti-racism taskforce
- Organization-wide: health equity framework, metrics and assessment, trainings, land acknowledgment and other inclusive or healing practices
- Operational: Hiring and purchase power, shifting of resources

#### Examples:

- UC ANR Nutrition Policy Institute organizational self-assessment on Health Justice and Racial Equity from the Praxis Project.
- UC ANR Human Resources Market Equity Adjustment Plan to make salary adjustments system wide.

## Recommendation #1 Example: UCSF Anchor Institution

Anchor institutions are place-based, mission-driven entities such as hospitals, universities, and government agencies that leverage their economic power alongside their human and intellectual resources to improve the long-term health and social welfare of their communities.



## What is the Anchor Mission?

The anchor mission is a commitment to consciously **leverage the long-term, place-based economic power** of institutions, such as hospitals, universities, and government agencies, along with its human and intellectual resources, to better the long-term welfare of the community in which the institution is anchored.

To create equitable health outcomes for communities we need to tackle the underlying economic and racial disparities that drive them—the structural determinants of health. The aim is to improve community health and well-being by leveraging all assets, including **hiring, purchasing, and investment** for equitable, local economic impact. (Healthcare Anchor Network)

We focus efforts in geographic communities surrounding UCSF campuses, and intentionally engage the most economically under-resourced

We seek to leverage our economic resources, aligning strategically with local partners, toward economic equity



## Anchor Institution Mission Theory of Change

#### **Procurement**

Diversify institution spend by leveraging UCSF's purchasing power so that more procurement can be sourced from small, local, and diverse businesses that are owned by or employ under-resourced populations

#### **Workforce Development**

Support career advancement for UCSF's frontline workers

Provide workforce development programming and employment pipelines for under-resourced populations

Foster a greater sense of belonging and inclusion for under resourced populations at UCSF

Strengthen educational, employment and internship opportunities for San Francisco/Bay Area youth

#### **Community Investment**

Increase lendable capital in San Francisco Bay Area, specifically in under-resourced communities through financial intermediaries by providing low interest loans for small local businesses, social enterprises and other social impact areas

## Workforce Development Goals:

In partnership with Human Resources & Office of Diversity & Outreach

**Goals: 1)** Increase UCSF's capacity to train, hire, and promote people from under-resourced populations; and **2)** Increase effectiveness of the education pipeline for under-resourced populations. To date, we have:

- •Expanded EXCEL, UCSF's flagship entry level admin/clerical workforce development program by 50% to serve 45 participants each year
- •Strengthened EXCEL's alumni program by launching a mentoring initiative
- •Continued to create and expand training programs, to intentionally **grow the entry level to mid-level opportunities** via a career pathway training in the following categories: Medical Assisting, Clinical Research Coordination, Practice Coordination, Patient Care Assistant, and IT Help Desk/Field Services
- •Provide more than **100 internship opportunities across UCSF** each year for those from the community and our internal team members.

## K-12 Pathway Key Accomplishments, FY 2022

- Expansion of UCSF-SFUSD paid internship program. SFUSD interns placed at UCSF during the summer '22 (34 interns) and fall '22 (6 interns).
- Established UCSF/OUSD paid HS summer internship program w/10 OUSD interns. Interns placed at BCH Oakland and UCSF main.
- Established OUSD Highway to ER Tech.
- Established OUSD Bioscience Teacher Institute.
- Provided ongoing advising and support of the SFUSD Mission Bay Linked Learning Hub in preparation for spring 2023 cohort.





#### Procurement Goal:

#### In partnership with Supply Chain Management

**Goal:** Understand UCSF's "addressable spend" to leverage purchasing power so that more procurement opportunities can be sourced from certified small and diverse businesses from our local and regional communities. Achieve 25% diverse spend by FY26.

#### Our progress to date:

- Created trust with city and community partners to collaborate
- Established innovative procurement processes that had not been done before
- Learned about **conflicting policies**, laws, initiatives and enterprise values that challenge our progress and require careful actions
- From February 2021 to date, we have seen improvements in diverse spend numbers compared with last year's numbers.
- Reviewed spend for Chancellor's Cabinet and Finance Executive Team to support
   True North Scorecard goals and make recommendations to redirect spend



## Community Investment Pilot

Goal: Develop a three-year pilot investment program where \$5 million in campus cash and other short-term equivalents can be directed to social impact investments. Our progress:


Identified 4 partner financial intermediaries through Request for Qualification (RFQ):

- 3. ASIAN, Inc.
- 4. Pacific Community Ventures

Utilize community **assessment** processes that integrate **data** science and resident **voice** to identify and address health inequities with greater precision.

#### Examples and description:

"I work with **CalFresh Healthy Living** in the early childhood education program. My work focuses on educating children to develop healthy eating and lifestyle behaviors that they can continue to practice throughout their life. We collaborate with SETA to reach preschoolers. This collaboration has allowed us to form relationships with many schools. Our activities are often games that include learning about the MyPlate food groups paired with tasting of these foods. We <u>collect data</u> looking at how many children ate the new foods and how many would eat these foods again. We meet with teachers delivering the lessons to the children to hear what they think about our curriculum and what we could change to make it more effective or easier to follow. When children repeat what they have learned and can recognize foods they previously were not familiar with, I can see how successful the program is. My work will increase the amount of people who understand how to make themselves healthy foods which 31 will translate into a more successful life."

**Invest** in the **success** and **visibility** of Cooperative Extension's health-related professionals, programs, and initiatives.

#### Examples and description:

"The Mindfulness Program is developing new lessons to address education, health systems and services, and social environments for young people who are neurodivergent. This effort is a collaboration between medical, mental health, and health equity professionals, in partnership with neurodivergent youth. To support improvements in education, health systems and services, and social environment for these youth, researchers will develop and pilot test adapted mindfulness activities with the goal of supporting youth-wellbeing. This work will be successful if the adapted lessons have similar or better outcomes than the existing curricula for neurodivergent youth. These efforts will allow educators, mental health, and medical providers to extend research-based strategies for supporting youth wellbeing, emotional regulation, improved relationships with others, and improved academic success for neurodivergent youth."

Establish **partnerships** with academic units, universities, government agencies, corporations, nonprofit organizations, and foundations that **share a commitment to reducing or eliminating** health inequities.

#### Examples and description:

- **UCANR-UCSF** this health equity partnership for the state of California
- YPAR Project focus on access and appeal to drinking water at school by partnering with the water district, 4-H, and school board to 1) add remodel plans for water filling stations and 2) to provide education to youth on the importance of drinking water
- Mindfulness Program: "I am a developmental psychologist with expertise in parent-child relationships and I collaborate with dieticians and nutrition scientists to develop educational content relevant to supporting parents in creating healthy home food environments for their children."

Utilize a **community development approach** to advance the work of coalitions focused on influencing the **social determinants of health**.

#### Examples and description:

- "Youth empowerment and leadership opportunities through student-led Cooking Academy classes"
- "We meet with teachers delivering the lessons to the children to hear what they think about our curriculum and what we could change to make it more effective or easier to follow"
- "Community voice: I could do more with this. Typically, community voices are added during the cognitive testing phase of the development of an evaluation or research tool, or in the evaluation process of an educational program"
