Napa County 2020-2021 4-H Adult Volunteer Re-Appointment Process *Starting July 1, 2020*

Re-Appointment Deadline: December 31, 2020

- 1. Submit your 4-H adult volunteer re-application in 4hOnline.**
Login to your family profile at <https://ca.4honline.com>. Login to adult record and click “Enroll for 2020-2021.” Enter all required information and submit. 4hOnline adult status will show as pending.
- 2. Complete required “2020-2021 California Returning Volunteers Course” in eXtension.**
Go to <https://campus.extension.org/course/view.php?id=1868>. Log into your existing account and click “2020-21 California Returning Volunteers Course” and enter the code “Napa”.
 - a. Abuse Risk Management for Volunteers (15 min)
 - b. Reporting Child Abuse & Neglect (40 min)(*Note: Every individual must use their own unique email address. For technical support, please contact idevelopsupport@ucanr.edu). For the Spanish language course, please visit <https://campus.extension.org/course/view.php?id=1868>.
- 3. Submit \$10 payment for 4-H program enrollment fees.**
 - a. Online Payment: Credit card payments will be collected using an online survey at <http://ucanr.edu/napaenrollmentfee>; a service fee will be added to the payment.
 - b. Check Option: If you would like to pay by check instead, please make payable to **UC Regents** and drop-off or mail to: UCCE Napa 4-H, Attn: Alia Urrutia, 1710 Soscol Avenue, Suite 4, Napa, CA 94559-1315 (no service fee charged for checks).
- 3. The application is reviewed by the county director.** If approved, notification will be sent from 4hOnline. If there are any limitations on the appointment, a subsequent letter will be sent. If not approved, a letter will be sent to you from the county director.

If your enrollment has not been submitted and approved before December 31, 2020, starting January 1, 2021 you are then not authorized to conduct any 4-H meetings or activities, transport 4-H members, or perform other 4-H adult volunteer duties, until you have been re-appointed and approved.
