2024–25 Bonnie Reiss Leading on Climate Fellowship: Sustainable Agriculture and Food Fellow

The <u>Nutrition Policy Institute</u> (NPI) at the University of California Division of Agriculture and Natural Resources is seeking a graduate student fellow to join our efforts to improve food and nutrition security among currently and formerly incarcerated individuals in California. Our <u>Farm to Corrections</u> project team has been working to implement and evaluate a Harvest of the Month (HOTM) pilot program, which is working with the California Department of Corrections and Rehabilitation (CDCR) to procure local and seasonal produce from small and medium family farms and deliver trauma-informed nutrition education to formerly incarcerated individuals and their family members. This fellowship is an excellent opportunity to gain hands-on public health and nutrition research and program experience while gaining exposure to a team of public health nutrition and food policy experts. This project is a collaboration between NPI and <u>Impact Justice</u>.

This fellowship opportunity is part of the 2024-2025 UC <u>Bonnie Reiss Climate Action Fellowship Program</u>. The UC Bonnie Reiss Climate Action program supports the UC's climate goals by reducing greenhouse gas emission and establishing climate programs and policies centered on equity, sustainability, and resiliency. The UC Bonnie Reiss Climate Action Program funds student-generated research, related projects or internships that focus on regenerative agriculture, sustainable food systems, or sustainable food service operations, and climate resiliency planning. All 10 UC campuses plus the UC Division of agriculture and Natural Resources (UCANR) and Lawrence Berkeley National Laboratory are participating in the program.

Fellows will be part of the Sustainable Agriculture and Food Fellow cohort. In addition to working with the NPI team, fellows will participate in systemwide activities, including a virtual orientation and leadership training in fall 2024, quarterly Fellows meetings, ongoing trainings, a closing symposium and poster presentation, and additional cohort building and continuing education activities. Student Fellows will submit periodic progress reports and a final report at the end of their fellowship.

Fellows will have the opportunity to engage with our Farm to Corrections project in a number of ways, including:

- Identifying and working with food distribution hubs and other local food aggregators; developing nutrition education programming for currently incarcerated individuals; promoting policies to promote continued and expanded procurement of local food on the part of CDCR; and
- Conducting program evaluation, including development of qualitative and quantitative data collection tools; data collection; data analysis; preparation of reports and articles for submission to peer-reviewed journals; and presentation of findings via conferences, webinars, legislative visits, etc.
