There is no evidence that other University systems were impacted. The University is in the process of transitioning to a new file transfer system with enhanced security controls, deploying additional system monitoring broadly throughout its network, conducting a security health check of certain systems, and enhancing security controls, processes, and procedures.
Accellion	My SSN was found on the dark web! Since SSN are connected to individuals for a lifetime, we should be provided a free lifetime benefit for the UC legal plan available at NO cost to faculty/staff/retirees.
