# What is required to buy restricted anticoagulant bait?

Provide the dealer with the following:\*

- Private Applicator Certification (PAC)  
and either
  - A Restricted Materials Permit (RMP)
  - or
  - An Operator Identification Number (OIN)

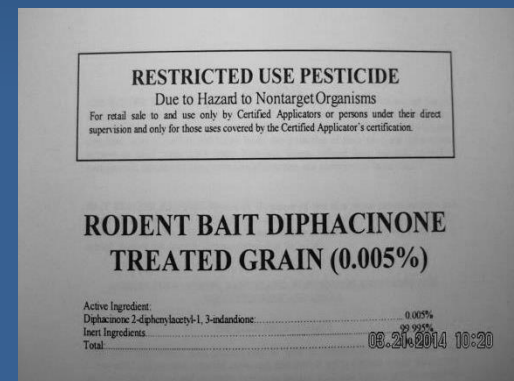
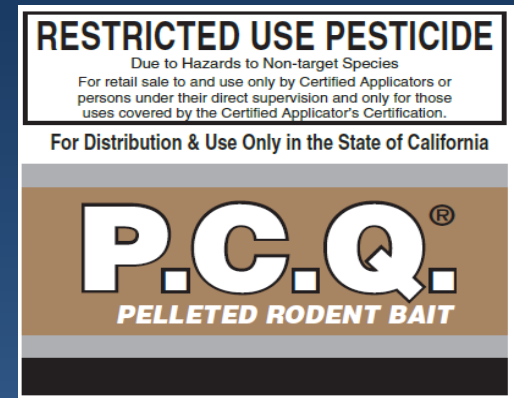

# Prices per 50# bag picked up in Hanford (includes surcharge)

## Chlorophacinone (0.01%)

Fewer than 20 bags	:	\$82.50
20 bags or more	:	\$76.50

## Diphacinone (0.005%)

Fewer than 20 bags	:	\$75.00
20 bags or more	:	\$67.50
