### Sonoma County 2024-2025 **4-H Youth Member Enrollment Process** For 4-H Program Year: July 1, 2024 – June 30, 2025

Revised July 17th, 2024

Youth are eligible to participate in 4-H if they meet the following criteria:

- Primary Member: Must be 5 years old on or before December 31, 2024. Youth who turn 9 on or after January 1, 2025 must participate as a primary member until the end of the program year.
- Junior, Intermediate, and Senior Members: Must be 9 years old on or before December 31, 2024. Youth may join if they are not 19 years old on or before December 31, 2024. Youth who turn 19 and who are already a 4-H member may continue capstone activities through December 31, 2025.



#### **Enrollment Steps**

- Find a local 4-H Club at https://ucanr.edu/sites/SoCo/files/400229.pdf Contact the 4-H Club Leader or visit during a 4-H Club meeting.
- 2. Submit 4-H youth member enrollment online at https://4h.zsuite.org
  - a. New Member: Create a family profile, create a new youth enrollment, enter all information, and submit. Status will show as pending approval.
  - b. Returning Member: Do not create a new duplicate account! Login to your family profile and click "Enroll for 2024-2025." Enter all required information and submit. Your Zsuite status will show as awaiting review.
- 3. Submit \$63 program enrollment fee.
  - Contact your 4-H Club Leader and/or Volunteer Enrollment Coordinator to discuss payment options. Some 4-H Clubs offer credit card payments while others only accept check or cash. Online Payment Option: https://surveys.ucanr.edu/survey.cfm?surveynumber=43271
  - Request Fee Waiver: The 4-H Youth Development Program is open to participants, regardless of their ability to pay. To request a waiver or reduction of program enrollment fees, please submit your request in writing to the 4-H Club Leader and/or Volunteer Enrollment Coordinator. - 4. The application is reviewed by the 4-H Club Leader and the County 4-H Office. When approved, notification of your 4-H youth member will be sent from Zsuite.
