How to enroll in the UCD Citi Human Research Protections Course:

- Go to Collaborative Institutional Training Initiative (CITI)
- Create an account "Register" or log in if you are already a User.
- Select "University of California, Davis" as the participating Institution.
- Use your Kerberos as your username when registering. If your Kerberos is already taken by another CITI user ID, create an alternative username.
- Use your UCD Email address as the "preferred email". By using your Kerberos and your UCD email address when registering, this will help ensure you receive credit for completion.
- Complete the Member Information online form. Once you have provided the member information, you'll be led through a series of screening questions to determine which training course to complete.
