

As of January 2021:

Financial Assistance

The Natural Resources Conservation Service (NRCS) provides financial and technical assistance to forest landowners through the Environmental Quality Incentives Program (EQIP). This cost share program supports landowners in addressing their natural resource concerns and delivering environmental benefits such as improved water quality, reduced soil erosion, promoting healthy forests and rangelands, and improved wildlife habitat. Additionally, for those landowners who have already completed an EQIP project, you may be eligible for funds to help maintain your existing level of conservation and stewardship through the Conservation Stewardship Program (CSP). The NRCS also has natural resource professionals on staff, such as soil conservationists, wildlife biologists, foresters, and rangeland managers, to answer any questions you may have.

Cal Fire provides cost share funding through the California Forest Improvement Program (CFIP). This cost share program provides funding for projects that protect, maintain and enhance productive and stable forest resources (reforestation, stand improvement, and conservation practices), as well as for the improvement of resources such as fish and wildlife habitat, and soil and water quality. Both the CFIP and EQIP programs require a CA Cooperative Forest Management Plan (CCFMP) that has been reviewed and signed off on by a Registered Professional Forester (RPF). CFIP cost share money can reimburse you for the cost of an RPF to prepare your CCFMP. For more information on the CFIP program, contact your local Cal Fire Forestry Assistant Specialist (FAS). My Sierra Woods (MSW) is a grant program administered by the American Forest Foundation and funded by Cal Fire. It provides landowners with reimbursements for fuels-reduction activities such as mastication and hand-thinning, transportation of biomass and reforestation in 12 Northern CA counties (Siskiyou, Trinity, Modoc, Shasta, Tehama, Butte, Yuba, Plumas, Sierra, Nevada and Placer). They are looking to expand into other counties if there is interest and need. Currently, MSW is not taking on new landowners as current fiscal year funding is all allocated. However, they are creating a wait

Resource Conservation Districts (RCDs) are special districts (entirely grant funded) whose purpose is to support and facilitate conservation of natural resources. RCDs provide professional services, technical assistance and advice in forestry and agriculture, assist in grant fund development for projects, mapping of fire infrastructure, and they collaborate with Fire Safe Councils. They are often viewed as a connection between the NRCS and landowners. RCDs also conduct educational programs for landowners such as YouTube channels, workshops and educational events. The U.S. Department of Interior, Bureau of Indian Affairs (BIA) provides scientific and other information about natural resources to tribal members and representatives living on, or managing, trust or allotment lands. The BIA has grant funding for projects related to forest management, forest pest management, Integrated Resources Management Plan development, timber harvesting, endangered species management, watershed restoration and woodland management.
