The Trinity County 4-H Administrative Oversight (AO) team met on Monday, August 11, 2025, at the UCCE office in Hayfork.

- The Trinity County 4-H Program Leadership Team Operating Procedures have been submitted to the State for approval on June 16, 2025.
- The volunteer finance manager, Kathy Johnson, presented the financial report and the proposed budget for the 2025/2026 program year. Enrollment fees will remain the same as the 2024/2025 program year. Adult fees are \$28.00, and Youth fees are \$77.00 (\$67.00 to state + \$10.00 to county).
