PPSM-30 (Compensation) & PPSM-2 (Definition of Terms): Employee Consultation Period

Attached for Employee Consultation is the proposed revision to *PPSM-30 (Compensation) & PPSM-2 (Definition of Terms)*, which is applicable to policy-covered employees in the Professional & Support Staff, Managers & Senior Professionals, and Senior Management Group personnel groups.
