Directions on How to Fill out Opt-In Sensitive Site Application (Reverse Side)

If you would like your location to be considered as a sensitive site in the consideration of your distance from apiaries, please fill in the boxes of the form on the other side with the requested information.

A sensitive site is identified as a location where at-risk people such as the elderly, physically challenged, small children, residents with a documented allergy to bee stings or animals that are confined or with limited mobility inhabit or frequent. The required distances will be measured between the location of the apiary and the property line of the sensitive site.

You will need to provide:

- Your name/address/contact information.
- The address of the potential sensitive site if it differs from your home address.
- The reason for applying (business, allergy, elderly, daycare, etc.). If your concern is due to an allergy, please provide a medical note completed by a physician.
- Please describe your situation in detail and provide any supporting documentation or maps as needed.
- If you are a business owner, please provide a copy of your business license showing business name, license and phone number.
- You must please complete one form for each location being considered.
