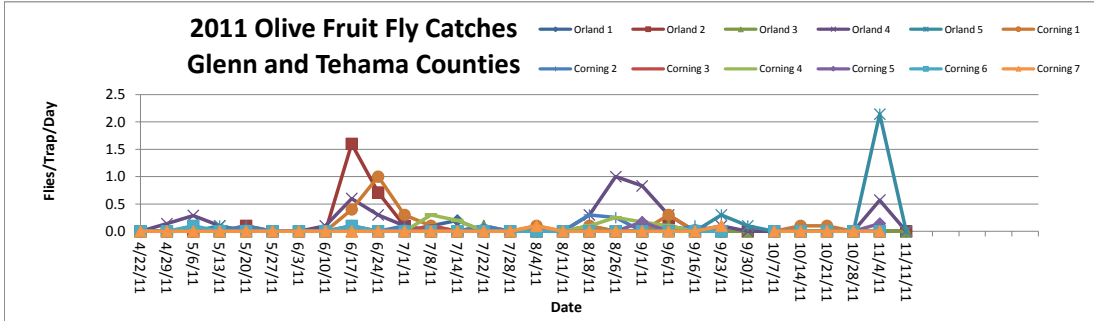


This concludes the Sacramento Valley olive fly trapping program for 2011. Trapping and posting of the results will resume in March or early April of 2012.
