HIGHLIGHTS FOR 2021

- RECORD US CROP of 1.17 BILLION POUNDS
- CALIFORNIA CROP OF 1.15 BILLION POUNDS
 - Previous year was 1.04 billion
 - 409,000 bearing acres
 - 2822 pounds per acre
 - 111,000 nonbearing acres

CROP QUALITY FOR 2021

- OPEN INSHELL 84.7%
 - On the high side for an on year
 - On year is normally about 75%
- Low closed shell, normally up in on year
- Average nut size small

WAS 2021 AN ON-YEAR CROP?

- Tree/orchard/industry, pistachios are historically alternate bearing
 - All indications that tree and orchard alternate bearing continues
 - Industry, last three years are exceptional –

• 2019: 2177 lbs/acre

• 2020: 2806

• 2021: 2822

• Not high yields (3262 in 2018)

WHAT DRIVES INDUSTRY ON/OFF?

- Weather
 - Lack of chill -2015
 - Great chill/bloom weather following off crop (2010)
- Number of acres coming into bearing since last synchronizing event
 - Since 2015: 169,000 acres of mostly Golden Hills
- 2021-2022 not likely synchronizing event
- "Only" 18,000 acres coming into bearing in 2022

PROGNOSIS FOR 2022 CROP TOTAL

- 427,000 bearing acres
- If off year: 2200 lbs/acre
 - 940 million pounds
- If on year: 2900 lbs per acre
 - 1.24 billion pounds
- Unexceptional weather, low new bearing acres => higher upside potential

INSECT DAMAGE in 2021

- LOW < 1.0%
- UNPRECEDENTED 4 YEARS IN A ROW
- WHY
 - Growers continued increased NOW control activities
 - HOST PLANT SUSCEPTIBILITY

HOST PLANT SUSCEPTIBILITY

- NOW larvae can't chew through intact hulls
- Pistachio hulls frequently degrade during maturity
 - Softer, thinner, tears, early splits
- EARLY SPLITS WERE LOW
- HULL INTEGRITY WAS GOOD THROUGH HARVEST

ANNUAL VARIABILITY IN NOW DAMAGE

- DAMAGE
 - GOOD YEARS (2010, 2018- 2021)
 - IN-BETWEEN YEARS (2008-2009, 2011-2012)
 - BAD YEARS (2007, 2013-2017)
- NOW CONTROL PROGRAMS RIGOROUSLY APPLIED CAN IMPROVE OUTCOME FOR INDIVIDUAL GROWERS

STERILE INSECT TECHNOLOGY (SIT)

- RELEASE AREA EXPANDED
 - LESS INTENSIVE GROWER CONTROLS
- CDFA TRAPPING
- SIGNIFICANT NUMBERS TRAPPED
 - An improvement year over year
 - Not at levels that would give significant control

MYCOTOXINS (EU)

- AFLATOXIN
 - Significant regulation across many commodities
 - PEAR Program
- Ochratoxin A (OTA)
 - Regulation in grain, some meats
 - Limits for pistachios have been proposed
 - 5 ppb for finished, 10 ppb for further processing
 - Could be trade disruptive particularly in years like 2016, 2017

MEALYBUG CONTROL

- Some issues with imidacloprid residual levels at harvest
 - Processors discouraged use in 2021
- Registrant conducted field trials in 2021 but data not yet available
- 70% of the pistachio crop is exported and many of the export markets are very sensitive about pesticide residues
- Expect restrictions on pesticide use if there isn't supporting pistachio data

CPRB CONTINUATION HEARING

- Time for the 5 year continuation hearing
 - Notification mailed to all pistachio producers by CDFA
- Normally done following Pistachio Day in a separate conference room
