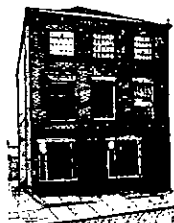


## CHAPTER 9



# COTTON, CO-OPS, AND THE U.S. CIVIL WAR (1861-1865)

The Co-op Withstands the Cotton Famine

*The moral miracle performed by our Co-operators at Rochdale is that they had the good sense to differ without disagreeing; to dissent with each other without separating; to hate at times, and yet always to hold together.*

— George Jacob Holyoake

**I**n 1861 the population of Lancashire was 2,428,440—nearly one-eighth of the population of England and Wales. One million people were employed in Lancashire's textile trade. People throughout Britain poured into the area, eager to find their fortune. The port of Liverpool, which contained 78,000 people in 1801, grew to 438,000 by 1861. The Liverpool Exchange was the center of the raw cotton trade, and Liverpool became a busier port than London. Manchester had grown from 94,000 in 1801 to 460,000 in 1861, and it was the "capital of the north." Rochdale itself had grown from 14,000 in 1801 to 68,000 in 1841.

There were 1,900 cotton mills in Lancashire in 1860. With its looms relentlessly spinning hour after hour, Lancashire was the thriving economic engine of Britain. In 1861 the cotton trade exceeded the gross revenue of the Brit-

ish government for the first time. Capital was receiving interest of 30 to 40 percent. Cotton was indeed king in the American South and in the English North, but its crown was about to be removed.

The early 1860s would be another testing time for the Pioneers of Rochdale. The American Civil War broke out, the North blockaded the South, and the cotton mills of Lancashire could not get their cotton from the Southern plantations in the USA. By 1861, the Confederacy was founded. Two weeks later the news reached Liverpool by cotton boat. That day the price of cotton drove up dramatically and wages for the millworkers went down drastically. On April 12, 1861, brother turned against brother in the U.S. Their blood drenched the American earth. Lancashire's industry died with them as King Cotton collapsed overnight. Of all the English counties, Lancashire bore the greatest brunt of the Civil War.

By November 1861, 49 Lancashire Mills had closed, 119 were on half-time, and eight thousand cotton mill workers were out of work. That same year, withdrawals from savings banks outpaced deposits by the largest amount since the "Hungry Forties." On August 7, 1862, eight thousand cotton operatives met on Lobden Moor to consider the distressed condition of the district. Because of the American Civil War, 8,359 people were out of work in Rochdale in 1863.

Edwin Waugh, a Rochdale native born on Toad Lane, described life during the Cotton Famine of the 1860s:

Just previous to the mills beginning to work short time, four of their five children had been lying ill, all at once, for five months; and before that trouble befell them, one of the lads had two of his fingers taken off whilst working at the factory, and so was disabled a good while. It takes little additional weight to sink those whose chins are only just above water; and these untoward circumstances oiled the way of this struggling family to the ground before the mills stopped. A few months' want of work, with their little stock of shop stuff oozing away—partly on credit to their poor neighbours, and partly to live upon them-

selves—and they became destitute of all, except a few beggarly remnants of empty shop furniture. (Lancashire Sketches, II, 212-213)

The severity of the hunger was immense. At the end of 1862, the soup kitchen in Rochdale was feeding 18,000 people and the Guardians providing relief to 13,226 people each week. In 1863, nearly 27 percent of Rochdale's citizens were receiving relief. In response, Rochdale, always the pioneer, was the second town in Lancashire to form local relief efforts. John Bright, ever the Quaker, implored the citizens to help themselves. The Reverend Charles Kingsley, then also chaplain to Queen Victoria, joined in the national effort to raise money to send to the suffering people of Lancashire. President Abraham Lincoln was well aware of the suffering and sent the following message to the people of Manchester on January 19, 1863:

I know and deeply deplore the sufferings which the working people of Manchester and in all of Europe are called to endure in this crisis. It has been often and studiously represented that the attempt to overthrow this government which was built on the foundation of human rights, and to substitute for it one which should rest exclusively on the band of slavery was likely to obtain the favor of Europe. . . Under these circumstances I cannot but regard your decisive utterances upon the question as an instance of sublime Christian heroism which has not been surpassed in any age or in any country. It is indeed an energetic and re-inspiring assurance of the inherent truth and of the ultimate and universal triumph of justice, humanity and freedom. . . I hail the interchange of sentiments, therefore as an augury that, whatever else may happen, whatever misfortune may befall your country or my own, the peace and friendship which now exists between the two nations will be, as it shall be my desire to make them, perpetual.

Fortunately, the voters of Rochdale had returned Cobden as their M.P. in April 1859, even though he was in the United States at the time. Abraham Greenwood, a Rochdale native and a champion of the cooperative wholesale was one of Cobden's official nominees. The election had been a bitter one, with the shopkeepers attacking Cobden as well as Bright for being the champions of the Rochdale Pioneers. Cobden's voice energized the nation to help Lancashire, and he issued the challenge, "We need a million pounds." The driving force behind the Lancashire relief efforts was Rochdale-born Sir James Kay-Shuttleworth, who had been brought out of retirement for the cause.

John Bright, always full of practical ideas, made a suggestion to U.S. Senator Charles Sumner. If people in the North could organize a donation of flour to the people of Lancashire, it would make for excellent propaganda. Collections were conducted in New York, and ship owner George Griswold offered to transport the food for free. His ship docked in Liverpool in February of 1863 with fifteen thousand barrels of flour on board. For many years, John Bright displayed one of the barrels at his factory in Rochdale.

Norman Longmate's book, *The Hungry Mills*, points out that Britain's role in the American Civil War was an extremely mixed one. He argues that, in general, public opinion in Lancashire was cautiously favorable to the South. Most people looked at it as a bread-and-butter issue—they wanted work but were not favorable to slavery.

"Only one cotton town stood out against the prevailing tide, the town where John Bright had both his business and his home," Longmate reports.

"It was a great time in Rochdale," wrote Bright's daughter, "with all its cotton workers in idleness and . . . alive to the reason. A meeting was called in the town in 1863 by a Liverpool association of Southern sympathies, formed to promote the breaking up of the blockade. The lecturer delivered his address, and the meeting passed a resolution censuring him for endeavoring to mislead them."

Supporters of the Northern Program ultimately took con-

trol of the hall and severely mishandled the lecturer.

Jacob Bright had moved to Rochdale in 1802 and started the second cotton mill in the town. When Lord Byron sold the manorial rights to the Dearden family, municipal affairs fell into neglect. Parliament had to appoint Commissioners to take responsibility for the town. Jacob Bright, then the local leader of the Quakers, worked hard to deal with the town's problems. Rochdale's leading citizens petitioned Parliament for a Municipal Charter. When it was awarded a charter in 1856, Jacob Bright became the first mayor. As Mayor, Jacob Bright agreed to be one of the Arbitrators for the Cooperative Manufacturing Society and the Corn Mill Society.

Jacob's son would become one of the nineteenth century's most remembered politicians. John Bright (1811-1889) was a radical Quaker orator and "Free Trader" who developed a thriving cotton manufacturing business in Rochdale with his father and his brothers. John Bright was one of the keynote speakers at the opening of the new Free Trade Hall in Manchester in 1843. The Free Trade Hall in Manchester was built on the Peterloo site. That year John Bright was elected M.P. for Durham. By 1847, the Brights employed one thousand people in Rochdale. In 1868, John Bright was received by Queen Victoria when he became President of the Board of Trade. He was the first Quaker to become a Minister of the Crown yet he never forgot the yearning for democracy and the example set by the Pioneers.

Mr. John Bright, when speaking in the House of Commons on the 18th of June, 1860, on the subject of Parliamentary Reform, dwelt on the history of the Rochdale Pioneers' Society, the Corn Mill Society, and the Manufacturing Society; and in passing a high eulogium on the members of these societies, said: "I have thought it desirable to place these facts before the House because I am able to produce evidence of everything I have said in regard to them, for I know many of these men and the establishments. I know something of the working population among whom I live, and I believe there is not a person in this House who will dare to stand up after I sit down, and

say with respect to the men who have thus conducted a large business, saved their money, and promoted all these means of spreading education, intelligence, and sobriety amongst the people, that it would be perilous to the institutions of this country—if those institutions are worth anything—to give such men a vote for members of Parliament.”

Soon the tide would turn in America against slavery but freedom would come a century later.

On April 9, 1865, General Robert E. Lee surrendered at Appomattox, Virginia, and the dreams of the Confederacy died. At the time Rochdale was full of electioneering for the seat previously held by Richard Cobden. On election night, poll results were being announced every hour in the town square, where a crowd began to build that soon filled the square. The final result: Thomas Bayley Potter had been elected to succeed Cobden. Speaking to the great gathering, Potter thanked the people and then paused, “But I have better news for you. Richmond has fallen.” A. Henry Brown wrote, “Then arose a cheer more deafening than any of the previous shoutings . . .” The son of the American Minister at Paris had gone to Rochdale to witness an English election and was standing with Potter. He remarked, “Mr. Potter, if that cheer could have been carried across the Atlantic, Americans would think very differently of your country.”

Bright admired Abraham Lincoln and strongly supported the North during the U.S. Civil War. His greatest service to his country was in keeping Britain out of the war on the side of the South. Because of the role of John Bright and the support of Rochdale for the North during the Civil War, the United States government presented Rochdale Town Hall with a bound volume of the addresses to Mrs. Lincoln after President Lincoln’s assassination. In 1865 there had been a Town Hall meeting to express indignation at the assassination of President Lincoln. In 1871, the American Consul presented President Lincoln’s gold-headed staff to John Bright, in accordance with the President’s wishes.

On November 16, 1881, John Bright’s seventieth birthday was celebrated by Rochdale’s citizenry. There was a

torchlight procession to Cronkeyshaw, where thirty thousand people joined in the festivities. When Bright died in 1889, the people of Rochdale gave him the biggest funeral of the century. Bright had been at different times an M.P. for Rochdale, Manchester, and Birmingham during the era of reform. His leadership on the issues of the day and his strong sympathies for the needs of working people made him one of the true heroes of his age. At Birmingham on January 20, 1864, John Bright had said:

My clients have not been generally, the rich and the great, but rather the poor and the lowly. They cannot give me place of honor and dignity and wealth: but honorable service in their cause yields me that which is of higher and more lasting value.

The British labor historian Asa Briggs described Bright as one of the most militant and eloquent middle-class radical politicians of his time, whose tactics as much as his principles were frequently criticized.

Rochdale was suffering badly as a result of the American Civil War. The cotton industry almost came to a standstill, and Lancashire verged on economic ruin. In 1862 the soup kitchens at Rochdale were feeding eighteen thousand people per week and the Poor Guardians were assisting thirteen thousand people a week. In 1863 there were over eight thousand people unemployed in Rochdale, mostly as a result of the Civil War.

William Cooper later reflected on the meaning of the American Civil War to the co-op:

Though the people have been great sufferers by the struggle brought on by the slaveholders in America none of the unprincipled advocates of the abominable cause of the South could move them from siding with the North and freedom of the slave; for the people love liberty and would not help to hold another people in bondage.

Lord Brougham spoke to the National Association of So-

cial Science in 1863 about how the force of the Pioneers' newsroom and education program shielded their cooperative from the ravages of the Cotton Famine. He concluded his remarks by stating that the Pioneers were "a striking example of the beneficial influence of Cooperation."

There is one postscript to this part of the story. During the Cotton Famine, the Union and Emancipation Society of Manchester was key in affecting public opinion. Its president was Thomas Bayley Potter, M.P. for Rochdale. J. C. Edwards and E. O. Greening, both ardent cooperators, were the honorable secretaries. Edwards was cashier for the Co-operative Wholesale Society from its start and remained in that position until 1868. Brown tells the story of Edwards' enthusiastic and unflagging support of the American cause. When the Co-operative Wholesale Society adopted its distinctive motto, "Labour and Wait," Edwards suggested that it should rather adopt "Labor and Wait," to permanently remind cooperators of the role of freedom and to honor the American cause. The change delighted the Co-operative Wholesale Society board, many of whom came from Rochdale and nearby towns.

With Thomas Bayley Potter, M. P., in the chair, the Union Society held its final meeting on January 22, 1866. Mr. Goldwin Smith, the society's secretary, ended his farewell address with these words: "Slavery is dead everywhere and forever." Within hours, he was in the co-op at Toad Lane celebrating with friends and cooperators and signing the visitors' book. Smith reminded the gathered cooperators to be watchful of all things essential to human well-being. John Bright came into the store shortly afterward and added his to the other honored names in the Toad Lane visitors' book.

The war was over, and worries about the price of raw cotton were once again the talk of Liverpool. From a height of over 485,000 people on relief in December of 1862, the numbers dropped dramatically, and by May of 1865 the count stood at 76,000. Lancashire had weathered the storm, but not without cost. Cotton was no longer king. Manchester and Liverpool had adapted to the war by weaning themselves away from a heavy reliance on cotton. That same April of 1865, Richard Cobden died. On the day of his funeral all the shops and the eight branches of the Society were closed for



three hours as a mark of respect for everything Cobden had done for the co-op and for Rochdale. Knowing slavery had been defeated and Rochdale revived, Cobden was at peace with the world he had changed.

Two events in the late 1860s mark the successful evolution of the co-op and the town of Rochdale through the Civil War years. As an M.P. in 1866, Bright laid the foundation stone for the Rochdale Town Hall, with all the co-op leaders in attendance. Opened in 1871, the Town Hall is one of the finest neo-Gothic buildings in England and is a lavish Victorian tribute to the creation of individual wealth and the newly arrived mill owners. It stands as one of the most exquisite representatives of Victorian architecture in Britain, 303 feet long and ornately decorated. The Town Hall dwarfed every other municipal building in the region with its magnificent spire rising 240 feet into the sky. A later fire destroyed the spire, and a clock tower similar to Big Ben was built in its place. The Great Hall in the Rochdale Town Hall is now the site of most major events in Rochdale. The Great Hall will be the venue for a ceremonial dinner on December 21, 1994, as the concluding event of the 150th anniversary celebrations.

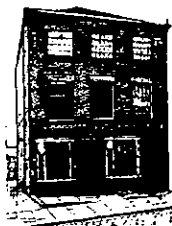
Just minutes away lay the new Central Stores of the Pioneers, a thriving tribute to the practices and principles of mutual self-help. It was a proud day for the seven thousand members when the Pioneers' Central Stores opened on September 28, 1867. The Mayor of Rochdale, Mr. J. Robinson, presided over the ceremonies, and co-op supporters Thomas Hughes, M.P., E. V. Neale, George Jacob Holyoake, and E. O. Greening were among the speakers. An invited speaker and special guest at the Co-op's opening ceremonies was a Colonel Hinton from Washington, D. C. Colonel Hinton had trained and commanded Black regiments to fight for their freedom on the side of the North during the Civil War.

The four-story Central Stores building was topped by an attractive beehive adorned by a large clock. For years, the beehive had been a symbol of hard work and cooperation. A beehive now decorates the rear wall of the Pioneers Museum on Tbad Lane. On the fourth floor, at the top of the central stores building, was the Pioneers' Hall, which could hold 1,500 people. The co-op included a huge newsroom to house

the newspapers and magazines of the day. In the tradition of the Pioneers, the massive department store, built at a cost of 13,400 pounds cost much less than the 155,000 pounds it cost to build the Town Hall. The Pioneers' new store paid for itself quickly. The Pioneers did not mind a big building as long as it made "brass" (money in Lancashire dialect).

The new stores stood at the juncture of St. Mary's Gate and Toad Lane, at the site of the former Wesleyan Chapel, then the Old Theatre (built in 1793). How much of Rochdale's past had taken place at that site: the simple preaching of the founder of Methodism, John Wesley; the Chartist rousings of the Irish orator, Feargus O' Connor; the public passion of the popular local M.P., Richard Cobden; and the pacifism and pragmatism of John Bright, the Quaker mill owner, M.P., and Minister of the Crown. The Pioneers were keeping good company.

## CHAPTER 10



# Together They Build

Co-operation Among Co-operatives

*They took their affairs into their own hands, and what is more to the purpose they kept them in their own hands.*

Rochdale's success was being repeated across Britain. Within two decades of Rochdale's founding there were hundreds of co-ops to be found in almost every major city and in many villages of northern England. The Rochdale principles and practices were being ardently followed and the flourishing dividend copied. Cooperative missionaries were in demand, speakers were rushing from one meeting to another, and the cooperative idea was the talk of the town. As the co-ops grew in neighboring towns they recognized there were many opportunities to unite together to increase their business and reduce their costs. Like bricklayers, they knew that placing one brick on top of the other was the surest way to build a foundation for the cooperative movement.

On August 12, 1860, a meeting was called that would change the face of cooperation forever. From that meeting emerged the impetus for the Co-operative Wholesale Society, followed by the Co-operative Insurance Society and, later, the Co-operative Union. Attending the meeting were representatives of cooperatives from Rochdale, Oldham, Manchester, and other towns of east Lancashire. They were meeting to

discuss formation of a jointly owned cotton mill, but reports of the meeting show that the topic which galvanized the attendees was, once again, discussion of a developing wholesale cooperative.

Time and time again the creation of a wholesale business occupied cooperators' discussions. It came up at conferences, was often written about in articles, and was the conversation of managers and the goal of numerous boards of directors. The continuing growth of existing cooperative societies and the development of new ones heightened the need. Rochdale had even attempted a wholesale agency, which it had to finally close down.

The meeting took place at Jumbo Farm near Middleton, six miles from Rochdale. The farm was a favorite meeting place for the area cooperators. Its central location made it easy for cooperators from a number of major societies to meet there on weekends. The atmosphere of the farm was also conducive to the dreams of cooperators. It was established in 1851 when a group of cottage workers decided to go back to the land. They rented the farm and six acres and renamed it Lowbands, in honor of the Chartist Estate in Gloucestershire. When they ran into economic trouble, they hired George Booth as manager. He helped them form the Jumbo Co-operative Society and opened up a small neighborhood co-op store at the farm. By 1861, the members sold off their assets and merged into the nearby Middleton Society. Booth was later appointed as an official of the Co-operative Wholesale Society.

For a decade Jumbo Farm was host to gatherings of numerous cooperative, labor, and other progressive groups. Its open-air atmosphere provided an attractive place for teas, picnics, and Sunday festivals. In that era, a day in the country on a farm was a cherished opportunity for working people. With Sunday being the only day off for most people, a picnic at Jumbo Farm was an eagerly anticipated activity.

Since 1856, George Booth had been an active supporter of the idea of a cooperative wholesale business. As host of the 1860 gathering at Jumbo Farm, he introduced the topic of the Wholesale Society. The talk ran again to the problems of starting a cooperative wholesale business, due to the limita-

tions of the law, which prevented cooperatives from investing in other corporations. At that time, there was no mechanism for primary cooperatives to organize secondary cooperatives such as wholesales. They could start a joint stock company or assign ownership to individuals to hold in trust, but there was great caution against either method. Once again those assembled adjourned without an answer.

After further meetings at Jumbo Farm and elsewhere in the area, the group drew up a five-point platform of legal rights:

- ◆ Cooperatives to be allowed to own more than one acre of land
- ◆ Acquisition of property to be unrestricted
- ◆ Cooperatives to be allowed to invest in other societies or companies
- ◆ Limited liability to be given under the Industrial and Provident Acts
- ◆ Educational grants to be given legality

This platform was reported to a conference of fifty to sixty delegates held on Christmas Day in 1860, under a railway arch in Manchester. The committee that drew up the platform included Charles Howarth, "the constitution maker" of the Rochdale Pioneers, and two of the twenty-eight founders, William Cooper and James Smithies. Abraham Greenwood, one of the early members and another giant of cooperation, was also part of the group.

The committee's recommendations were adopted, and a small subscription was raised to pay for further efforts. A subcommittee was appointed to propose legislation to E. V. Neale, the great friend and legislative champion of the cooperative movement. The fight had begun!

Percy Redfern, author of *The Story of the Co-operative Wholesale Society*, wrote about the group:

With all their differing individualities, there was a remarkable bond of common character between all these founders of the Co-operative Wholesale Society. Independence with them was a passion. If they wanted money it was not for lucre's sake, but that

they might enjoy freedom . . . This mating in them of qualities derived from the soil and Christian ethics was to be represented by the matter of fact yet idealistic structure they now meant to build.

By late June of 1861, R. A. Slaney, M.P., had brought the bill desired by cooperators before the House of Commons. Richard Cobden, M.P. for Rochdale, was a major backer and John Bright, then M.P. for Manchester, was on hand to assist. However, delays due to Slaney's ill health prevented its passage that year. The next year, the Rochdale Co-op sent James Smithies and Abraham Greenwood to London to lobby for passage. Slaney was too ill, and Bright had to gain the services of another M.P., J. Southerton Estcourt, to carry the bill.

Support of both the Conservatives and Liberals was assured, and after slight amendment, the bill passed both houses and received royal assent. The law still had its imperfections. Although co-op societies now had freedom to invest, they were limited to investing no more than two hundred pounds in another society.

On Christmas Day, 1862, the cooperators once again gave up their holiday to meet in the King Street store of the Oldham Co-op. This time it was to be a joyful occasion, for victory was theirs! It was reported that "one thousand six hundred postal communications," including letters, petition forms, fund requests, and circulars, had been sent to Parliament by co-op activists during the two-year effort.

By Easter of 1863, the cooperators were ready to do business. They met in Manchester, numbering two hundred delegates from all over England. A motion was passed to establish the North of England Co-operative Agency and Depot Society Limited. "A more delightful meeting of Co-operators I never attended," said a correspondent in the pages of the May 1863 *Co-operator*. By the end of that year, forty-eight societies had joined, almost a quarter of those in existence in England at the time. In 1864 the Co-operative Wholesale Society would begin business. Although there were to be many ups and downs in the early years, the Cooperative Wholesale Society sustained almost continuous growth for decades.

The coming of age of the Co-operative Wholesale Society

is probably best reflected in its role as one of the key supporters of the Manchester Ship Canal. Since 1882, the Co-operative Wholesale Society had subscribed annual organizational expenses for the promotion of the canal. In fact, to show its confidence in the Canal company, the Co-operative Wholesale Society bought ordinary rather than preference shares, and lent 20,000 pounds to the project. In his *History of the Manchester Ship Canal*, Sir Bosdin Leech stated, "This [coop support] was in marked contrast to the tardy support given by many leading merchants and capitalists of the district, who either held aloof entirely, or contributed the smallest sum that money would allow."

In 1885, John Mitchell, Chairman of the Co-operative Wholesale Society, gave testimony in favor of the canal at hearings at the House of Lords in Westminster. Mitchell believed it was a critical advancement for both the commerce and people of northern England. Almost thirty years earlier, Mr. T. Livesy spoke on behalf of Rochdale to a similar parliamentary select committee that was looking at the costs of local shipping charges to inland towns. He stated that Rochdale was paying Liverpool 4,100 pounds annually for import and export duties.

Queen Victoria opened the canal on January 1, 1894. Ten thousand people from Rochdale went to Manchester to participate in the celebration. The Co-operative Wholesale Society's own steamship, *S. S. Pioneer*, was given the right to lead the first convoy through the canal. The honor of wheeling off the first case of sugar was given to John Mitchell, the Chairman of the Co-operative Wholesale Society, who had never wavered in his support for the canal. From then on, ocean-going ships from every corner of the world were able to sail into the heart of industrial Manchester. The savings to the Co-operative Wholesale Society in both shipping costs and transportation time were substantial. No longer did everything have to be off-loaded in Liverpool and then sent by railroad to the Co-operative Wholesale Society warehouses in Manchester.

In 1884, a joint delegation from the Co-operative Wholesale Society and the Scottish Co-operative Wholesale Society visited the United States and Canada. On this trip, Mitchell,

the delegation leader, outlined his dream to unite the purchasing power of the British, Canadian, and U.S. consumer cooperative movements through the Co-operative Wholesale Society depots in each country. His proudest moment occurred when he presented the balance sheet of the Co-operative Wholesale Society to U.S. President Grover Cleveland.

### **The Immense Contribution of John Mitchell to Consumer Cooperatives**

The role of John Mitchell is intertwined forever with the early growth and success of the Co-operative Wholesale Society and its rise to prominence as Britain's largest wholesaler and one of the country's largest employers. His practical impact on the movement towers over that of any other British cooperator.

Mitchell was born in Rochdale in 1828. His grandfather had been a member of the earlier co-op store at 15 Toad Lane and of the Owenite Queenwood Community. Mitchell joined the Rochdale Pioneers in 1853, when he was twenty-four. He served on its management committee in 1856 and later on its library committee. He attended the adult classes given by the Pioneers, a benefit he never forgot. He was secretary to the Pioneers' arts and sciences classes for over fifteen years. When the Borough of Rochdale merged the co-op classes into its Municipal Technical School, Mitchell became the first secretary and served in that role until his death.

For the first forty years of his life, Mitchell belonged mostly to Rochdale. In 1869, he was elected to the board of the Co-operative Wholesale Society, and he was chairman from 1874 until his death in 1895. He was nicknamed "Baron Wholesale" because of the immense power he held as chairman of the Co-operative Wholesale Society. Beatrice Webb and others would say that it was his views that defined the theory of consumer cooperation. Mitchell debated frequently with other co-op leaders at the Co-operative Congresses and other large meetings. He was favorable to neither workers' cooperatives nor workers' domination of consumer cooperatives. On this topic, he engaged in many debates with the Christian Socialists. For one of the best accounts of this critical period of cooperative practice and philosophy, consult



Philip Backstrom's masterpiece, *Christian Socialism and Co-operation in Victorian England*.

When he died, Mitchell had achieved greatness and respect. The coffin at Milton Church in Rochdale where he taught Sunday school was covered in flowers from cooperators and school children. Redfern recounts, "An enormous concourse went to the grave or lined the streets to watch the long procession. Not since the death of John Bright had Rochdale born such witness." He had been born, lived there his whole life, and then had died there. From a humble—and likely illegitimate—birth, and a childhood spent in a beerhouse, he had risen to become one of England's most powerful merchant voices. As an idealistic young man with practical qualities, he had achieved more of his dreams for working people than almost any other progressive leader of his time.

On his grave in the Rochdale Cemetery, the Co-operative Wholesale Society erected a granite monument on which is engraved the following passage from one of Mitchell's addresses:

The three great forces for the improvement of mankind are religion, temperance, and Co-operation; and as a commercial force, supported and sustained by the other two, Co-operation is the grandest, noblest, and most likely to be successful in the redemption of the industrial classes.

"The romance of the wholesale side of the movement," says Catherine Webb in *Industrial Co-operation*, "is not in its inception, but in its marvelous growth and expansion, and in the possibilities that yet lie before it. But for being illuminated with the cooperative spirit and enthusiasm of the founders, its origins might also be counted a commonplace evolution of sound commercial practice."

### **The Growth of Cooperative Enterprise Through Unity**

The Co-operative Wholesale Society continued at a fast pace during the latter part of the nineteenth century. The Co-operative Wholesale Society played other major roles as it expanded the organization to serve the needs of the millions

of consumers who patronized its member societies. The following activities depict the vigorous growth of the Co-operative Wholesale Society—

◆ **Production**

In 1873, the Co-operative Wholesale Society began production of items to be sold in co-op stores with the introduction of Co-operative Wholesale Society biscuits and shoes. Eventually the Co-operative Wholesale Society entered into the manufacture of almost every domestic product the cooperatives sold. Among these were bread, flour, jams, clothing, furniture, and soap. The Co-operative Wholesale Society makes 60 percent of its own brand goods in its own factories. Today the Co-operative Wholesale Society has twenty factories operating throughout most of England.

◆ **Farming**

The Co-operative Wholesale Society continued the co-op's long-term interest in food purity and quality by purchasing estates not only in Britain, but throughout the world. As a result, the Co-operative Wholesale Society is now Britain's largest commercial farmer, with over 45,000 acres of cultivated land. The Co-op's "Farm World" near Leicester is Britain's biggest working Farm Park visited by thousands of people yearly.

◆ **Dairy**

In its early stages, the Co-operative Wholesale Society developed contracts with Danish and Irish creameries to supply butter to the British cooperatives. While the Co-operative Wholesale Society encouraged development of an Irish farmers' cooperative movement, the relationship between them became unworkable. To ensure its dairy supply, the Co-operative Wholesale Society entered the creamery business in 1896. In the twentieth century, the cooperatives were to become Britain's major milk distributor, providing one-third of the households with their daily milk.

**◆ Banking**

In the 1870s, the Co-operative Wholesale Society had to engage in major efforts to manage its cash flows. Limited by laws on investments by and in other cooperatives, the Co-operative Wholesale Society set up a Credit Agency to administer its millions of pounds in cash. By 1872, the Co-operative Wholesale Society had set up a Loan and Deposit Department, which existed until 1876, when legal restrictions were removed and the Co-operative Wholesale Society Bank was founded. Over time, the bank became the main deposit institution of the cooperative societies, trade unions, working men's clubs, and other popular institutions. Thousands of cooperators and trade unionists became depositors, and from 1909 to 1929 the bank's deposits rose from three million pounds to forty million pounds.

Today the bank, now called The Co-operative Bank, is the most innovative bank in Britain. Its commitment to putting the consumer first, in both philosophy and practice, has won it numerous awards. Its recent commitment to an ethical policy has proved very popular. The Co-op Bank has the largest in-store banking network in Europe. It scores highest of Britain's banks for customer satisfaction and recommendation.

**◆ Insurance**

The idea that co-op members and societies might develop their own insurance service had been raised for decades before the Co-operative Wholesale Society was founded. The idea began to take shape on Good Friday, April 19, 1867, at a meeting in a co-op store in Manchester. Delegates representing 65 cooperative societies in the Manchester region met to review the insurance needs of 151 societies that had participated in a survey. The delegates decided to proceed with the establishment of an insurance company, which was registered on August 29, 1867. The board of directors was elected at the first official meeting, which was held

on November 16, 1867.

The first office was registered at the Pioneers' Buildings on Toad Lane in Rochdale until 1871, when it was moved to the Co-operative Wholesale Society in Manchester. Charles Howarth and two other directors from Rochdale were three of the original seven directors. The company went to work immediately, insuring the co-op stores against fire and property damage. Other lines of business insurance were soon added, because the co-ops had diverse insurance needs which they preferred to meet through their own company. In response to member demands for coverage, individual life insurance was added in the 1880s.

The Co-operative Insurance Society has gone on to become one of the most important insurance companies in Britain. Today Co-operative Insurance Society holds 9 billion pounds in assets on behalf of its over four million families, one of the largest market shares in the U.K. Co-operative Insurance Society's staff of 12,500 are based at 224 locations throughout the UK. Not only has the Co-operative Insurance Society flourished in Britain, but it also has played an important role in assisting the development of other cooperative insurance societies throughout the world, particularly in former British colonies.

### **The Co-operative Union**

The Co-operative Union was formed in 1869 to link together the interests of the many societies and to assist in the development of new co-ops. The Co-operative Union has evolved as a national coordinating, advisory, and information body of the cooperative movement. The union also participates in many international cooperative conferences, and monitors political and legislative activity. All co-ops in Britain are eligible to join, and almost every sector is a member. The Co-operative Union holds an annual Co-operative Congress, which is the Co-op Movement's Parliament. A thousand delegates are expected to attend the Co-operative Congress in Rochdale during the anniversary year of 1994.

The Co-operative Union is responsible for the Co-operative College at Stanford Hall near Loughborough. The Co-operative College is an educational charity dedicated to the memory of the Rochdale Pioneers. The College conducts a varied range of both short and long courses, some that focus on education and others that focus on management. The College offers advanced studies in management policy and post-graduate diploma courses in international development.

### **The Co-operative Party**

Owing to various forms of legislative discrimination and attacks against their legislative and tax status, cooperators in Britain often needed parliamentary help. Rather than beg to be heard politically, they formed the Co-operative Party in 1919 to give cooperators a voice in Parliament. Today the Co-operative Party is working all the way from the local council to the European Parliament. There are now fourteen Co-operative-Labour members in the House of Commons, five Co-operative-Labour peers, four Co-operative-Labour Euro M.P.s, and many hundreds of Co-operative-Labour members of municipal councils. John Beasley, Mayor of Rochdale for 1994-1995 is sponsored by the Co-operative Party.

### **The International Co-operative Alliance**

The International Co-operative Alliance was founded in 1895 in London. Much of the early leadership which created the International Co-operative Alliance came from the Christian Socialist group working with the British cooperative movement. E. V. Neale in particular gave tremendous effort to get the International Co-operative Alliance going.

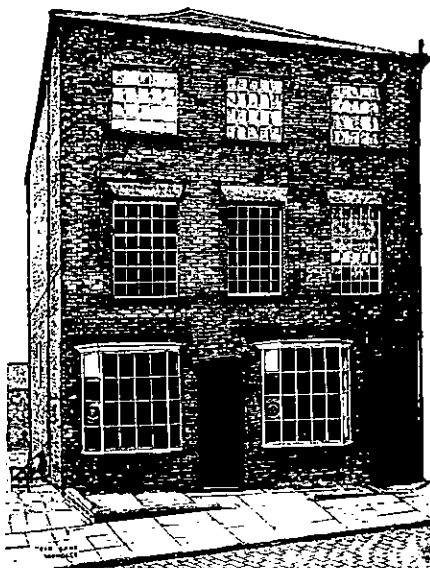
By the end of the 150th anniversary year, there will be over 100 countries represented at the International Co-operative Alliance through over 200 organizations. In 1844 there were 28 members who started the co-op in Rochdale; by 1944 there were 72 million members of the International Co-operative Alliance; and by the end of 1994, there will be 720 million members in the International Co-operative Alliance member organizations. A tenfold increase in fifty years is amazing growth for an idea 150 years old.

The International Co-operative Alliance represents the

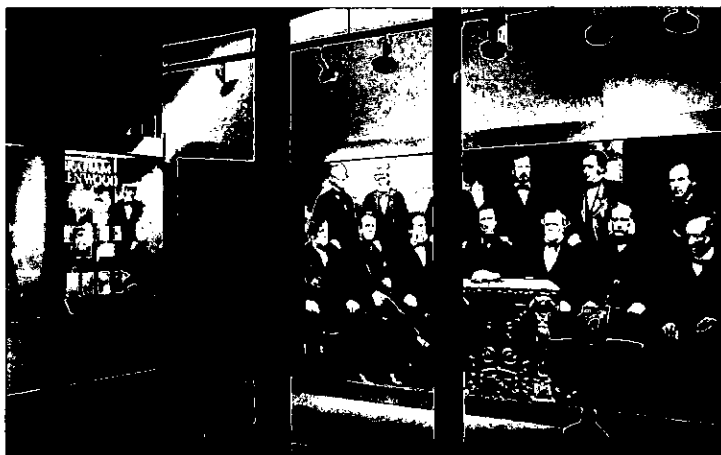
interests of the world's cooperatives from their headquarters in Geneva, Switzerland, and through a number of regional offices. The International Co-operative Alliance's membership comes from every sector of the business world and every part of the globe.



*New Lanark in Scotland, the model village created by Robert Owen in the early 1800's is visited by over 100,000 people a year. Owen, a practical Utopian, was the founder of the first wave of cooperatives in Britain in the 1820's and 1830's. He is known for initiating laws on childhood education, health and labor conditions, model factories and communities. New Lanark, now an historical site, preserves one of the most successful community experiments of the industrial age.*



*The Rochdale Society of Equitable Pioneers opened for business on December 21, 1844. The first modern cooperative began as a humble shop with five items for sale: flour, sugar, oatmeal, butter, and candles. When the co-op opened on the ground floor of 31 Toad Lane in Rochdale, England, it set in motion a model of mutual self-help. In 1994 there were 722 million members of cooperatives worldwide. This drawing by C. W. Chapman was presented to the Cooperative Union on the 125th anniversary of the Pioneers.*



*On the ground floor of the Pioneers' Museum are a number of exhibits. A popular mural photograph is that of 13 of the remaining Pioneers taken in the 1860's. In front of the mural photograph on the right is Charles Howarth's table. On this table he wrote the Rochdale Principles and developed the ideas leading to the birth of the modern cooperative movement.*



*The upper two floors of the Pioneers' Museum are now one. In earlier years the upstairs had been the reading room, library, and education center for the cop. This room is the birthplace of the University Extension and Adult School Movements which revolutionized and popularized education. The delegation from the National Cooperative Business Association of the United States are seen here being greeted by John Beasley, the Mayor of Rochdale during a commemorative dinner held at the time of the 1994 opening ceremonies of the 150th anniversary.*





The Co-operative Women's Guild is the most successful women's organization ever to exist in Britain. For over 100 years the Guild has been at the forefront of changing living conditions for women, children, and working people. The work of the Guild helped bring about the vote for women and assured them of their property rights. At its height in 1938 the Guild counted over 83,000 active members. Their legacy is to have educated and trained many of the women in Britain who went on to become town councilors, elected officials, and full and contributing citizens of their communities, their country, and many international organizations.

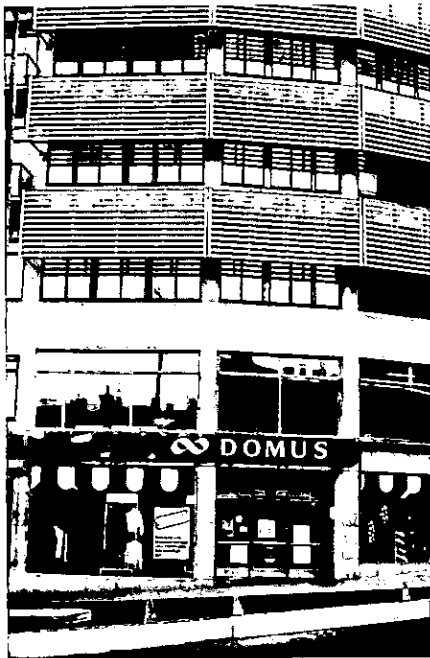
By the late 1850's, there were hundreds of co-ops all across Britain. Whenever the co-op leaders met they discussed unifying their economic activities. From a meeting at Jumbo Farm, near Rochdale, in 1860, emerged the idea of the Co-operative Wholesale Society. Later the visionary co-op leaders created the Co-operative Bank, the Co-operative Insurance Society, the Co-operative Building Society and the Co-operative Union and were leaders in establishing the International Co-operative Alliance.



*One of the original objectives of the Rochdale Pioneers was to establish a cooperative community for their members. They built their first houses in the early 1860's and in 1867-88 constructed a cooperative estate of 84 houses in Rochdale with two of the streets being named Equitable and Pioneers. By the turn of the century, the different cooperative societies in Britain had built nearly 25,000 homes for their members. During this century, the housing programs became too large for the local co-ops and were replaced mainly by government and building society programs.*



*Ebenezer Howard, the father of the Garden City Movement was struck by the Pioneers' cooperative model and advocated housing, consumer, worker and agricultural cooperatives for a central role in the first Garden City in Letchworth, England. For many years Howard lived in Homesgarth (pictured above), a housing cooperative in Letchworth. One of the legacies of the Pioneers was to take the idea of the model village out of the pockets of the philanthropists and place it in the hands of the people. The cooperators gave impetus to the cooperative housing movement, council housing, and the democratic community.*



Sweden and the other Scandinavian nations all have strong cooperative sectors. Pictured here is a Domus department store in Stockholm, one of the nearly 1500 co-op stores in Sweden. There are over 2 million members of Swedish consumer cooperatives and two out of three households are connected with the cooperative movement. KF, the Cooperative Union and Wholesale Society, is the fourth largest company in Sweden and accounts for about 20% of the sales of everyday items.



The Mondragon system of cooperatives in the Basque Region of Spain are renowned worldwide. Through its development bank, an educational institute, an enterprise division, and over 100 self-governed, worker-owned enterprises, Mondragon is a unique success. A Basque priest, Father Jose Maria Arizmendiarieta, developed the first cooperative in 1956 from reading about the ideas of Robert Owen and the Rochdale Pioneers. With over 3 billion dollars in sales and over 25,000 worker-owners, it is the largest corporation in the Basque Region and the fifteenth largest in Spain.



*With over 1.3 million active members and nearly 40 stores nationally, Recreational Equipment Inc., is the largest consumer cooperative in the United States. REI was founded in 1938 to pool the purchasing power of a group of mountaineers in Seattle, Washington, who wanted to import quality climbing gear from Europe. The co-op has grown into one of the leading retailers of recreational goods in the USA. In the photo, a group of REI members and staff take a training course in the Rocky Mountains.*



*In the United States, the National Cooperative Business Association established a Co-op Year Committee to coordinate the celebrations of the 150th anniversary. The highlight was a Cooperative Economic Summit in Washington, D.C. attended by nearly 200 co-op leaders. As part of the Co-op Year celebrations an NCBA delegation attended the opening ceremonies in Rochdale. The U.S. delegation is seen presenting a number of gifts from the U.S. cooperative movement to the Rochdale Pioneers Museum.*



*Throughout Latin America there are thousands of cooperatives both large and small serving nearly 14 million members. Here on the streets of San Jose, the capital of Costa Rica, a vendor makes a living selling the products of Dos Pinos. Dos Pinos is a farmer-owned dairy cooperative which markets 60% of the milk production of Costa Rica. The Dos Pinos symbol originated in the United States as Twin Pines and is found throughout the Americas as the symbol of a cooperative.*



*Oscar Arias, Nobel Peace Prize Winner and former President of Costa Rica, discusses the role of cooperatives with Ann M. Evans at his home in San Jose. Ann is a former Mayor of Davis, California, the founder of the Davis Food Co-op, and spouse of the author. Arias believes strongly that cooperatives build an equitable and democratic economy and are an important tool for developing countries.*



*Japan is the home of a vibrant and varied consumer cooperative movement with 14 million members. A popular form of consumer cooperative serving over 5 million member families is the Han group, a network of almost one million buying clubs which regularly pool orders. As a group, their order is sent by phone to a main computer at a regional cooperative which then assembles the orders in the warehouse on delivery day.*



*The Han groups are serviced by regional cooperatives through local warehouses. Every working day, hundreds of delivery vans leave the warehouses on their way to drop off the orders for the neighborhood groups. The vans make a number of trips each day. The volume of the Han groups are now over 10 billion dollars a year. Kanagawa Co-op is engaged in a joint venture with Isuzu to produce the first mid-sized electric delivery van.*

## Chapter II



# The Revolution in Time

The Impact of the Stamp, the Newspaper,  
and the Train

### The Stamp

The tremendous growth of the Co-operative Movement in Britain could not have taken place without two other major changes. The most important was the introduction of the penny stamp at the General Post Office on May 1, 1840. What became known as the Penny Black stamp, featuring an engraving of Queen Victoria, introduced the first national program of postal service. The Penny Black was the first postal stamp in the world, with 68,158,080 copies printed. On May, 23, 1991, a Penny Black stamp with a May 2, 1840, cover was sold for 1.8 million pounds, the highest price ever paid for a postage stamp.

In *The Co-operative Movement in Great Britain*, Beatrice Potter wrote, "Further—and this is a fact of historical significance—the penny postage introduced in 1840 secured to these latter day Co-operators a means of frequent communi-

cation, and rendered feasible, for the first time, the present consolidation of the Co-operative, trade union and political of working men." Success was clear. In 1854, the post office handled 684,047 letters.

### The Railway

The development of the railway system was the second major contributor to the growth of the Co-operative Movement. Initially, intense speculation led to abusive fares. Fortunately, the House of Commons passed the Cheap Trains Act of 1844, which required that all railways had to run at least one train per day—each way—with a fare costing no more than a penny a mile. For the first time, people could travel to most parts of Britain easily and cheaply. In a short period the railways revolutionized the meaning of time. Prior to the development of the train, distances of twenty to thirty miles were covered on foot. The first train from Rochdale to Manchester traveled the rails in 1841. By 1856, there were thirteen daily trains to Manchester, ten to Leeds, and eight to Liverpool.

The Liverpool to Manchester Railway opened in 1830 and was the first line to use steam engines exclusively. At that time, 375 miles of track had been constructed in Britain. By 1838 there were 89 railway companies operating approximately 500 miles of track and by 1840 there were nearly 2400 miles constructed. The railway boom was now off and running with railway shares setting the pace for the stock market. By 1848, over 8000 miles of track was in place covering every major area of the country. Over a quarter of a million men were then feverishly building the railroads of Britain.

The railway was a boon to the cooperative organizers because it allowed them to meet regularly with both new and existing cooperatives. It also made conferences easy to arrange, and hundreds—even thousands—of cooperators could gather together to share ideas and develop plans. For example, on September 19, 1862, the Pioneers ran an excursion train to London carrying 308 members who had bought round trip tickets at six shillings. Compare that with the fact that the first stagecoach service from Rochdale to Manchester began in 1767, ninety-five years earlier.



Newly emerging railways and the postal service ensured that the mail, magazines, and newspapers were delivered timely and efficiently to all corners of Britain. The railways were the bustling booster of Britain, signifying the progress and optimism of the times. Trains, more than any other invention, changed the everyday life of working people. The railway bridges, tracks, and tunnels spread to every corner of the country and sped the delivery of goods from the producer to the consumer. The railway system helped to turn the Co-operative Wholesale Society into the most powerful consumer distribution system in Britain. Interestingly, the Co-operative Insurance company invested its early surplus funds in the stock of the burgeoning railway companies.

### **The Newspaper**

The British government placed a prohibitive tax on newspapers, which made their circulation among the general population too expensive. One major reason for the popularity of the Pioneers' reading rooms was that the Pioneers could buy one newspaper for many people to read. Holyoake owed an immense unpayable debt of 600,000 pounds to the government when he died. His crime—having published unstamped newspapers for decades.

Upon his death in 1906, Holyoake was buried in Highgate Cemetery in a grave just opposite Karl Marx. Both their statues exhibit a firm gaze and determination. Both Holyoake and Marx believed wholeheartedly in their own actions and philosophies. Yet Holyoake's statue has his back to Marx. In life, they never saw eye to eye, and in death it had been guaranteed.



## CHAPTER 12



# The Basket That Changed Britain

The Successes of the Cooperative Women's Guild

*The spirit of co-operation which binds the Guild into one united whole in purpose and action, and gives to the shopping baskets of its members a great power to lift the ordinary commerce of daily existence into a movement for social betterment, is also the spirit which can regenerate the world.*

*The Woman with the Basket*

**T**he women of Rochdale have always been at the forefront of reform. In 1808, when the first political reform meeting in Britain took place at Cronkeyshaw Common near Rochdale, the local newspaper gave this description:

The procession began to move about 2 o'clock and was headed by at least 5,000 female reformers and followed by 30,000 men bearing but too sad an evidence of the distress of the times . . . The cap of liberty was carried in front with other banners . . . and on a fourth (banner) "Success to Female Societies.

During the 1830s and 1840s, the Chartists and the Anti-Corn Law League were uneasy and infrequent allies. The

Chartists focused on extending the vote to the working class and gaining representation in Parliament. Man could no longer live on bread alone, although the middle-class Anti-Corn League worked hard to reduce the price of flour. In 1839 there was a public meeting in Rochdale to discuss the repeal of the Corn Laws. Although John Bright had called the meeting, the Chartist supporters outnumbered the members of the Anti-Corn Law League and voted in their own chair. The Chartist women had an active role in the takeover of the meeting. As in 1808, the Chartist women usually led the demonstrations and processions. That year (1839) they founded the Female Radical Association to ensure that women would have their own protected forum for debating issues.

When strikes were spreading throughout Lancashire in August of 1842, John Bright wrote, "About 2,000 women paraded the town this morning singing hymns. The men are gone to other towns and villages to turn all the hands out. Has the revolution commenced? It looks very probable. The authorities are powerless."

Holyoake credits Ann Tweedale with playing an important role in helping to organize the co-op. When the co-op organizers needed a regular meeting space, she got them a room at the Labour and Health pub, where her brother, Samuel Tweedale, one of the original Pioneers, was the landlord. She was on the list of an earlier cooperative society which preceded the Pioneers. Did she not have money? Was she living with her family and was the family the member? Were the Pioneers concerned about allowing women members? Why was she not an early member?

Ann Tweedale later married Benjamin Standring (probably a brother or relative of James Standring, one of the Pioneers) and encouraged him to become a member of the co-op. However, married women were restricted by law from owning assets in their own name; Tweedale at the time could not become a member nor own stock in her own right. Keep in mind that there was no cooperative law, nor corporate law as we know it today. Co-op historians such as Percy Redfern do recount that the first person to shop at the store was a woman. History has its own way of bestowing honor.

December of 1844 also saw the founding of the Rochdale Protestant Female Friendly Sick and Burial Society, which met at the White Lion Inn on Yorkshire Street. In those days, friendly societies were created informally as a simple sort of group insurance and mutual assistance. This group was possibly the first and only female mutual enterprise in Rochdale at the time.

In those days, the males of the upper class governed society through their ownership of land and the major resources and control of the key institutions. Society's rules on ownership precluded women from owning shares in their own right and keeping their own bank accounts. W. Henry Brown inspected the records of the privately owned Rochdale Savings Bank, which failed in 1849. Of the bank's members, 271 were men and only 14 were women (probably they were widows).

Dr. Ann Hoyt at the University of Wisconsin has a long-time interest in the role of women in cooperatives. She comments on this subject:

The invisibility of women has had a devastating effect in all of the countries whose systems are based upon English Common Law. The principle has been used consistently in the United States, for example, to deny equal distribution of assets in case of divorce. To me, one of the most wonderful moments in the Rochdale Pioneer's history is that the co-op intentionally broke the law and allowed women to accumulate capital in their own right. The co-op protected the women's right to keep their capital even when their husbands demanded it. This often provided the cushion these women needed to escape dire poverty.

For a description of the effects, read *Life As We Have Known It*, edited by M. L. Davies, originally published by the Women's Co-operative Guild.

At the turn of the century, women and men were joining co-ops in Britain in equal number. By June of 1944, of the 271 persons joining the Pioneers, 159 were women and 112 were men.

In February of 1861, Mr. Ambrose Tomlinson, an activist,

provided material for a short history of the co-op to a local newspaper, *The Rochdale Spectator*. Tomlinson gave *The Spectator* the book of the association that preceded the co-op that was being formed. Many members of that association were among the twenty-eight Pioneers. The list of members of this earlier co-op includes two women, Ann Tweedale and Mary Bromley.

According to Roy Garrett, Curator of the Rochdale Museum, the first woman accepted as a member of the Pioneers Society (in 1846) was Eliza Brierley. The records show that Ms. Brierley showed up and paid her three-pound share in full. Garratt credits G. J. Holyoake as a great cooperator but a factually incorrect writer who gave too much credit to Ann Tweedale, and he points out that her name never appeared in the Rochdale record book of members. As we can see, there are many reasons from the era which would ensure that her name is missing from the list.

Ann Tweedale is to the Co-operative Movement a little like the unknown soldier. She represents so many who fought without recognition. We keep her name alive because she is the only woman that historians give any credit to for actively getting the co-op started. On the other hand, as with the unknown soldier, we know little to nothing about her. We therefore keep her name alive as an eternal representative of the role of women in starting and supporting the Co-operative Movement. We know that women played an important role, but we also know that male society of the era scorned activist women and the historians of the day ignored their contributions. The name of Ann Tweedale celebrates the contribution of the women who helped start the co-op in Rochdale and all the women who invisibly are a part of the starting of so many co-ops.

Women took many roles in the creation of the co-op. Who got the dinner ready at night, who put the kids to bed, who waited up to see how the meeting went, who understood better than anyone what a co-op could do, who went without to buy the co-op share, who loyally shopped at the co-op even though there was little on the shelves? Who shopped for cash when credit would have fed the children that day? Who sewed the staff aprons and spread the word, who were the

missionaries and who carried the heavy basket home? Who had a voice yet no vote? And don't forget most women were also working a long day. Could any one of the Pioneers have put in the time were it not for the backing of his wife?

William Cooper, a founding Pioneer, wrote a short history of the Co-operative Corn Mill Society in which he included a passage which praised the role of women in co-ops:

The wife, who is mostly as good a supporter of the Mill as her husband, generally putting up with the flour when it was not so good as it ought to be, and often, when she had a nice baking of bread, showing it to all neighbours and comers—that they might be convinced what good flour the Corn Mill Society was making. Certainly some husbands would find fault with the wife when the bread was not good, and say she had spoiled the flour, to which some wives would reply, they could bake as well as other people if they had the same flour, and that they would not use the Corn Mill Society's flour if they were to be grumbled at because they could not make good bread out of bad flour. We have said the husband would be from home while attending meetings, and may be, the wife had put the children to bed, and would be waiting with no one to speak a word to her, until the husband came from the meeting. All would be silent except the constant tick of the clock, the rain battering against the windows, and the wind whistling and howling as if it had risen in revolt against the restraints imposed upon it by nature. To the wife alone, minutes seem as long as hours, she thinks she is neglected, her husband attending meetings or anything else rather than home. At another time little Elizabeth has been sickly some days, and father has been at work all day, and now, when his work is done, has gone to the meeting. The mother cannot get the child to rest—she thinks it is getting worse. When the husband comes home, she tells him how sickly the child is, and that he ought not to have gone to the meeting—indeed if he had any thought for the child he could not

go. He tells her he has come home as soon as the meeting was over, but he cannot persuade her that he ought to have gone at all. He believes the child will be better in a few days, and promises to help her to nurse and take care of it till it is so. These, or many similar incidents, will have occurred to most persons engaged in promoting social or other reforms. But it must not be said that the women are opposed to Co-operation; no, they are, and ever have been, as much interested and as zealous of its success as the men. There are many instances where the husband was lukewarm, and the wife could not prevail on him to join the Co-operative Societies, but she was not to be baffled, so she enters the Co-operative Societies herself.

Near Rochdale, just ten miles away on the other side of the Pennines, is the town of Ripponden in Yorkshire. Since 1832, the Ripponden Co-operative Society has laid claim to the title of the oldest continuing cooperative society in the world. It is one of those co-ops that began with the first wave initiated by Owen. I will, however, leave this question to other historians. In the centenary history of the society published in 1932, the author, John H. Priestley, challenged Rochdale's claim to fame:

On the question of admitting females into the movement we also find the Pioneers much behind the Ripponden Society. They had an application from a woman to become a member in 1846, and were diffident about admitting her. Not till February, 1847, did they admit another, nearly three years from the commencement.

Ripponden on the other hand admitted three women within three months, and seven within two years, and in 1842, two years before the Pioneers had begun, they had nineteen female members. Ripponden recognized the strength of the "women with the basket" in good time. The writer [of a brochure by the Rochdale Pioneers] is mistaken in saying that the



first women admitted by the Pioneers in 1846 and 1847 were the first to venture into the shareholding lists of modern Co-operation. Margaret and Rachel Mathews and Sarah Whiteley, who joined the Ripponden Society in 1833, were the first women on the shareholding list of modern Co-operation.

The women's movement of the 1850s and beyond focused mainly on the lives of middle-class women who complained that the conditions for middle-class women were oppressive and purposeless. These women were educated, but they could not vote and had few rights. They were intellectually developed, but had no real voice. They were as competent as men, but were excluded from roles in business and politics. They knew they could shine, but were relegated to the shadows of society. At the height of their suffocation they looked to free their new consciousness. The time had come to act!

The co-op also was pushed to take a role in educating women. Mary, the youngest daughter of James Smithies, was encouraged by her father to apply to the Pioneers to use the library. She became the first woman to use the (then) exclusively male Pioneers' library. Mary was a teacher and eventually became headmistress of Derby Street School in Rochdale. She became the first president of the Rochdale Women Teachers' Association formed in 1917.

The issues related to the Industrial Revolution, class differences, and poverty were central to the times. In the period beginning with the 1840s and 1850s, the social novel and the protest novel entered literature. More importantly, women writers were making a breakthrough. In just over a decade, the following protest novels by women were published: Frances Trollope's *Michael Armstrong the Factory Boy* (1840), Elizabeth Gaskell's *Mary Barton* (1848) and *North and South* (1854), Charlotte Bronte's *Shirley* (1849), Helen Tonna's *Helen Fleetwood* (1849), and Geraldine Jewsbury's *Marian Withers* (1851).

Novels by women writers differed from those authored by men in that they featured women as central characters and highlighted issues of concern to women. These novelists wrote from a feminist perspective and saw society through

the eyes of women. Because they came from the middle class, the writers represented the perspectives prevalent in middle-class society. They avoided urging revolution by the working class, although they wrote of the agonies the working class suffered. They pleaded with the manufacturing classes and the new middle class to be considerate of the workers. They hoped that a woman's voice infused with the values of family, community, and caring would be heard and would modify promotion of individuality and isolation by the manufacturing class. The women writers hoped for a peaceful resolution of the differences in society through reducing the excesses of the era.

The women writers of the 1800s continued a tradition begun by their counterparts in the 1700s. Sarah Scott, author of *Millennium Hall* (1762), writes about a woman's Utopia. At Millennium Hall the women are no longer chattel to the male world and without voice. They choose to create a cooperative community committed to a life of equality, participation, and friendship. In conducting research on this hidden part of history, Alessa Johns states, "Their utopias become places where they can overcome financial difficulties, retain their class position, contribute to the common good, and simultaneously maintain their independence." While they are all of independent means, they see the inequality of society. They pursue education as a foundation for income and finance a factory where people in the village have good working conditions and pay.

However, by the 1840s there is no longer an idealized Utopia to give comfort. The impact of industrialized society had brought a new reality to the same concerns and a hard edge to women's writing. In *North and South*, by Elizabeth Gaskell, the mill owner is challenged by the heroine:

"Mr. Thornton," said Margaret, shaking all over with her passion, "go down this instant, if you are not a coward. Go down and face them like a man. Save these poor strangers whom you have decoyed here. Speak to your workmen as if they were human beings. Speak to them kindly. Don't let the soldiers come in and cut down the poor creatures who are driven mad."

The theme of woman writers appealing for justice and understanding continues to the present.

The difficulties and obstacles for women of that era were numerous. The efforts of the Pioneers were to make a difference. One of the Pioneers' important contributions to women's rights was the role the Pioneers played in the passage of the Married Women's Property Rights Act in 1870. Almost from the beginning, the Pioneers made no distinction as to who could own shares, but prior to 1870 the law held that a married woman's property legally belonged to her husband. The Pioneers ignored the law and protected the rights of their shareholders, be they male or female. If a man demanded the share or dividends of his wife, he was refused and the wife was informed of his attempt to take her money.

The British Home Secretary, Mr. Bruce (later Lord Aberdare), was told about this policy by Professor Stuart of Cambridge University. The Home Secretary sent his private secretary, Albert Rutson, to Rochdale. Rutson talked with the women in the store and inspected the society's records. He was impressed by what he saw and heard, and returned to London to report positively on his visit. It was mainly owing to Rutson's visit that women's property rights became the law of the land.

One of the most important women in Britain at the time got her start studying the growing Co-operative Movement. Beatrice Potter was a young social researcher who took a keen interest in Cooperatives. In 1883 she began researching the institutions of working-class life in Lancashire. In the beginning, she posed as Miss Jones because the Potter family were too well known in South Lancashire. Her father, Richard Potter, was an industrialist and railway magnate. One uncle, Thomas Bayley Potter, a former M.P. for Rochdale, has already been mentioned. Coming from a powerful political family and an upper-middle-class manufacturing background, she would likely be suspect in the parlors of the poor weavers.

Beatrice Potter often gave papers at Co-operative and trade union meetings. She gave her first major address to the Co-operative Congress at Rochdale in 1892. In 1889 she began writing *The Cooperative Movement*, which for many

years was the only impartial study of the progress of the consumer cooperatives. Later she married Sidney Webb, another rising star, forming one of the most influential and enduring political partnerships in Britain. Together they played a critical role in founding the Fabian Society and the London School of Economics and in reforming the British Labour Party. They co-authored a book, *The Consumers Co-operative Movement*, published in 1921. The Webbs remained co-op supporters all of their lives. In her later years, Beatrice Webb traveled in the most powerful circles in the nation, as well as the globe. She remained an inspiration to the many women in the Co-operative Movement who pursued education as a means to progress. Those humble, hard-working women never forgot the young woman's speech at Rochdale in 1892 to a hall mostly full of men. The women were made proud and no longer afraid.

In 1883, Mrs. Alice Ackland lit the spark for organizing women members of cooperatives to play a larger role. She was invited by Samuel Bamford, the editor of *The Co-operative News*, to write a column titled "Women's Corner." Ackland wrote:

What are men always urged to do when there is a meeting held at any place to encourage or to start Co-operative institutions? Come! Help! Vote! Criticize! Act! What are women urged to do? Come and Buy! . . . To come and buy is all we can be asked to do; but cannot we go further ourselves? Why should we not have our meetings, our readings, our discussions?

Ideas began to pour into *The Co-operative News*. One woman wrote:

Women want more changes than they have now; they want taking away from the cares of the home for a time, and I think there ought to be meetings held at the store expressly for women . . . so that we could converse together on Co-operation.

In 1883, as a result of the interest, the Co-operative Women's Guild was born. Within a short time there were

hundreds of branches throughout Britain.

D. H. Lawrence captured the impact of the Co-operative Women's Guild on working-class women in a passage from his novel, *Sons and Lovers*:

When the children were old enough to be left, Mrs. Morel joined the Women's Guild. It was a little club of women attached to the Co-operative Wholesale Society, which met on Monday night in the long room over the grocery shop of the Bestwood Co-op. The women were supposed to discuss the benefits of Co-operation, and other social questions. Sometimes Mrs. Morel read a paper. It seemed queer to the children to see their mother, who was always busy about the house, sitting writing in her rapid fashion, thinking, referring to books and writing again. They felt for her on such occasions the deepest respect.

But they loved the Guild. It was the only thing to which they did not begrudge their mother—and that partly because she enjoyed it, partly because of the treats they derived from it. The Guild was called by some hostile husbands, who found their wives getting too independent, the clat-fart shop—that is the gossip shop. It is true, from the basis of the Guild, the women could look at their homes, or at the conditions of their own lives, and find fault. So the colliers found their women had a new standard of their own rather disconcerting. And also, Mrs. Morel always had a lot of news on Monday nights, so that the children liked William [the eldest son] to be in when their mother came home, because she told them things.

### **Votes for Women**

Between 1832 and 1884, three reform bills had been passed. While they made some changes in voting requirements, the laws still based voting rights on levels of male property ownership. Out of a Rochdale population of 28,000 in 1832, only 687 males had voting rights. In the 1832 elections 632 males voted, and in the 1840 elections only 734 voted. Arguing in Parliament in 1866 for extension of the

voting franchise, John Bright, M.P., used the example of the Rochdale Pioneers and their responsible use of the vote. In replying, William Gladstone commented that the town of Rochdale "probably has done more than any other town in making good to practical minds a case for some enfranchisement of the working-classes." It would not be until 1884 that a majority of property owners finally won the right to vote.

In 1915, the Guild published *Maternity: Letters from Working Women*. This was the first ever presentation of the working women's view of maternity. "Do publish these letters . . . they are so amazing," wrote Virginia Woolf to her friend, Margaret Llewelyn Davies. The collection of letters, which had been assembled as part of a campaign by the Guild for maternity benefits, stunned the middle class into action. By applying pressure, the Guild won a thirty shilling maternity benefit. More importantly, in 1913 the Guild established that legally, the benefit was the property of the mother.

It was not until 1918 that universal suffrage in national elections was extended to everyone except women under thirty. Women had to wait another ten years to have the same rights as men. Were it not for the suffragettes, the Co-operative Women's Guild, and the role of women in World War I, it probably would have taken longer. Out of suffering often comes beauty. During the First World War, it was suggested to Hubert Parry that he write suitable simple music to William Blake's poem, "Jerusalem." People were hungry for a song that an audience could join in. The result was the magnificent unison song, "Jerusalem," that is now a second national anthem. It was first performed at a Votes for Women concert in 1916 and has never stopped stirring audiences.

One of the early issues taken up by the Guild was that of women's suffrage. In 1893, the middle-class suffrage societies organized a giant petition, which was signed by a quarter of a million women; one-quarter of the Guild members were signatories. But, as before, the petition failed. Guild members were then urged to take action at the local level. In 1894, forty-five Guild members ran for election as Poor Law Guardians, and twenty-two were successful. From that beginning, Guild members felt encouraged to run for various other locally elected offices.

By 1927, over seven hundred Guild women had been either elected or appointed to public office in Britain. The Guild had taken the "Woman with the Basket" to a very different role in society. Catherine Webb's book by that name documents the victories of the Co-operative Women's Guild. The women who were changing their co-ops were now prepared to change Britain.

By the turn of the century, over half the members of British consumer cooperatives were women. By 1930, sixty-two thousand women were active members of the Guild through the local branches. Because co-op members were generally from the artisan class, their wives had hopes for the future. Theirs was the generation and class who saw that life would change for the better. The key to the world beyond the row house was education and organization. The Guild became Britain's pre-eminent women's organization and compiled an enviable record of success in parliament centered on issues of importance to women, children, and the welfare state. For decades it was the strongest organization working on behalf of the voteless and voiceless women of Britain.

In 1933, the Guild celebrated its Jubilee Year. The highlight was a rally at the Crystal Palace in London at which fifteen thousand women gathered together in unity to sing their hymns, hear speeches, and parade with their banners. The Guild's former General Secretary, Margaret Llewelyn Davies, urged them ". . . not to be content with [their] triumphs but to go forward . . ." At the outbreak of World War II, the Guild membership had risen to 1,819 branches and 87,246 individuals, its highest ever.

There is one woman, Margaret Llewelyn Davies, who will forever be remembered for her devotion and contribution to the success of the Guild. Born in 1861, she became Secretary of the Marylebone, London, branch of the Guild in 1886 and was elected to the Central Committee in 1888. She became General Secretary in 1889 and served in that position until she retired in 1921. Her father was a reformer, Christian Socialist, honorary chaplain to the Queen, and an activist in developing the Working Men's College. When her father was appointed Vicar of Kirkby Lonsdale in West Yorkshire in 1889, the whole family moved there.

Educated at Queen's College, London, and Girton College, Oxford, Ms. Davies studied education and feminist emancipation. When the family moved to Kirkby Lonsdale in the moors of West Yorkshire in 1889 the Guild moved there, too. All of the activities of the Guild were conducted from a small room in the rural vicarage. For over 30 years she and Lilian Harris, her loyal friend and Assistant Secretary of the Guild, served there without pay. Ms. Davies never married, she committed her life to the Guild and to the Co-operative Movement. She was known as a powerful speaker, a great presence, and an untiring organizer.

She helped found the International Women's Guild Committee in 1921 in Basel, Switzerland. Her greatest honor was being elected President of the Co-operative Congress in 1922, the first woman ever to reach this position. She died in 1944, Rochdale's centenary. Her memorial meeting, held on June 15, 1944 at the Co-operative Wholesale Society Assembly Hall in Manchester, was described in *The Cooperative News* as "Not a service of mourning, not even great sorrow. Rather there was a spirit of thanksgiving for a noble life of service and gratitude for the privilege of having known her and shared in the work she inspired."

It was not until 1975, the International Year of the Woman, that Eva M. Dodds, a Co-operative Wholesale Society Director, became the second woman to be elected president of the Co-operative Congress. Nora E. Willis was the third—elected in 1983 in honor of the 100th Anniversary of the Guild—and Gladys Bunn became the fourth woman president, elected at the 1987 Blackpool Congress.

After the war ended, Britain would undergo the greatest changes it would experience in the twentieth century. To the surprise of many in 1945, a majority Labour Government was elected for the first time.

An elated Aneurin Bevan, an M.P. and soon to be cabinet minister in the new Labour Government, stated "We have been the dreamers, we have been the sufferers, and now we are the builders." His wife, Jennie Lee, also an activist Labour M.P., was a lifetime supporter of the Co-operative Movement. The nation was ready to adopt massive changes in social policy, education, welfare, health, and housing.

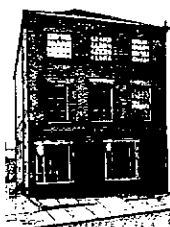


What the Guild had been urging Parliament and the nation to do for decades was now achieved overnight. In a post-war Britain, society was being radically restructured. With a government committed to the same goals as the Guild, there was now less reason for the Guild. With retailing also undergoing a massive reformation, the co-ops were being forced to merge rapidly to ensure that they remained competitive, leaving fewer co-op organizations around to sponsor the local Guilds. A sympathetic Labour Government and the merging of societies brought about a continued decline in the Guild membership.

But the Guild's decline should not be viewed as failure. The Guild had been the most successful women's group in Britain and the only mass working-class women's organization. The Guild served as the training ground for women entering public service and politics. It had taken on issues which had changed the face of the nation. Almost all of its social and political objectives had been achieved. "The woman with the basket" carried home from the co-op more than groceries. In their baskets they carried home hopes and dreams, leaflets and petitions. The extras the Guild members took home in that "basket" changed Britain forever.



## Chapter 13



# COOPERATIVE EDUCATION

The Road to Economic Freedom and Democracy

*Unless the principles of Co-operative economics are well understood by every member, the Cooperative will ultimately collapse, although outside pressure may hold it together for a while. Accordingly the Cooperative movement must begin with a thorough-going educational movement.*

— *Tsyohiko Kagawa*  
*Brotherhood Economics*

Providing food during the “hungry forties” was important to keeping people alive, but education was the tool for ensuring that people got ahead. The Pioneers recognized the importance of both strategies for serving the needs of their members. At the time, there was no public education or free library system in England, and the cost of books and newspapers was beyond reach of working people. Working people had few opportunities to move into the skilled positions that would increase their earnings. The Pioneers were clear in their focus; education would ensure that their members could walk towards economic freedom and democracy. If the co-op was to advance its goals of serving millions of working people, it needed educated and competent employees. The goals of the Owenites, Chartists, and other idealists of the era were to create communities filled with educated inhabitants. Education would prepare people for industry and citizenry.

The Rochdale store is to the beginning of the Co-operative Movement what Faneuil Hall in Boston is to the birth of the United States of America. On the ground floor of both historic buildings was an everyday marketplace for food, and on the second floor the marketplace for revolutionary ideas. Knowledge, education, public meetings, debates, and dissent were the currents and currency of the upper floors. As Faneuil Hall fed the mind and bodies of Bostonians during the Revolutionary era, so did the co-op shop in Rochdale during the Industrial Revolution. Shopping for democracy and daily bread were one and the same during the historic beginnings of both movements.

The self-help organizations of cooperatives, political organizations, nonconformist chapels, and civic-minded groups were key to education in the 1800s. The 1833 Factory Act had required that factory owners provide education to their young workers (two hours of schooling and nine hours work for those under thirteen). However, an inspection of 500 mills in the West Riding of Yorkshire in 1838 revealed that only 12 mills had complied with the regulation. As a result, Factory Schools were made compulsory in 1844 and provided three and a half hours of education to all children working in the factories covered by the 1833 Act. Until then, almost all education of the working class had been voluntary and through self-help organizations.

Education was a high priority for the Pioneers. They saw how education allowed people to learn more, earn more, and organize more effectively. The shop at Toad Lane was quickly put to educational uses, especially on Sunday, when the store was closed for business but open for education. The members would turn up to discuss the issues of the day. Founding pioneer Samuel Tweedale gave the first lecture: "Morals in Their Relation to Everyday Life." Another Pioneer, James Smithies, taught writing and arithmetic on Sundays and encouraged his daughters to attend the classes. Knowledge was power, and brains became more important than brute strength. The passport to prosperity was learning, and the skilled co-op members were an artisan aristocracy in search of progress.

Elizabeth Gaskell knew full well of this undercurrent in

society whereby workers relentlessly pursued knowledge. She wrote in her 1848 novel *Mary Barton*:

There is a class of men in Manchester, unknown even to many of the inhabitants, and whose existence will probably be doubted by many, who yet may claim kindred with all the noble names that science recognizes. I said in "Manchester" but they are scattered all over the manufacturing districts of Lancashire. In the neighborhood of Oldham there are weavers, common hand loom weavers, who throw the shuttle with unceasing sound, though Newton's *Principia* lie open on the loom, to be snatched at in work hours, but revealed over in meal times, or at night. Mathematical problems are received with interest, and studied with absorbing attention by many a broad-spoken, common looking factory hand.

In order to have a space for discussions and classes, the co-op took over the upper part of the building, vacated by the Bethel Chapel, when it became available in June of 1849. The rental for the entire building was fixed at twenty-three pounds per year. James Daly, the joiner, was allocated 200 pounds to re-fixturing the front of the store. The top floor became a tailoring department and a clog and cobbler's shop.

### **The Pioneers' Library**

The co-op turned the second story into a reading room and began developing a library. Books were then too expensive for working people to purchase, and there were no free libraries. On August 20, 1849, it was resolved by the Board

that Messrs. James Nuttall, Henry Green, Abraham Greenwood, George Adcroft, James Hill and Robert Taylor be a committee to open a stall for the sale of books, periodicals, newspapers, etc.; the profits to be applied to the furnishing of the members room with newspapers and books.

Thus began the cooperative's education department. In 1850, the People's Institute, a middle-class literary so-

ciety, failed, and their library of 1,100 books was immediately purchased by the Pioneers.

The progress of the co-op's educational activities was aided immensely by the acquisition of both the books and the librarian of the People's Institute, Abraham Greenwood. A member of the co-op since 1846, Greenwood went on to become one of the great co-op leaders of England. It was Greenwood who drew up the scheme for the Co-operative Wholesale Society and became its first president.

By 1862, the Pioneers' library collection had grown to five thousand volumes, and use was now free. In December of 1869, John Bright donated 750 books from his library to the Pioneers Society, and in 1870, a library of nine thousand volumes was opened in the new Central Store. After one year at the new location, the library had grown to seventeen thousand volumes. By then, eleven reading rooms had been opened at other co-op stores located throughout Rochdale.

As a result, the co-op became the foremost educational institute in Rochdale. Years later, Karl Marx commented, that in all of Britain, the library and newsroom of the Rochdale Pioneers was second only to that of the British Museum. George Dawson, a popular orator of the period, spoke of his visit to Toad Lane:

I have seen many libraries—in Rome, Vienna, Paris and Oxford, but the library of libraries was that of the Rochdale Equitable Pioneers. There were libraries with more books and scarcer and more splendid volumes, but the origin of this library was unparalleled in the history of the world.

### **The Newsroom**

The Rochdale Almanac of 1854 described the newsroom thus:

a bounteously filled room in those days, abounding in dailies, weeklies and quarterlies, was open from nine in the morning to nine at night, at a charge of two pennies per month. This gave an average of 2520 hours reading for two pence.

Working people could not afford both the cost and the tax on regular newspapers. When the co-op moved to the Central Stores in 1867, the Central newsroom was supplied with twenty-seven daily papers, fifty-five weekly papers, and many monthly and quarterly magazines.

In a paper about the origins of the Education Department of the Rochdale Equitable Pioneers' Cooperative Society given in 1877, Abraham Greenwood had this to say:

The early Pioneers were in the habit of assembling themselves together after the day's toil was done in the back room of the old store, for the purpose of hearing the news of the week . . . News of the day was circulated by word of mouth to a very great extent amongst the working-classes forty years ago, and often gained rather than lost something of the truth in being thus diffused . . . There were certainly some Utopian dreamers amongst the early Pioneers; all of whom were more or less sentimentalists; but while all sentimentalists, they were not necessarily void of common sense to curb that sentiment within the bounds of reason and what was practical . . . Aim high enough in your purpose, and in the attempt at its accomplishment your effort will result in having done some good, if not all the good you proposed to do.

### **Budgeting for Education**

In the beginning, the quarterly meetings of the Pioneers made illegal grants towards education. The Registrar of Friendly Societies had disallowed the Pioneers from allocating 10 percent of the profits to education. John Kershaw, one of the Pioneers, wrote, "These were the days when the law prohibited workmen from educating themselves and the government refused them the franchise on account of their want of knowledge." Upon adoption of the new Industrial and Provident Act of 1853, the co-op set aside 10 percent of its profits to go towards education. The government's Registrar of Friendly Societies disallowed such generosity, and finally agreed to 2.5 percent. An education committee was formed, which was to change the face of education worldwide, and each subsequent co-op shop was designed to include a library

and reading room.

### **The Birth of University Extension**

A school for young people operated from 1850 to 1855. Advanced subjects were provided for the mature and inquisitive working-class audience, and the co-op was committed to bringing in distinguished lecturers from all across England. The response was voracious, and people walked miles to attend lectures or classes. People were starving for knowledge, and no one lecture could satiate the appetite of the co-op members—they always wanted more.

Professor Sadler's *Manual on University Extension* stated:

It was at Rochdale that a Cambridge astronomy professor, Professor Stuart invented "The Class," the period of conversational teaching, enlivened by brief periods of "heckling" which has ever since been an important feature of the University Extension system.

Its origins were simple. Stuart's lectures were illustrated by diagrams which were left on the walls of the co-op until the next meeting. Members attending a general meeting of the society were so attracted to the materials and the concepts that they stayed to discuss them, and they wrote to Professor Stuart asking him to come to the lecture room before the next class so that they might ask him some questions. "He did so, and thus began the first University Extension Class," Sadler adds. Other ties were created between the universities and the cooperatives. This episode provides another example of the leadership of the Rochdale Pioneers. When Beatrice Webb visited the Guild branch at the cooperative in Hebden Bridge in 1881 she recalled, "Young Oxford men are down here; and they and the co-operators form a mutual admiration society between intellectual young Oxford and Co-operative working-class."

In 1873 the Pioneers affiliated with the Science and Art Department of South Kensington, London. This academic relationship allowed the co-op to offer classes in most of the sciences, and it began to rent scientific equipment to its



members.

In 1894 the Pioneers decided to discontinue all of its technical classes. In the twenty years since the Pioneers had begun this work, technical education had changed dramatically. The role of educator had been assumed by the state and the local authorities—there was no longer a need for the Pioneers to do what society was now doing. The task of the Pioneers was complete, education was universally available, and the Adult School was in place throughout Britain.

### **Cooperative Education**

During the early decades of the cooperatives, education about cooperatives played a secondary role to education for industry. As the co-op role was filled by the state, cooperators began to focus on Cooperative education.

At earlier cooperative congresses in the 1870s, the idea of a cooperative college had been the dream of a small band of dedicated cooperative educators. The Co-operative Congress of 1898 vastly reorganized the structure and delivery of cooperative education. At the Congress, Albert Mansbridge, an employee of the Co-operative Wholesale Society, made an impassioned plea for the co-op to meet the needs of working-class students. In 1903, he wrote a number of articles on how co-ops, trade unions, and university extension should work together in a more focused program. To support his ideas, he founded the Workers' Educational Association. By the next year, the Oxford Extension Summer Meeting convened a special meeting to discuss Mansbridge's ideas.

In later years, cooperators began to discuss the wider application of cooperative education. In 1909, the Co-operative Union sponsored its first weekend school at the innovative garden city of Letchworth. It seemed fitting that a new town built on cooperative principles and focused on the future should host the school. The first of the annual Easter Education weekends took place the next year, and in 1913 the first summer school convened in Castleton. The growth of the co-op's educational activities brought the vision of a cooperative college ever closer. The college was to educate the board and committee members and the management and staff of cooperatives, to strengthen the organizational and operational

capacity of the cooperative movement.

At the 1919 Co-operative Congress, the central board was asked to formulate plans and set a fund-raising goal of fifty thousand pounds. Because the money was slow to come in, it was decided to get the concept started at Holyoake House, the home of the Co-operative Union in Manchester. A hostel was acquired for the students at Kersal in Manchester. For the years 1938 to 1939, there were 1,350 classes and 23,529 students registered with the Co-operative Union Education Department.

The Co-operative College claims to have been the only adult working-class college to remain open during the entire war. During 1944, the centenary year of Rochdale, the education executive initiated an appeal to fund a new Co-operative College with room for one hundred students. A sum of 250,000 pounds was sought and over half was donated in the first months of the appeal. By March of 1945 enough had been raised to purchase Stanford Hall in Leicestershire. A glorious country home surrounded by three hundred acres of land, Stanford Hall became home to the Co-operative College, which continues today as one of the preeminent places in the world to study cooperatives.

Stanford Hall now stands as a location where cooperators can become both pilgrims and practitioners. Stanford Hall in England, Var Gard in Sweden, St. Francis Xavier University in Canada, and now Kobe's Kyodo Gakuen co-op in Japan—with its exact replica of the Toad Lane store—are the crown jewels of cooperative education today.

This same commitment to education has made Migros, the innovative Swiss cooperative, that nation's largest and most famous adult education program. Through its cultural levy of 1 percent of sales, the co-op commits 45 percent to the Migros Club Schools, offering tremendous educational opportunities to thousands of Swiss cooperators. Migros had been one of the largest private businesses in Switzerland, but after reading about the commitment of the Rochdale Pioneers, the owners decided to make their business a cooperative and give it to their customers. The dreams of the Pioneers therefore led to the development of the largest retail business in Switzerland.

These noble examples embody the Pioneers' commitment to education as a tool of human freedom, and giving people the gift of education gives people a tool that serves the world's future. An investment in the type of knowledge that creates community, enhances the common good, and is meant to enrich others can only benefit both the individual and greater society. This is the purpose of the cooperative colleges, which stand as beacons of learning across the globe.

### ***The Co-operative News***

The early co-op movement was served by a number of disparate newspapers, yet needed cohesion. In 1860, Henry Pitman, brother of Isaac, the inventor of shorthand, edited *The Co-operator*, a nationally oriented paper published by the Manchester & Salford Society. *The Co-operator*, however, lost both money and the faith of the cooperators, owing to its alliance with other issues of the day. As a result, the Co-operative Congress decided to establish and support a national publication called *The Co-operative News*. First published on September 2, 1871, *The Co-operative News* is today the oldest democratically owned weekly newspaper in the world.

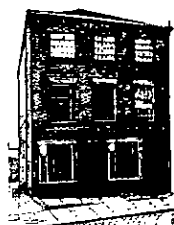
Despite its ultimate success, *The News* started off with difficulty. Samuel Bamford was appointed editor in 1875, at a time when the paper was heavily in debt and had a circulation of only eleven thousand. Bamford himself was a Rochdale native and a product of the Rochdale Pioneers. He had attended many of the classes given by the Pioneers and had distinguished himself in the Equitable Pioneers science and art classes. At his death, over twenty years later, the paper boasted a circulation of fifty thousand, and was a sizable and profitable enterprise. Bamford's son William became editor of *The News*; his daughter, Ann Bamford Tomlinson, was editor and founder of "Women's Outlook," a column in *The Co-operative News*.

Bamford is regarded as a key contributor to the growth and diversity of the movement because of the ideas expressed and supported in the pages of *The Co-operative News*. The weekly *Co-operative News* was the clarion call for the growing cooperative movement. Priced at a penny, it was within

reach of and read by a wide cross section of the British public. During its heyday, it was one of the most influential papers in England, especially for its size.

By the end of the nineteenth century, the “learning for earning” pioneered by the co-op was provided by both local and national institutions and many other public bodies. The co-ops recognized that their contribution in this area was complete. The light lit at Rochdale in the second-floor classroom of the Pioneers now shone brightly in thousands of schoolrooms throughout Britain. Cooperatives, which had pioneered universal education programs, now looked to more specialized ways to educate their members. Assuring the future of cooperative education in an educated Britain was a much more difficult task. Co-ops could claim to have been at the forefront of overcoming inequality through education and economic action. However, by building a democratic economy with wider opportunities for working people, the co-op had lost its unique place in British society. How to reinvent itself for the twenty-first century is one of the co-op’s greatest challenges. Cooperative education will be critical to strategies for rebuilding the Co-operative Movement.

## Chapter 14



# FROM UTOPIAN COMMUNITY TO GARDEN CITY

Home Builder and Mortgage Banker

*When the capital has accumulated sufficiently, the Society may purchase land, live upon it, cultivate it themselves, and produce any manufactures [sic] they please, and so provide for all their wants of food, clothing and houses. The society will then be called a community.*

—*The Co-operator, Volume 1, May 1, 1828*

*Dr. William King, Editor*

The goal of the Pioneers was the creation of a cooperative community. The means to accomplish that goal were quite simple: obtain members, form a society, sell shares, open a shop, build houses, create work, and, finally, buy land and build a community for all. What stood in the Pioneers' way was the law. Until 1862, friendly societies were prevented from owning more than an acre of land, and any planner could tell you that you cannot build a Utopia on one acre.

On the other hand, the co-op's amazing growth as a grocer had stunned the nation, and co-ops were springing up in almost every town. Many of them were opening up branches and department stores, and there seemed to be no limit to the possibilities. The full-scale development of the world of retail captured the imagination of the members as they planned for

greater glory. Why try anything else when the world of retail seemed such a prize?

Many of the Pioneers had been supporters of either Owenite or Chartist colonies. All of them dreamt of building a society to bring about the new world, and much of their dreams revolved around living and working in model communities.

I will not cease from mental fight  
Nor let my sword sleep in my hand  
Till we have built Jerusalem  
In England's green and pleasant land.

*Jerusalem*  
— William Blake

However, by the time they were in a position to do something constructive, the movement for Utopian communities was on the wane. By the 1860s the back-to-the-land yearning had passed and England's future lay with industry, not agriculture. Towns held the jobs and prosperity, as well as the squalor. What the co-op members wanted was no longer a Utopian community, but a small, neat, terraced house to call home. Town planning was now more important than idealized country living.

Engels wrote his classic description of Manchester in 1844 in *The Condition of the Working Class in England*:

(in the old town) the street, even the better ones, are narrow and winding . . . the houses dirty, old and tumble down, and the construction of the side streets utterly horrible . . . Here one is in an almost undisguised working men's quarters, for even the shops and beer houses hardly take trouble to exhibit a trifling degree of cleanliness.

It was this type of urban living that the co-op members wanted a solution to. Not in some rural Utopia, but in a nice row house.

Fortunately, the Rochdale Pioneers did not forget their roots and their commitment to community. In November of 1860, the Cooperative Land and Building Company was

formed. By early 1861, the Pioneers had set up a housing and mortgage loans cooperative society and they assumed its management in 1868. In *The Co-operator* of May 15, 1867, Mr. Smithies, one of the founders, reported that the Pioneers had established a separate Building Company with a subscribed capital of four thousand pounds, and had built thirty-seven cottages. The Pioneers had the power not only to build cottages, but to buy and sell land, make bricks, supply the furniture, and do almost anything else. The Pioneers Society provided one-half of the capital, and the bulk of the Building Company's members belonged to the co-op. When the Co-operative Insurance Company (later the Co-operative Insurance Society) was formed in 1867, it set aside 50 pounds to purchase shares in the building company.

Objective 2 of the Rochdale Equitable Pioneers Society:

The building of a number of houses in which those members desiring to assist each other in improving their domestic and social condition may reside.

Just south of Rochdale's railway station off Hare Street, lie Equitable Street and Pioneer Street. These two streets were built as exact replicas of each other, each composed of two rows of the same two-story homes with small gardens in the front. In the center runs a narrow street, which clearly did not anticipate the modern car. There were approximately fifteen houses on each side of the street, making sixty houses altogether. It is quite likely that the houses were built with funds either from the Rochdale co-op or from the Co-operative Wholesale Society. Rochdale and other retail co-ops frequently sponsored this type of development to meet the needs of their members. During the past twenty years, half of Pioneer Street has been demolished to make way for a neighborhood park.

Catherine Webb, in *Industrial Co-operation*, reported that a number of the retail societies became involved in helping their members obtain housing. Nationally, by the end of the century, mortgages had been lent to finance 23,940 member houses; 8,247 houses had been built and rented to members; and 5,080 had been constructed and sold to members. The Co-operative Wholesale Society also lent money to retail

societies to support home lending programs for members. Under this program, initiated in 1897, the Co-op Bank advanced to retail societies 75 percent of the cost of the property. The Bank initially set aside 250,000 pounds. The scheme proved so popular that by 1914 the Bank had provided 600,000 pounds, an amount that was over 10 percent of the total assets of the bank. In 1923 the Co-operative Insurance Society introduced its own house purchase scheme, which by 1931 covered 8,800 mortgages. In a number of cities in northern England you will find a terraced street named Co-operative, Co-operation, or Equitable. Most often, the origin of its name can be traced back to the funding and sponsorship of the local cooperative society.

In Leicester, worker cooperatives began to emerge in the late 1800s. Their presence was brought about by differences with the Co-operative Wholesale Society about employment practices, which resulted in a strike. Because they were interested in his views about cooperative workshops, the Leicester workers invited E. O. Greening, the champion of worker co-ops, to come to meet with them. Over two hundred workers agreed to join, and they asked Greening to draft a constitution. This new enterprise, known locally as "The Equity," began production in 1887, and by 1990 it employed 170 people. "The Equity" was supported by many of the consumer co-ops and became very successful.

"The Equity" next focused on a community-building project. The top floor of the factory was converted into a hall which could seat 250 people, and was to be used for social and educational purposes. There were a library, many newspapers, games, and a piano. The partners formed a number of building societies which together built sixty houses. Another worker co-op, formed in 1903, was called "The Anchor," and it was also committed to community. In the 1890s, they had purchased twenty-eight acres of land at Humberstone and built their own "garden city." The Anchor Tenant's Estate had light, airy homes, spacious gardens, and even tennis courts.

A job and partnership at The Anchor, a home on The Anchor Tenant's Estate, and shopping at the co-op shop meant that members came close to living entirely in the "cooperative commonwealth" and to following Objective 5 of the



### Rochdale Equitable Pioneers Society:

That as soon as practicable, this society shall proceed to arrange the powers of production, distribution, education and government, in other words to establish a self-supporting home colony of united interests, or assist other societies in establishing such colonies.

Another innovation was the founding of the Tenant Co-operators Limited in 1888 for the express purpose of providing dwellings for working men under a cooperative system. At the turn of the century, this society owned a number of estates around London. By 1909, it had built 6,600 houses. In 1907, the Lord Mayor of London opened the first cottage of the Hampstead Tenants, a co-partnership estate. Within four years, four hundred units of cooperative housing would be built by Hampstead Tenants. By 1909, there were ten tenant societies affiliated with the national organization, Co-Partnership Tenants Ltd., which raised capital and provided technical assistance to its member organizations.

One man who had an impact on the model community movement was the British Prime Minister, Benjamin Disraeli, who wrote the novel *Coningsby* in 1844. Coningsby, the protagonist of the novel, visits Manchester and looks carefully at the industrial world he finds there:

The next day he visits the factory of Oswald Millbank and describes a clear stream running alongside the attractive mill in this green Lancaster valley. About a quarter of a mile further on, appeared a village of not inconsiderable size, and remarkable from the neatness and even picturesque character of architecture, and the gay gardens that surrounded it. . . The village too could boast of another public building; an institute where there was a library and a lecture room; and a reading hall which anyone might frequent at certain hours, and under reasonable regulations.

Dean Mills, a village near Bolton, now called Barrow Bridge, is reputed to be the inspiration for Disraeli's novel.

Industrialist Robert Gardner built a model village for the workers complete with a school and excellent housing. By 1850, the workers had started a successful co-op shop. The mills were demolished in 1913, and the remaining buildings have become a picturesque village favored by day trippers.

In his next novel, *Sybil*, or *The Two Nations*, published in 1845, Disraeli describes an enlightened industrialist, Mr. Trafford, who builds a model village near his mill. Disraeli's ideas influenced the first experiments in popular housing. The Bradford woolen magnate Sir Titus Salt read *Sybil* and went out and built Saltaire, a model mill community on the banks of the river Aire in west Yorkshire. Built in 1853 in the wake of the Chartist uprising, Saltaire was intended to improve conditions and avert revolt.

In *Sybil*, Disraeli describes a workmen's club similar to the Socialist Institute in Rochdale, with fifty members and subscriptions to three London papers. Disraeli spent a great deal of time in the area around Rochdale, and he was impressed by the neighborliness among the cooperators. In a later novel, *Endymion*, he captured their singular hope.

"And I have a principle too," said the hero. "It will carry all before it, though it may not be in my time. But I am not so sure of that."

"And what is it?" asked Endymion.

"Co-operation."

It was in *Sybil* that Disraeli presented his description of the "two nations." He wrote:

Two nations between whom there is no intercourse and no sympathy; who are as ignorant of each other's habits thoughts and feelings, as if they were dwellers in different zones, or inhabitants of different planets; who are formed by a different breeding, are fed by a different food, are ordered by different manners, are not governed by the same laws—the Rich and the Poor.

Mrs. Gaskell would follow a similar theme in her novel *North and South*, which describes the disparity between the

people of the north and south of England.

In 1907, the president of the National Co-operative Festival, William Openshaw, said:

Almost every variety of the necessaries of life was now Cooperatively produced but Co-operators had a long way to go before they reached the end they had in view, viz. to become a practically self-supporting and self-employing community, co-extensively with the limits of the civilized world.

### **Ebenezer Howard and the Garden City Movement**

The concept of cooperative community continued in the creation of the Garden City Movement. Ebenezer Howard laid out this idea in his book, *Tomorrow: A Peaceful Path to Real Reform*, published in 1898. The book was reissued in 1902 under the title, *Garden Cities of Tomorrow*.

There is a very American aspect to Howard's intellectual growth. In the 1870s, he spent time in the United States, partly under doctor's orders to strengthen his lungs. He chose Nebraska with its wide open spaces to get the fresh air he needed. There, Howard was impressed by the waste of time and labor in farming due to the lack of cooperation. Later he spent time in Chicago and came under the influence of the Quakers and the humanistic philosophy of Emerson, Lowell, and Whitman.

On a second visit to the United States, in 1898, Howard was given a copy of Edward Bellamy's *Looking Backward*. Later Howard would write:

This book graphically pictured the whole American nation organized on cooperative principles . . . The next morning as I went up to the city from Stamford Hill I realized, as never before, the splendid possibilities of a new civilization based on service to the community and not on self-interest, at present the dominant motive.

Howard would remain undeterred by *The Times'* review of *Looking Backward*. "The only difficulty is to create such a City, but that is a small matter to the Utopians."

In 1899, Howard and his supporters formed the Garden

City Association, and in 1900, a limited company, Garden City Limited, was created and authorized to sell shares. The next year, a conference to discuss the garden city concept was held near Birmingham at the model village of Bournville. Three hundred delegates attended from local councils, trade unions, and cooperative and friendly societies. Edward Cadbury, son of George Cadbury, the Quaker "king" of chocolate and cocoa, became a charter director of the Garden City Pioneer Company and a major supporter of the idea.

Another Quaker family, the Rowntrees, who had developed a housing co-op in their model village of New Earswick, sponsored a competition for the design of Letchworth. The Quaker concern for social planning moved from the employer's model village to the citizen's garden city. The Joseph Rowntree Village Trust hired the architects Raymond Unwin and Barry Parker in 1902. The two young men were greatly influenced by the ideas of John Ruskin and William Morris on visual architecture and played a major role, with Ebenezer Howard, in the creation of Letchworth and the Garden City Movement.

Letchworth, the first garden city, embodied many cooperative principles. The land is owned in common by the residents through a corporation, which they controlled democratically. The entire community was planned, and cooperation was one of its foundations. Howard proposed to the Co-operative Wholesale Society that it take over most of the retail distribution in the town. He urged firms to come to Letchworth and practice worker co-partnership, and he recommended that agricultural cooperatives and cooperative dairies run the farms. He hoped that many of the inhabitants would reside in cooperative housing.

Howard himself set a great example by living in Homesgarth, a revolutionary housing cooperative. Homesgarth was a venture of Letchworth Co-operative Houses Limited, of which Howard served for a period as chairman. To free up the work of women, the co-op was built without kitchens. All meals were held in a communal dining room. The co-op operated this way for over forty years. Today, the dining room is a quiet local pub rather than a busy intellectual cauldron. Another co-op in Letchworth was created

for single women. In those days it was often difficult for single women to get mortgages, but this co-op was financed to allow women to become members.

In 1905, Garden City Tenants was established at Letchworth, created on co-partnership principles. Four hundred houses were constructed at two sites, one near the factory area and the other adjacent to the agricultural belt. Three other cooperative building societies were created in Letchworth, which together built another five hundred homes for their members.

When Letchworth opened on October 9, 1903, one thousand shareholders and guests turned out. Ebenezer Howard was fifty-three years old, and the Garden City Association numbered 2,500 members. Presiding over the formal opening ceremonies was Earl Grey, chairman of the association and an ardent, lifelong cooperator. He had been an active participant in the movement for an international cooperative body, and he was president of the first International Co-operative Alliance Congress, held in London in 1895. Grey was the first chairman of the Executive Bureau of the International Co-operative Alliance, and he was key in the development of the Canadian Co-operative Movement while Governor General of Canada. He was one of the many cooperators who played a role in the development of the Garden City Movement.

During Letchworth's early years, there was a competition for the best house built for 150 pounds or less. The cottage that won first prize was later bought by the Co-operative Permanent Building Society and used as their local office. Arthur Webb, secretary of the society, was a supporter of Howard and the Garden City Movement. Webb convinced the board to provide up to twenty thousand pounds in loans for people buying homes in the first garden city. After the first one hundred homes were financed, the society furnished other large sums. The society conducted good business while helping turn a pioneering idea into reality.

Years later Howard said that he encountered two disappointments with Letchworth. The first was that the Co-operative Wholesale Society turned down his proposal to be the main retailer, and the second was that cooperative production at Letchworth occurred on such a minimal scale. None-

theless, Howard continued to encourage cooperatives as a major element in the development of "New Towns."

After a century of paternalistic housing schemes in Britain, there is now a movement which puts people first. The community architecture movement in Britain makes partners of housing professionals and consumers. Together they are building communities with architecture and design that meet the needs of the people who will live in them. These communities take into account the nature of people's lives and their needs for recreation, child care, employment, and shopping. The birth of the community architecture movement began with a project of three hundred households in Macclesfield, Cheshire in 1972. Once again the Northwest took the lead in the building and rebuilding of community. Britain's Community Architecture Movement maintains strong linkages to cooperatives. As Robert Owen was the patron of the Utopian communities of the nineteenth century, the Prince of Wales has become the patron of today's community architecture.

In the forward to Alan McDonald's *The Weller Way*, a book about the development of a housing cooperative begun in 1977 in a poverty district of Liverpool, the Prince of Wales wrote:

The result was what amounted to a very attractive village nestling like an oasis in the midst of a barren urban desert. . . The value of housing Co-operatives is that they can help to provide the impetus to unleash all that potential for regeneration and ensure that people can live their lives in a more fulfilling way. . . It must surely be our aim in this country to try and create, and restore a real sense of inner city areas, based on taking account of the individual needs of residents, and by ensuring that the physical surroundings are on a suitable intimate scale to engender that community feeling. . .

Except for the passage of 150 years, the interests of the Prince of Wales differ little from those of Robert Owen when he proposed his Villages of Co-operation in 1817. Owen built his communities to allay the effects of poverty and designed

them to assure sunshine, light, and room. He set aside land for vegetable gardens, buildings for schooling, canteens for good food, and halls for entertainment. Villages of Co-operation, home colonies, and housing cooperatives are all part of the quest to create community, and Rochdale's role was to create a formula for success. Today, housing cooperatives and cooperative communities lead the way in fostering community involvement and a sense of ownership and place.

As the new century began, it became clear that the old hopes of the Pioneers were being fulfilled by fresh new ideas about community and society. Building societies offices were on every High Street, and garden cities were being planned in every part of Britain. The Housing and Town Planning Act (1909) ensured quality standards of housing. Unemployment insurance was introduced in 1912, and in the same year it was followed by an early form of health insurance.

Model villages, garden cities, new towns, and planned communities all trace their origins back to the nineteenth century and Robert Owen and New Lanark. The Rochdale Pioneers, with their commitment to model community, occupied part of the continuum from Utopia to garden city. However, they ought to be viewed as having played a much more critical role in the progress towards the garden city. Prior to the Pioneers, almost all the 18th and 19th century Utopian communities were provided for by enlightened philanthropists. The Pioneers took control of the idea of community, and used their resources to build houses for their members.

The Pioneers' strength lay in their ability to create economic power from the bottom up. For the first time, working people were in control of their circumstances, and, in the case of the cooperators, sizable assets. They were also able to decide their destinies. The working poor now had a successful model which did not need to be supplemented by the rich. That ordinary people had finally found a practical model with which to build economic freedom was a breakthrough. Uniting their consumption, capital, and labor provided them with the democratic power and economic profits to carry out their dreams.

In the latter half of the nineteenth century, the Rochdale model of cooperation captivated Britain. Its economic and so-

cial success was copied in every sector of the economy. The major lesson that Ebenezer Howard learned from Rochdale was to tie citizenry to the community. It was time to put the philanthropist out to pasture—this was the age when deference gave way to democracy. New sources of capital, in the form of building societies and cooperative organization, could provide every English man and woman with his or her castle.

Michael Cassell, author of *Inside Nationwide*, eloquently captured the impact of the Rochdale Pioneers:

The movement was based on the vision of a Cooperative community, where self-help and mutual assistance prevailed, and on the raising of funds among—and for the use of—the working population. Democratic control was the keynote and although the concept of Co-operation had its roots in the previous century it only began to spread rapidly after the initial success of the Rochdale experiments.

Howard was well aware of the success and the power of cooperation. In the introduction to his book, Howard states, "The town is the symbol of society—of mutual help and friendly Co-operation . . ." Were it up him, Letchworth would have been a community of extensive cooperative activity in retail, housing, and production. The reluctance of the Co-operative Wholesale Society to step forward to be the main retail partner in developing the garden city concept was a grave error. Nevertheless, Howard drew strength from the co-op model, and brought forward one of the great eras of community planning.

Lewis Mumford wrote an introductory essay for the 1965 U.S. paperback edition of Howard's book. In it Mumford wrote, "But Howard was a practical idealist like the Rochdale co-operators before him." Both the Pioneers and Howard were dedicated to dreams that worked. Charles Howarth and Ebenezer Howard were cut from the same dour cloth, and the world is a better place for it. Howarth used consumption and capital to create economic citizens, and Howard molded citizens and capital into creation of a democratically controlled community.



### Club Row

Another form of cooperative house building was the club row. The building club was a common system in Lancashire in the late eighteenth century. A group of up to twenty people would buy land together on which to build a row of houses, which were then allocated by ballot. Club rows exist in almost every town in industrial Lancashire. Part of the original goal of the club rows was that the members would build the houses together, but it soon proved too difficult to accomplish. Even having a contractor build the homes at the same time proved complicated. In the end, the most popular method was for the club to furnish the money to the ballot winner, who then contracted directly for the building of his or her own unit.

The oldest existing club row is located at Longridge, near Preston in Lancashire. The society was established in 1793 under the guidance of the local minister. There were twenty members in the group, it cost twenty-one shillings to join, and monthly dues were ten shillings and sixpence. The society found a site suitable for twenty houses, and, with the help of the minister, raised two hundred pounds to buy the land. Each house was balloted, and the winner could either occupy the house or install a tenant. Each two-floor terraced house cost one hundred dollars to build. Within five years, all the houses had been constructed, and by 1804 the loans had been repaid and the affairs of the society terminated.

The Longridge Building Society and the club rows of Lancashire were part of the birth of both the Building Society Movement in Britain and the savings and loan associations in the United States. Early models such as Longridge were called Terminating Building Societies, because as soon as the members were housed and the leftover funds dispersed to them, the society was disbanded. Club row still stands today as a tribute to the foresight and cooperation shown by ordinary people two hundred years ago.

The societies soon gave up the roles of builder as well as banker. It became easier to gather and advance the money directly to the members who would then build their own homes. As the societies rediscovered value in playing the role of banker, they developed the concept of the permanent

building society. By 1865 there were thirteen building societies in Rochdale, all committed to providing their members with the financing to build houses. These building societies became the powerhouses of finance for home-building, and they still today provide the majority of home loans in Britain.

### **Building Societies**

The historic origins of the Building Society Movement can be traced to the creation of one in the hamlet of Deritend, in Birmingham, England, on December 3, 1781. The founding was recorded in local history, but there is no further evidence as to what happened. The era contains numerous references to building societies and club rows, and fraternal methods to furnish their members with houses.

In 1831, a group of thirty-seven men met in Frankford, Pennsylvania, to found the Oxford Provident Building Society, an idea they had gotten from the English societies. The society was necessary because banks generally would not lend money to build homes. In the American model, the person bidding the highest premium for the pooled money won the right to build the first house. In this case, the first winner's loan turned out to be a dud, but the second loan, to Comly Rich, a lamplighter, allowed him to buy a house. When Mr. Rich fell behind in his payments a few months later, another member took over the loan. In due time the loan was paid off, and thus began the Savings and Loan Movement in the United States. If you go to 4276 Orchard Street in Philadelphia, you can see the house of Comly Rich, which today is maintained as an historic monument.

### **The Growth of the Nationwide Building Society**

In the 1880s, cooperators in Britain were well aware of the potential of the building societies. More importantly, they were deeply cognizant of the crisis in housing. Britain's towns and cities had tripled and quadrupled in population in just forty years. Demand had outstripped supply, and quality was scarce. Slums and squalor compounded the health problems of the young economy. How could hard-working cooperators find a decent place to live and the money to buy a home?

In London, a group of interested people had come together to form the Guild of Co-operators. The guild members were influenced by the success of their northern brethren, whose shops and commerce were fanning out and flourishing in every town and village in northern England. The early co-ops had branched out into wholesaling, distribution, production banking, and insurance. The guild members met on a cold January night in 1883 in a small gas-lit room on Southampton Street. Housing in Britain was a mess, and Gladstone, the Prime Minister, was consumed with problems in Ireland and elsewhere in the Empire and was unable to focus on domestic issues. If something had to be done it must be done by the people themselves. The guild members talked of encouraging thrift and making a small contribution to better living and working conditions. The challenge was immense, yet the guild members were ready. It was time to act!

The cooperators at the meeting were drawn to the ideas of Charles Cooper, who outlined to the group the concept of a building society. Cooper saw the role of the building society as financing the purchase of buildings for cooperative societies and making loans to co-op members for house construction or purchase. Six weeks later, the guild met again to review a more in-depth plan which "would aid the commercial and domestic aspirations of Co-operators." At the end of that meeting, Thomas Webb, who would become the society's first president, wrote down the guiding principles of what would become one of the world's largest and most successful building societies.

In a school exercise book that cost one penny, Webb wrote:

The specially convened meeting decided that it was desirable to establish a Co-operative building society for the London and southern section as further aid to Co-operators and the public generally in the practice of thrift, the more comfortable housing of working people and the accumulation and profitable investment of capital.

On the evening of July 21, 1883, a small group of people gathered at the London offices of the Co-operative Wholesale

Society to witness the start of a building society to be called the Southern Co-operative Permanent Building Society which is today called Nationwide. The banking department of the Co-operative Wholesale Society agreed to be the new society's banker. One hundred years later, the society would have three million members and assets worth more than four times Britain's national income at the time of its formation.

Just weeks after the society opened for business, it made its first loan to Mr. A. O. Idle, a committed cooperator. The loan, for 120 pounds, went toward the purchase of 29 Morrison Street on the Shaftesbury Estate in Battersea. Lord Shaftesbury was the key promoter of subsidized housing estates in Britain, and he sponsored major housing reform in Parliament. The famous statue of Eros in Picadilly Circus is actually a statue to the memory of Lord Shaftesbury's contributions to the reform movement.

The house and borrower were both looked over carefully by the board of directors. Interest was set at 5.1 percent and weekly repayments at six shillings. Mr. Idle was reportedly very pleased with the mortgage. Mr. Idle worked for the society until his death, and his three sons and one daughter followed him in his work. From this simple start emerged one of the most powerful financial institutions in Britain.

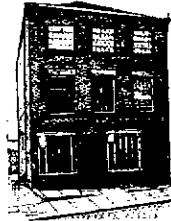
From its beginnings, Nationwide had been an innovative house lender. It went out on a limb to support the early development of Letchworth, the first garden city, and later worked with municipal councils on developing housing estates. In 1982, the society established a separate housing department to expand its role in housing development. For its entire existence, the society had been financing housing. Now it was in the business of house building, which is where the building societies had begun almost two hundred years earlier. The society was a pioneer in rebuilding the inner city and is now a leader in developing housing for people with special needs, such as the elderly and handicapped.

For most of its early years, the society maintained an institutional affinity with the British Co-operative Movement. However, a series of financial difficulties within the British retail cooperatives in the late 1960s led to the need for a clear separation. In 1970, the society changed its name to the Na-

tionwide Building Society. What began as a humble idea among cooperators has grown into Britain's second largest building society and one of the world's unique financial institutions. At the end of 1992, Nationwide had over 6.2 million member depositors, with the most branches in the United Kingdom (730) and 35 billion pounds in assets. The handful of co-op leaders who had gathered in that cold room in London in 1883 would be proud of the progress of the idea which has housed millions.



## CHAPTER 15



### Toad Lane Yesterday and Today

*Drops in separation could only fade away,  
Drops in Co-operation made the ocean.*

—Mahatma Gandhi

The co-op occupied the Toad Lane premises for twenty-three years. In 1867, the co-op moved up the lane into the Central Stores, a four-floor department store which the members had built to house their thriving business. The future seemed so bright that only a few looked back at the tiny store that formed the co-op's foundation. The little store became a private shop. But as the power of cooperation grew, people coming to Rochdale from all over the world would inquire about the store that had given birth to modern cooperation. When they were shown 31 Toad Lane, they saw not the "Birthplace of Co-operation," but a shoddy little shop selling canaries and bird seed. At the 1914 Co-operative Congress it was therefore resolved to raise subscriptions to buy the building. Unfortunately, World War I impeded the campaign.

By the 1920s, enough money had been raised to buy the shop, and as soon as the lease came to an end, the shopkeeper and his canaries left the building forever. The Co-operative Union and the Co-operative Wholesale Society drew up plans to restore the building to its original appearance, and the shop was officially opened as a museum in 1931. Between

1974 and 1978, the museum was closed to allow for extensive renovations and structural changes. The building is now in excellent condition, although the interior third floor was removed to provide a more open feeling to the second floor. Due to urban development and demolition, Toad Lane has gone from being the longest street in Rochdale to being the shortest. The renovated building and the Toad Lane Conservation Area was dedicated by Princess Alexandra on 13 May 1981.

The Pioneers' Museum is dedicated to displaying the history of the Co-operative Movement. Along with the building next door, the short street is a well-maintained attraction and one of the most visited sites in Rochdale's history. Visitors are strongly suggested to contact the Co-operative Union for the operating hours of the museum.

The front room of the first floor of the museum depicts the simplicity of the original store, with its meager supply of the shop's first few products: sugar, butter, flour, oatmeal, and tallow candles. Nearby are the benches where members waited to be served, the scale where their purchases were weighed, and the desk where their purchases were entered into the books of the cooperative. The rear room of the first floor depicts the history of the Rochdale Pioneers and the early leaders of the Co-operative Movement.

Originally a school and a chapel were located upstairs; the co-op took over this floor in 1849. Initially, the co-op operated a library and classroom on the first floor and a drapery and shoe repair service on the third floor. When the building was remodeled extensively in the 1970s, it was decided that the museum would be structurally safer if the third floor was removed. As a result, the second floor of the museum is a lofty and well-lit meeting and exhibition hall. Around the walls hang many historical banners and photographs. On the second floor you can also purchase a wide range of wonderful co-op souvenirs.

As the birthplace of the Pioneers, Rochdale is the Mecca of any co-op pilgrim. Percy Redfern, the great co-op historian, once stood in the store and later recounted, "So far from being dead, the Co-operative pioneers of 1844 brush past you; another deep browed, firm lipped Howarth, another slender hopeful Cooper, another Quaker-like Smithies." To open the



door and enter into the tiny shop where it all began is a never-to-be-forgotten experience for any co-op activist.

The original Rochdale Equitable Pioneers Society merged with the Oldham Co-operative Society in 1976 and then was absorbed into the Norwest Co-operative Society in 1982. In 1989, the Rochdale Equitable Pioneers Society was re-registered to revive the society as a supportive and promotional organization on behalf of the Pioneers Museum in Rochdale. In 1994, the society will once again be in operation.

In 1844, twenty-eight weavers gathered together to launch the modern Co-operative Movement. By 1944, the International Co-operative Alliance noted that 72 million people worldwide were members of cooperatives. When the door at 31 Toad Lane—site of the first modern cooperative—opens again on December 21, 1994, the global cooperative community will count 720 million members.

The cooperative family today is however a wider and more diverse family than the one started in 1844. The Pioneers began their co-op as a method for the little people to pool their purchasing power and effectuate savings. Today cooperatives still are the tool of the little people; however, they serve not only consumers but producers, small businesses, and nonprofits. Many of these cooperatives composed of small businesses have created big businesses such as Associated Press, F.T.D., and Best Western. With thousands of members worldwide, global cooperatives such as these provide a unique competitive edge.

Every single day, enterprising people discover the cooperative form as they look to maximize their economic needs through group effort. The taxi drivers, seamstresses, farmers and family-run corner stores in the developing world all have their co-ops to help them cut their costs and increase their opportunities. Cooperation has also become the strongest protection for independent enterprises in the developed countries to use to compete with big business. Independent grocers, hardware dealers, stationery stores, pharmacies, and florists have all built strong co-ops to build their own enterprises. Without their cooperatives, many small businesses on the High Street in England and Main Street in America would be out of business. Over 150 years later, coop-

eratives everywhere remain the champion of the little people in business.

The Co-operative Movement began as a working class movement in Europe intent on creating a different world. The Rochdale Pioneers made two important choices when they chose power over philanthropy and prosperity over pity. Without capital and economic independence they would be a slave to charity and beholden to a society controlled by a wealthy few. With capital they would accumulate power, and with power they could make choices and bring freedom and a democratic economy to their members.

There was philanthropy enough to ease the suffering but it would not bring independence. There was pity enough to ease the pain but it would not bring prosperity. What the Pioneers wanted was not to hope for charity but to develop a model of mutual self-help which would lift them up without others having to be brought down. They no longer wished to rely upon others to alleviate their circumstances; they intended to take matters into their own hands, and, as Holyoake said, "... keep them there." They saw that through cooperation they could create new wealth and develop an equitable society. They did not have to take from anyone, they just had to figure out how to keep what little they had. When millions of poor people pool their pennies they create pounds. In time, those pennies are the foundation for a rich and powerful organization. The Pioneers did just that, creating an effective model copied time and time again throughout the world. What is so unique is that the founders of each new cooperative often begin with the same enthusiasm, economic need, vision, and purpose as the Pioneers of Rochdale.

The origins of the Middle Way during the 1930s-1940s, Alternative Economics in the 1960-70s, and the Green Economy and socially responsible investing of the 1990s can all be traced to the door of Toad Lane. The Rochdale Pioneers were the first successful practitioners of a people-oriented economic model that looked beyond individual corporations to the society as a whole. Many co-ops had been tried before and most had failed. The Pioneers at Rochdale learned from earlier mistakes and history was made.

The first page of *The Best of James Herriot* begins with

Herriot's words, "The narrow street opened on to a square where we stopped. Above the window of an unpretentious grocer shop I read Darrowby Co-operative Society. We had arrived." Herriot was right, most people in the north of England identified the co-op as part of their community. For many decades the co-op stores in the north of England were models of working-class success and signified community, thrift, and self-help. These stores made a huge difference in a changing society, much as they do today in villages around the world where the local co-op *is* the community.

The Rochdale Pioneers studiously modified the cooperative model and put it into modern practice. They were ordinary people who created an extraordinary concept. Can we ever forget the cooperative legacy they left, which now affects millions? While others bombed, they built, and while others suppressed hope, they sought harmony. They knew that through cooperation they held the key to the future. Through perseverance and unity, their own meager capital, and the loyal spending of their pennies at their own store, they would gain their freedom and would never lose it. A simple idea, a committed group, and a small shop. They began a revolution that brought hope to millions and harm to none. The Pioneers gave birth to the idea of modern cooperation and the world is a better place for it!

## APPENDIX B

### Original Statutes of the Rochdale Society of Equitable Pioneers and Today's International Co-operative Alliance Co-operative Principles

#### **The Original Statutes, Laws, and Objectives of the Rochdale Society of Equitable Pioneers, Registered October 24, 1844 in Rochdale**

The objects and plans of this Society are to form arrangements for the pecuniary benefit and the improvement of the social and domestic conditions of its members, by raising a sufficient amount of capital in shares of one pound each, to bring into operation the following plans and arrangements.

The establishment of a store for the sale of provisions and clothing, etc. The building, purchasing, or erecting a number of houses, in which those members desiring to assist each other in improving their domestic and social condition may reside.

To commence the manufacture of such articles as the society may determine upon, for the employment of such members as may be without employment, or who may be badly remunerated.

That as soon as practicable, this society shall proceed to arrange the powers of production, distribution, education, and government, or in other words to establish a self-supporting home-colony of united interests, or assist other societies in establishing such colonies.

That for the promotion of sobriety a Temperance Hotel be opened in one of the society's houses, as soon as convenient.

#### **The International Co-operative Alliance Principles**

The Rochdale Principles proved to be difficult to uphold for many non-consumer cooperatives, especially worker and producer cooperatives. As a result, the International

Co-operative Alliance appointed a committee at the end of the Second World War to develop a set of principles with broader application.

The 1966 Congress of the International Co-operative Alliance, held in Bournemouth, England, approved this wording of the six Co-operative Principles:

- ◆ Membership of a Co-operative society should be voluntary and available without artificial or social, political, radical, or religious discrimination to all persons who can make use of its services and are willing to accept the responsibilities of membership.
- ◆ Co-operative societies are democratic organizations. Their affairs should be administered by persons elected or appointed in a manner agreed by the members and accountable to them. Members of primary societies should enjoy equal rights of voting (one member, one vote) and participation in decisions affecting their societies. In other than primary societies the administration should be conducted in a democratic basis in a suitable form.
- ◆ Share capital should only receive a strictly limited rate of interest.
- ◆ The economic results arising out of the operations of a society belong to the members of that society and should be distributed in such a manner as would avoid one member gaining at the expense of others. This may be done by decision of the members as follows: (a) by provision for development of the business of the corporation; (b) by provision of the common services; or (c) by the distribution among the members in proportion to their transactions with the society.
- ◆ All Co-operatives should make provision for the education of their members, officers, and employees and of the general public in the principles and techniques of the Co-operation, both economic and democratic.
- ◆ All Co-operative organizations, in order to best serve the interest of their members and their communities, should actively Co-operate in every practical way with other Co-operative at local, national and international

levels.

The International Co-operative Alliance principles are once again under review. Further modifications will be introduced at the International Co-operative Alliance Congress to be held in Rochdale and Manchester in 1995. The occasion of the 100th anniversary of the founding of the International Co-operative Alliance will be used to adopt a revised set of Co-operative Principles to keep up with the rapid changes occurring in the global economy and within cooperative enterprises.

David J. Thompson was born in Blackpool, England, in 1942 and emigrated to the United States in 1962. In the late 1960s, he became involved in the civil rights and anti-war movements. Looking back on the crowd of over a quarter of a million people gathered for the 1970 San Francisco Peace March, he came to the conclusion that if people were active in co-ops, a better society could be built. Since then he has committed himself to building a cooperative economy.

For the past twenty years, David has been active in the cooperative sector in the United States. He co-chaired California's efforts to win passage of the legislation that established the National Cooperative Bank in 1978 and the Center for Cooperatives at the University of California in 1987. David was Director of the Western Region of the National Cooperative Bank and later the Director of International Relations for the National Cooperative Business Association. He is now principal of Thompson Consulting. David has written over 100 articles about cooperatives, and his work has been published in six books and four languages. He serves on the board of REI, America's largest consumer cooperative (1.3 million members) and the Davis Food Co-op. He is president of the Twin Pines Cooperative Foundation.

David has collected the world's largest private library on cooperatives. Much of his collection has been gathered from sources in Britain, and it is from much of this original literature that he studied and culled the material to write this book.

David's family on both sides is descended from generations of Lancashire folk. In 1844, his great-great-great grandfather was a hand loom weaver working in the Lancashire village of Hoghton, eighteen miles from Rochdale. By the 1860s, both maternal and paternal families were members of cooperatives. Both sides of his family have been of public service to Lancashire. His grandfather, John Clayton, served on the Oldham Town Council; his uncle, Peter Thompson, served as chairman of the Oswaldtwistle and Church Urban District Council; and a cousin, Pat White, works for the Rochdale Metropolitan Borough Council. Carrying her own family tradition, his wife, Ann Evans, was Mayor of Davis, California, a "City of Cooperatives" and the first manager of the State of California's Cooperative Development Program.

From David's first day in the world, the co-op milkman delivered to the family's door. The dividend earned at the co-op helped buy the house, his first suit, and the annual Christmas presents and dinner. David and every member of his family have all worked for the "co-op."

His strength of purpose is derived from the contribution his family made to the building of Lancashire. He was taught to honor those who make history and to respect the unselfish pioneers who left behind a better world. The best part of this world was created by people like the Pioneers who nurtured it for future generations. He is glad that his daughter Hatley Rose can live in a world of cooperatives and cooperation.
