## **Important Registration Details**





- Fee: \$10 per entry. Fees must be submitted to the 4-H Office by April 29th or you cannot participate in the event. (Max fee is \$20)
- Eligibility: 4-H members are eligible by enrolling in the "Clothing & Textiles" or "Fashion Revue" projects. Members enrolled in the 2023-2024 program year may participate.
- Members may enter up to 2 modeling categories plus the Quilts, Softie
   Challenge or leather creations. The garments and accessories for each modeling outfit must be distinctly different. An item in one outfit may not also

be used as part of another outfit. Quilting challenge entries will be judged while on display.

- If two (2) modeling categories are won by the same individual, judges will determine which category the winner may compete in at State Fashion Revue. The alternate will be eligible for state in the other category.
- The same outfit may not be entered into multiple categories.
- You will receive your time to arrive for judging.
   This will hopefully reduce long wait times.

\* Members entering in two modeling categories will be judged in each outfit separately which may require a few quick outfit changes. Please be aware of this ahead of time and plan accordingly.

#### **PHOTO SHOOT & FASHION SHOW**

After participants have their time with the judges they will go outside to take photos and practice modeling for Fashion Show.





## **Instructions for Members:**

- Complete the General and Supplemental Entry Forms.

- A completed entry form includes:
  - Traditional: completed supplemental entry form and 2x2 sample of each fabric used
  - Consumer Science Purchased \$50 limit: attach photocopies of your receipts for all items showing and completed supplemental entry form
  - Make It With Wool: completed supplemental entry form and 2x2 sample of each fabric used
  - Costume Challenge: completed supplemental entry form and 2x2 sample of each fabric used
  - Softie Challenge: completed supplemental entry form and 2x2 sample of each fabric used
  - ° Leather Creations: completed supplemental entry form
  - Quilts: completed supplemental entry form



# **Instructions for Members (con't):**

- Photos of your completed garment are not mandatory, but are required if you are eligible to participate in State Fashion Revue.
- Pay your entry fee online, give to your clothing leader or bring in to the 4-H Office.
- Enter online then submit the above materials to your clothing project leader or the office by Friday, April 29th.
- Members requiring special arrangements due to disability, please explain on registration form or contact the 4-H Office.

# **Instructions for Project Leaders:**

- Distribute the enclosed materials to your project members.
- Make sure all participating members complete their online entry by April 17th.



- Collect receipts, completed supplemental forms and/or pictures (according to what category entered).
- Place in the envelope provided and submit to the 4-H office by April 29th.

# **Divisions and Judging**

#### **AGE DIVISIONS** (as of 12/31/2023)

- <u>Primary members</u>: Age 5 8 Note: Primary Members will not be judged but they will get an opportunity for feedback on their outfits/projects. They are not eligible to participate at State Fashion Revue in May.
- <u>Junior</u>: Age 9 10
- Intermediate: Age 11 13
- <u>Senior</u>: Age 14 18 (A member is eligible to participate as a senior until Dec 31st of the calendar year in which they turn 19.)

#### **JUDGING**

- Participants are divided by county, age division, and category for judging.
- Judging is on overall appearance and expression of personal style while wearing their outfits.
- Participants will briefly tell the judges what they made or purchased and what they learned. They should be prepared to answer questions from the judges. The judges will review the entry forms and accompanying information.
- Judging is closed to the public.

#### **AWARDS**

- All entries will be judged by the Danish System.
- Each participant will receive a certificate and a participation pin.
- Additional awards may be given in each age division, in each category, including donated gifts.
- Awards are based on merit, as determined by the judges. If there is only
  one entry in a category, it does not automatically warrant an award.



### **ATTENTION: (Applies to all categories)**

- The outfit must be produced and modeled by the individual member.
- To be in alignment with State Fashion Revue: All outfits must meet the 4-H
  Dress Guidelines, found at <a href="http://4h.ucanr.edu/files/210170.pdf">http://4h.ucanr.edu/files/210170.pdf</a>. All shorts,
  skirts, dresses, etc. must be at least fingertip length.
- Each entry a member enters should be distinctly different.

# 2024 Categories

County Winners from the following categories are eligible to compete at State Fashion Review.

#### 1. TRADITIONAL:

Features garments the participant has constructed, showcasing sewing skills and the ability to coordinate an outfit. The entry must be sewn by the member as part of his/her 4-H Clothing and Textiles project and modeled by the member. The outfit must contain at least one constructed garment. Participants are encouraged to construct additional garments to complete the outfit.

#### 2. CONSUMER SCIENCE PURCHASED, \$50.00 LIMIT:

Participants in this category will shop for an entire outfit with the total cost not to exceed \$50.00, including shoes but not sales tax. Receipts from the current 4-H year are required for any item that is visible. Gifts, prior purchases, and items without receipts are not eligible for this category. Receipts from yard sales, etc. may be hand written. The member should consider value vs. cost, versatility, the shopping experience, and coordination of the outfit within the cost limit. There is no 4-H project requirement and must be modeled by the member; any 4-H member may enter this category.

#### 3. MAKE IT WITH WOOL:

Participants in this challenge will sew, knit, or crochet garment/s from 100% wool, wool blend (minimum of 60% wool) fabric or yarn or specialty wool fiber. a pair of pants. The entire garment body (front, back, and sleeves) must be wool or wool-blend fabric.

Garments created for the Make It With Wool competition that is supported by the American Sheep Industry meet the requirements for this category. (https://makeitwithwool.com/welcome) If you choose to enter the Make It With Wool competition, it is your responsibility to ensure that your entry meets the Make It With Wool requirements.



The garment in this category must b sewn by the member as part of a 4-H Clothing & Textiles Project and modeled by the member.

#### 4. COSTUME CHALLENGE

Participants in this category will create a costume for themselves or another person using any technique, materials, or pattern. It does not need to be sewn from fabric. The costume can be any theme and from any time, place, or country as long as it is 4-H appropriate. 70% of the costume must be handmade by the member; 30% can be handmade or purchased. The member must be able to move comfortably in the costume—sit, stand, and walk, and go up and don stairs.

This category has no 4-H project requirement. If it was sewn for the member, they must model it. If it was sewn for another person, that person may model it, or it may be shown on a hanger. The member must be present and participate at the Fashion Revue event if it was sewn for another person. Conit

# 2023 Categories con't

#### **5. SOFTY CHALLENGE:**

Members create a stuffed animal, cloth doll, plush toy, soft sculpture, or fabric toy. In this challenge, the participant will sew, felt, knit, or crochet a softie using a pattern or their own design. Any type of fabric and any embellishment techniques (trims, embroidery, yarn hair, removeable clothing) may be used. Participant must present the entry themselves at the Fashion Revue event. This category has no 4-H project requirement and must be shown by the member at the event.



#### **6. LEATHER CREATIONS:**

Participants in the Leather Creations category will create any leather accessory purse, wallet, belt, saddlebag, key fob, etc. - in any style. Any leather techniques may be used (tooling, carving, dying, painting, shaping, stitching, etc.) Materials used may be any leather, suede, or faux leather products. This category has no 4-H project requirement and must be shown by the member at the event.

#### 7. QUILTS:

Participants in this category will sew a quilt of any size and pattern. The quilt must have finished edges and may use any quilting method (machine, hand, hand-tie, etc.) This item/s must be sewn by the member as part of a 4-H Clothing & Textiles Project and shown by the member at the event.
