Topic: NV Department of Ag. Grnat Proposal – Including biocontrol

Discussion: Grant will help with treatment and survey in Incline, biocontrol for spotted knapweed site in Glenwood and assist with the printing of the new green books.

Topic: Aquatic Invasive Species Group Update

Discussion: The groups 2008 annual report is almost complete, many outreach products were shown, and 2008 Watercraft Inspection summary was provided.

Topic: Outreach Update, Funding and Planning 2009

Discussion: Funding—SNPLMA Rnd 8 RFP out Jan 6th, Rnd 9 NRCS has agreement and secured for work in 2009, Rnd 10 we are not applying, Rnd 11 we will jump back into the pool. FS is the same and then will be applying for regional funds. NTCD is applying for license plate grant which sounds positive, for survey and treatment. Outreach—In 2008 we reached over 54,000 people. Green books will be going to print in Jan. Website is continuing to be developed, group provided some feedback. Pressure maps for website and to use internally will be revisited in Jan. A new FS intern will need outreach projects to work on.
