



**Purpose:** This FAQ provides answers to questions about the use of alcohol, illegal drugs, and tobacco in the 4-H Youth Development Program (4-H YDP) and assists in policy implementation and interpretation.

## 1. What is a 4-H Youth Development Program event?

*A 4-H event is any activity or meeting organized by clubs, units, 4-H adult volunteers, 4-H members, or the 4-H YDP staff.*

## 2. What is defined as smoking?

*Smoking means inhaling, exhaling, burning or carrying of any lighted or heated product, as well as smoking substances that are not tobacco, and smoking instruments.*

## 3. What is defined as tobacco use?

*Tobacco use includes inhaling, smoking, chewing, dipping or any other assimilation of tobacco products.*

## 4. What is a tobacco product?

*A tobacco product means all forms of tobacco, including but not limited to cigarettes, cigars, pipes, hookahs, electronic cigarettes and all forms of smokeless tobacco.*

## 5. Can alcohol be served at 4-H YDP events?

*No, the use of alcohol, illegal drugs and tobacco is prohibited at all 4-H YDP events.*

## 6. Can 4-H members attend events that are not 4-H events where alcohol is served and work with the organization as 4-H members?

*At events where alcohol is served, there should be two 4-H adult volunteers assigned as chaperones of 4-H members, with a minimum of two adult volunteers for every eight 4-H members (1:4 ratio). Additionally, 4-H members should not handle or come into contact with alcohol. Specifically, 4-H members should not serve alcohol at these events.*

## 7. Can alcohol be given as a prize in a silent auction or for door prizes at events where 4-H members are present?

*Yes, however, 4-H members cannot accept an alcoholic item either as a door prize or silent auction item.*





**8. How can counties inform the public of these 4-H policies?**

*Please use the phrase, "In support of positive youth development, this event is alcohol, drug, and smoke and tobacco free" on posters, letters and other announcements for your 4-H events. The University of California has a [Smoke & Tobacco-Free logo](#) that can be used.*
