



MARIN COUNTY FISH & WILDLIFE COMMISSION 2025 SCHOLARSHIP APPLICATION

The Marin County Fish & Wildlife Commission's scholarship program provides financial assistance, encouragement, and public recognition for students in the fields of natural resource management, environmental restoration, preservation, or other fields of study related to fish and wildlife conservation. The scholarship recognizes academic achievement and community service by the diverse student body studying these disciplines. The scholarship will be awarded to one Marin County student:

- Commissioner Ed Schulze Memorial Scholarship: \$3,500.00 or 8% of annual funds, whichever is less

ELIGIBILITY REQUIREMENTS

- Resident of Marin County
- Enrollment in or plan to enroll in a course of study at a college campus that is supportive of fish and wildlife population and habitat management
- Currently enrolled as a high school senior (entering college) or college student

APPLICATION REQUIREMENTS

- Completed scholarship application form (attach additional pages if needed)
- School transcript for the past academic year
- Two letters of recommendation (letters of recommendation from teachers, school staff, work or internship supervisors, or other acquaintances familiar with the applicant's educational performance or community service achievements)

SUBMITTAL INSTRUCTIONS

Completed application packet, including application form, transcript, and letters of recommendation, must be received in the UCCE Marin Office by the first Monday of March, to be considered for the award. Applications received after that date will not be considered.
