**CONSUMER & FAMILY SCIENCES & ARTS KEY LEADER**  
JOB DESCRIPTION

**General Description**

The Consumer and Family Sciences and Arts Key Leader is a 4-H adult volunteer who serves as a middle manager and who has the overall responsibility for the development and delivery of programs to 4-H members in the Consumer and Family Sciences and Arts program. The Consumer and Family Sciences and Arts Key Leader is responsible for the function of the Consumer and Family Sciences and Arts Program Development Committee and for working with the chairpersons of event/activity committees in the Consumer and Family Sciences and Arts program. The Key Leader functions as a critical link between the Consumer and Family Sciences and Arts event/activity committees, the Program Development Committee, the 4-H Youth Development Program (YDP) staff and the 4-H Office.

The programs, events and activities under the Consumer and Family Sciences and Arts program include:

- Fashion Revue
- Other events pertaining to the Consumer and Family Sciences and Arts program
- 4-H Leader Training in the Consumer and Family Sciences and Arts field

**Objectives**

1. To strengthen the educational quality of the 4-H YDP. Ensure consistent and dynamic educational program in the Consumer and Family Sciences and Arts program.
2. To ensure that programming in the Consumer and Family Sciences and Arts program is aligned and consistent with the UC 4-H YDP Framework.
3. To incorporate and strengthen STEM, Healthy Living, and Civic Engagement in the Consumer and Family Sciences and Arts program.
4. To have an effective communication link between project leaders in the Consumer and Family Sciences and Arts program, the Consumer and Family Sciences and Arts event/activity committee, the Consumer and Family Sciences and Arts Program Development Committee, 4-H Program Development Board, 4-H Youth Development Management Board and 4-H YDP staff.
5. To provide specialized leadership and support for the Consumer and Family Sciences and Arts program within the 4-H YDP. To stay informed of new development in the Consumer and Family Sciences and Arts field and make adjustments to programs or establish new programs as necessary.





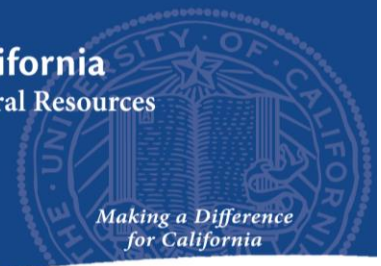
### **Specific Skills**

1. Either an understanding of or a willingness to devote the time necessary to learn about the 4-H YDP, especially in the Consumer and Family Sciences and Arts program.
2. Interest in Consumer and Family Sciences and Arts education.
3. Strong leadership skills.
4. Ability to relate to and work with youth and adults from a wide range of socio-economic and ethnic backgrounds.
5. Enthusiasm, patience, understanding and the ability to motivate youth and adults.
6. Ability to resolve conflict in a timely manner.
7. Good organizational skills.
8. Either an understanding of or a willingness to devote the time necessary to learn about the Program Development Board and Key Leader concepts in the county and the ability to communicate it to others.
9. Willing to participate in the screening necessary to become a 4-H Adult Volunteer in order to serve as a Key Leader.

### **Specific Responsibilities**

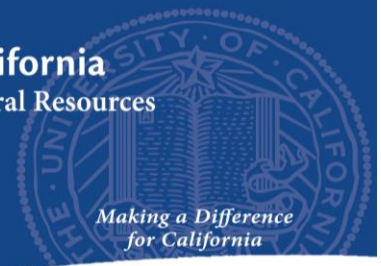
1. Follow and abide by the Consumer and Family Sciences and Arts Key Leader Job Description.
2. Work closely with the 4-H YDP staff in the development and delivery of programs in the Consumer and Family Sciences and Arts program.
3. Develop and oversee the Consumer and Family Sciences and Arts program budget approved by the Management Board. (Authority to re-budget between line items or change the budget as needed given the budget remains within the amount allocated.)
4. Serve as an active member of the 4-H Program Development Board and attend regularly scheduled meetings (approximately 3 to 4 per year).
  - a. Help to carry out the responsibilities of the Board.
  - b. Serve as an important link between the 4-H Program Development Board and the Consumer and Family Sciences and Arts Program Development Committee and the various event/activity committees. Keep the board informed by giving reports as to their plans, what they are doing and how they are functioning.
  - c. As needed, recommend new Key Leader positions to the Management Board for approval.





1. Serve as the chairperson of the Consumer and Family Sciences and Arts Program Development Committee. As chairperson, be responsible for:
  - a. Operation of the committee, including setting meeting dates (approximately 3-4 per year), reserving the meeting room, meeting agendas and other items needed for smooth committee operation.
  - b. Recruitment, selection and orientation of committee members.
  - c. Development and implementation of a dynamic Consumer and Family Sciences and Arts educational program based on the Key Leader Job Description.
  - d. Providing leadership for the training and support of project leaders, 4-H adult volunteers, 4-H members or junior/teen leaders in the Consumer and Family Sciences and Arts program to ensure consistent quality programming and adherence to the overall organizational strategic plan.
  - e. Keep the Administrative Assistant in the Management Board apprised of all dates of events, trainings, etc. to be put on the county calendar.
  - f. Ensure that any fundraising activities to support the Consumer and Family Sciences and Arts program are coordinated with the Resource Development Director and within the confines of the overall fund development plan.
  - g. Special emphasis on Affirmative Action/Outreach.
2. Work the Consumer and Family Sciences and Arts program closely with the chairpersons of the various event/activity and ad-hoc committees in the Consumer and Family Sciences and Arts Program
  - a. Recruit and select the chairperson(s) for the committee(s), utilizing committee membership lists as much as possible.
  - b. Work with the chairperson(s) of the committee(s) to make sure that members are recruited, timelines and policies are being followed and adhered to and that the committee is functioning so that the educational event or activity is planned, implemented and evaluated.
  - c. Develop, implement and evaluate new activities, special events or project innovations in the Consumer and Family Sciences and Arts program.
  - d. Ensure planning is based on direction from the Program Development Board, Program Development Committee and the program vision and plan.
  - e. Keep the Program Development Committee informed by giving reports as to the committee's plans, what they are doing and how they are functioning.
  - f. Provide support to the committees as needed and as appropriate.
3. Serve as mentor to the 4-H Youth Leaders on the Consumer and Family Sciences and Arts Program Development Committee.
4. Attend scheduled training sessions for Key Leaders.





**Relationships**

The Key Leader will be responsible to the 4-H YDP staff and the 4-H Youth Development Management Board. The Key Leader cooperates with the other Key Leaders in the county, as well as other adult volunteers, members and participants in the 4-H YDP, especially those working in the Consumer and Family Sciences and Arts program. Key Leader orientation will be closely coordinated with the 4-H YDP staff to assure compliance with 4-H and University policies.

**Time Involved**

The time needed to do the job varies throughout the year. It is estimated that on average 8 to 10 hours per month throughout most of the year would be required to do this job well.

**Reimbursement/Compensation**

Participation in one professional/volunteer development opportunity pertaining to Director work will be paid (subject to funding and approval by the 4-H Management Board).

**Term of Appointment**

Key Leaders shall serve a two-year term, with eligibility for reappointment to another two-year term. There must be at least a one-year period after the second term before reappointment can be made to the same position. Applicants will go through an application and selection process.
