ALL STAR REPORTS

VICTORIA HAYES

2. I & R Committee

A. Cross Clubbing Form

B. Changing Lake County's program year

Val Schweifler read 1 email in regards to changing the year. The author said that they wouldn't mind the change as long as our record book year and our fiscal year coincided. Joanna Parker reported that she conducted a survey within her club (Anderson Marsh). The results of her survey showed that 99% were in favor of changing our program year. After some more discussion it was brought to a vote. Where it **PASSED**. Karen Hayes made the motion and Cyndi Hill Seconded it.

5. Set dates/volunteers for Peer Review + 2012 budget

6. County Wide Resource Fund

Julie Frazell asked if Council would approve releasing funds so that the office may purchase color ink cartridges. Council agreed to release the funds needed from the restricted Program Enrollment Fund.

7. Livestock Expo

The Livestock Expo will be held on 2/4/12. It will be an all day event. They have gained access to a second building and will be able to double the education. There will be 2 tier 3 quality assurance trainings. One in the morning with another in the afternoon/evening. Committee members expressed that there may be a need for funds but at this time the budget is still being formulated.

Consensus was that Council is interested in making a good faith donation to Kiwanis so that we may be invited back to share in the Pancake Breakfast Fundraiser. Discussion was made in regards to a donation and it was ultimately decided that we would table this until we could combine more information.
